This is in response to your 25 March 2014 Freedom of Information Act (FOIA) request sent to the United States Army, Washington DC and Fort Belvoir, Fairfax VA FOIA request service centers for various records regarding contract SP0600-04-C-8253 and CLIN 0007. Your request was transferred to the Fort Eustis, Newport News VA contracting office from the Defense Logistics Agency. After coordination with the 633d Contracting Office (633 CONS), Langley AFB VA it was determined that the 633 CONS has records responsive to your request.

Portions of the records are releasable and attached. Redacted portions are exemption under the FOIA, Title 5, United States Code, Section 552(b)(5). Negotiations are still ongoing between Dominion Virginia Power and the 633d Contracting Office; therefore, denied portions are non-releasable because they are deliberative in nature or part of the decision-making process, to include attorney-client work communications.

You may appeal our partial denial determination by writing to the Secretary of the Air Force within 60 days from the date of this letter. If no appeal is received, or if the appeal is postmarked after the conclusion of this 60-day period, the appeal may be considered closed. Include your justification for appeal along with a copy of this letter via the Air Force Public Access Link at <https://www.efoia.af.mil/palMain.aspx> or mail to:
