

This is a follow-up e-mail to confirm our discussions on the subject FOIA Appeal during our phone calls earlier today.

I initially called you to obtain the status of the Appeal, and to inform you that despite numerous attempts, I had been unable to reach the assigned FOIA Officer, Mr. Timothy Lyon. I advised you that I have not received any status updates from him, other than his initial acknowledgement of receipt of the Appeal, which was sent more than two months ago, on February 10, 2015. You indicated that you would check-in with Mr. Lyon and get back to me.

You later called me back to inform me that you were able to contact Mr. Lyon, to obtain a status on the Appeal.

You explained that according to Mr. Lyon, the office of primary responsibility (OPR) as well as the Legal office at Langley have both decided to stand behind their original denial determinations for the records at issue in the Appeal.

You further explained that the Appeal will now be forwarded to the Air Force's Legal Operations Appellate Authority (AFLOAA) for a higher-level review, and that AFLOAA will make the final agency determination on the Appeal.

Lastly, you indicated that you expect to receive the Appeal file later this week, and upon receipt, you will be working to develop a written interim response, which will be sent to Blank Rome prior to Langley's forwarding of the appeal to AFLOAA for additional review.
