Dear Attorney General Garland:

We write to request that the U.S. Department of Justice (Justice Department) immediately initiate an investigation into the leaked draft opinion on a matter currently pending before the United States Supreme Court.¹ This “extremely rare breach of the court’s deliberative process” represents one of the most fundamental and troubling breaches of Supreme Court “confidentiality and secrecy” in its history.² Indeed, “Supreme Court historians, former law clerks and other court watchers say they cannot recall a previous instance” of what has happened this week.³ The circumstances of the leak indicate the draft opinion’s release was not accidental but deliberate and calculated. It stands to reason it was intended to affect either the ultimate outcome of the case or the public’s reaction to it. Whoever is responsible for this breach must have known that the draft opinion would foment discord and upheaval, potentially pressuring Justices to reconsider their votes through threats or intimidation. Whatever the reason, this leak undermines the institution of the Court; it also serves to potentially intimidate and manipulate its members, threatening the integrity of one of the three branches of the U.S. government. We therefore request further information regarding steps the Justice Department is taking to address this troubling development.

Leaks of internal deliberations between Justices threaten the integrity of the judicial branch, and therefore our republican system of government. The judicial process requires Justices to deliberate internally and candidly with each other without concern those deliberations may become public. Leaks, for whatever reason they occur, erode the integrity of the institution by undermining the working relationship between Justices, their clerks, and other employees of

the Court, damaging the open exchange of ideas, and permitting pressure campaigns against Justices. As the Constitution sets forth, “[t]he judicial power of the United States, shall be vested in one Supreme Court, and in such inferior courts as the Congress may from time to time ordain and establish.”⁴ This flagrant attack on the Supreme Court, the pinnacle of the judicial branch, threatens to delegitimize and undermine our nation’s entire judicial system. Therefore, targeted and immediate congressional oversight is of the utmost importance.

To assist Republicans on the Committee on Oversight and Reform in conducting oversight of this matter, we request that you produce the following documents and information no later than May 17, 2022:


1. All documents and communications regarding any investigation by the Justice Department or its law enforcement partners into the leaked draft opinion referenced above;
2. A description of all potential laws violated by leaking a draft Supreme Court opinion during deliberations with the intent to threaten or intimidate members of the Court;
3. The number of open investigations into any threats made against members of the Supreme Court, especially threats stemming from the release of the draft opinion referenced above;
4. A description of all steps the Justice Department is taking to ensure the integrity of Supreme Court deliberations, prevent violence, and pursue the individual or individuals responsible for leaking the draft opinion referenced above.

Additionally, we request the Justice Department provide a briefing to the Committee Members on this matter, including the status of any investigations and whether criminal charges are being considered against the individual or individuals responsible for this breach. We request this briefing no later than May 10, 2022.

Thank you for your consideration of this important issue.
