GOVERNOR

Description of office: The governor is the chief executive officer of the commonwealth, executing the laws of the state through executive agencies. A governor must be at least 30 years old and have been a U.S. citizen and resident of the state for seven years preceding the election. S/he manages the financial affairs of the state and must annually present a balanced budget to the General Assembly. The governor has extensive appointive powers, may recommend legislation, and signs or vetoes bills passed by both houses of the General Assembly (subject to 2/3 override). S/he is commanderin-chief of the state National Guard, except when they are called into the actual service of the United States. The governor can grant reprieves, pardons and paroles. The holder of this office may only be reelected once. Salary: \$213,026

LIEUTENANT GOVERNOR

Description of office: The lieutenant governor will be elected jointly with the governor in the general election, although candidates are nominated separately in the primary. A lieutenant governor must be at least 30 years old and have been a U.S. citizen and resident of the state for seven years preceding the election. S/he is president of the Senate, presiding over the Senate but having no vote unless the Senate is equally divided. S/he is chair of the Board of Pardons and the Pennsylvania Emergency Management Council. The Pennsylvania Constitution provides that in case of the death, conviction or impeachment, failure to qualify, resignation or other disability of the governor, the powers, duties and compensation of the office shall be transferred to the lieutenant governor for the remainder of the term or until the disability is removed. There are no term limits to this office. Salary: \$178,940

Those that exceeded the word limit are indicated by /// at the end of the response. Candidates were invited to participate in the Vote411 online voters guide sponsored by the LWVPA-CEF and Patriot News/ Penn Live via email. All reasonable efforts

were made to encourage candidates to participate. The candidates listed are those whose names appear on the ballot as of March 10. The candidates are listed according to their party. Nothing in this guide should be construed as an endorsement or nonendorsement of any candidate, party or initiative by the League of Women Voters of Pennsylvania-Citizen Education Fund.

ABSENTEE AND MAIL-IN VOTING

Registered voters who are ill, disabled, may be absent from the municipality or choose to vote via mail-in ballot on Election Day may vote by absentee ballot or mail-in ballot. Completed applications for absentee and mail-in ballots must be received by 5 p.m. May 10. Completed absentee and mail-in ballots must be received back to the board of elections by 8 p.m. May 17. If an emergency arises (unexpected illness or business trip) after the May 10 deadline, call your county board of elections for information on emergency absentee voting. In order to obtain an emergency absentee application you may need to provide proof of emergency. Any disabled voter having questions regarding the accessibility of a polling place should

consult the county board of election.

WRITE-IN VOTING

Information for write-in voting will be available at the polling place.

ELECTION DAY PROBLEMS

If your right to vote is challenged at the polls on Election Day and the problem cannot be resolved at the polling place, the judge of elections at the polling place should telephone the county board of elections. The problem could be resolved by phone if your name appears on the county records. If it does not and you want to try to resolve the problem, then you can go in person to the county board of elections, where a judge from the Court of Common Pleas will be on duty to resolve election problems. Alternatively, you can ask for and vote by provisional ballot. If it is later determined that you were eligible to vote, your ballot will be counted. You will be given instructions on how to determine if your vote was counted. If you have questions or need to report any problems, call 1-866-OURVOTE for assistance in English or Spanish or 1-888-APIVOTE for assistance in Asian languages.

IDENTIFICATION REQUIREMENTS FOR NEW VOTERS

If you are a new voter or if you are voting at a polling place for the first time, you must bring your voter ID card or photo ID such as a driver's license, student ID or some other form of federal or state government-issued ID. Some forms of nonphoto ID are also acceptable, such as a firearm permit, current utility bill, bank statement, paycheck or government check. If you do not have an acceptable ID, then you must be allowed to vote by provisional ballot. If you are not a new voter and are not voting at the polling place for the first time, you are NOT required to bring or provide identification.

A U.S. representative must be at least 25 years old, have been a citizen of the United States for the past seven years, and be a resident of the state they seek to represent at the time of the election (though not necessarily the same district). The House of Representatives is responsible for introducing and voting on bills, resolutions and amendments, and for approving the budget. Representatives

Senators must be at least 25 years old, have been a citizen and a resident of the state for four years and a resident of their district one year before their election, and shall reside in their district during their terms of service. The Senate develops budget packages, makes taxation decisions, allocates spending and passes laws (including redistricting in collaboration with the House of Representatives). In addition, the Senate tries officials impeached by the House and authorizes executive appointments. Senators serve on various policy committees that may propose legislation. 
