On April 4, 2022, the Office of the Attorney General ("OAG") received a public information request under the Public Information Act ("PIA"), Chapter 552, Government Code, from Ms. Emma Lewis. A copy of the request is attached as Exhibit A.

The OAG will release some responsive information. However, our office asserts the remaining responsive information is excepted from required public disclosure under the PIA. Pursuant to sections 552.301(b) and 552.301(e) of the Government Code, the OAG submits this brief to seek a decision as to whether section 552.103 of the Government Code applies to the information at issue. The OAG has copied the requestor as a recipient of this brief pursuant to sections 552.301(d) and 552.301(e-1) of the Government Code. A representative sample of the information at issue is attached as Exhibit B.

I. Information Excepted from Required Public Disclosure Under Section 552.103: Pending Litigation

Section 552.103(a) of the Government Code states that information is excepted from required public disclosure if it is information:

relating to litigation of a civil or criminal nature to which the state or a political subdivision is or may be a party or to which an officer or employee of the state or a political subdivision, as a consequence of the person's office or employment, is or may be a party.

Gov't Code § 552.103(a). The purpose of section 552.103 is to enable a governmental body to protect its position in litigation by forcing parties to obtain information relating to litigation through discovery procedures. See Open Records Decision No. 551 at 4-5 (1990). The OAG has the burden of providing relevant facts and documents to show that the section 552.103(a) exception is applicable in a particular situation. The test for meeting this burden is a showing that (1) litigation is pending or reasonably anticipated, and (2) the information at issue is related to that litigation. University of Tex. Law Sch. v. Texas Legal Found., 958 S.W.2d 479, 481 (Tex. App.—

Austin 1997, no pet.); *Heard v. Houston Post Co.*, 684 S.W.2d 210, 212 (Tex. App.—Houston [1st Dist.] 1984, writ ref'd n.r.e.); ORD 551 at 4. The OAG must meet both prongs of this test for information to be excepted under section 552.103(a).

The communications at issue are related to five pending lawsuits, in which the OAG is representing the State. State of Texas v. Equal Employment Opportunity Commission, et al, Case No. 2:21-cv-00194-Z; Jane Doe, et al v. Greg Abbott, et al, Cause No. D-1-GN-22-000977; Texas, et al v. Biden, et al, Case No. 2:22-cv-00014-M; Texas v. Biden, Case No. 4:21-cv-00579-P; and Elizabeth Van Duyne and the State of Texas v. Centers for Disease Control and Prevention, et al, Case No. 4:22-cv-00122-O were all pending prior to the date of the instant request. The representative sample of communications in Exhibit B relates to the pending cases and has not been seen or accessed by all parties in the respective litigation. Accordingly, the OAG asserts the information at issue in Exhibit B may be withheld from required public disclosure under section 552.103 of the Government Code.

II. Conclusion

The OAG respectfully requests a decision from the Open Records Division regarding the applicability of the argued exception as provided by the PIA.

Brief Concerning Attorney General Opinion Request RQ-0426-KP

Introduction¹

On August 6, 2021, Governor Abbott requested the Commissioner of the Texas Department of Family and Protective Services ("DFPS") to "issue a determination of whether genital mutilation of a child for purposes of gender transitioning through reassignment surgery constitutes child abuse." Governor Abbott asked the Commissioner to consider the broad definition of child abuse under state law and the fact that female genital mutilation is separately prohibited. The governor stated that Texas law on child abuse "should cover" sterilizing surgeries and removal of healthy reproductive organs and breasts done for "reassignment" purposes on minors.

The DFPS Commissioner replied to the Governor by letter of August 11, 2020, and confirmed that "genital mutilation of a child through reassignment surgery is child abuse," but presumed that the abuse applied where such surgeries were done "for non-medical purposes" and also clarified that "[w]hen medically necessary, this surgical procedure may not constitute abuse." On August 23, 2021, Representative Matt Krause, Chair of the Texas House Committee on General Investigating, wrote to the Office of the Attorney General asking for official clarification as to exactly which sex change procedures performed on children constitute child abuse and if the administration of certain drugs or hormones that result in permanent infertility in minors would constitute child abuse as well. Finally, Chairman Krause asked that any clarifications on these points consider exceptions for medical necessity with respect to physical disorders of sexual development.

In assessing whether medical treatments cause injuries for child abuse purposes, relevant considerations are the expected health benefits versus harms of the treatment, governing standards of care, and informed consent. The analysis below argues that there is neither federally-required nor federally-recognized standards of care for transgender treatments in minors that would preclude competent state authorities from deeming such treatments excessively risky, harmful, and not medically indicated based on their independent analysis of the best available medical evidence.

Medical risks and benefits of transgender treatments and standards of care

Although customary medical competency standards exist through centralized accreditation and testing organizations,⁶ there is no formal national medical licensing regime in the United States and medical licensing and discipline remain primarily an exercise of state police power. However, with respect to drugs and biologics, the federal government licenses and approves specific medical uses after the FDA establishes their safety and efficacy under the Food, Drug, and Cosmetic Act.⁷ Additionally, the FDA may require certain particularly risky medications to be administered by physicians under tighter protocols called a Risk Evaluation and Mitigation Strategy (REMS).⁸ Federal law does not prohibit physicians from administering drugs "off-label," that is, for medical or treatment purposes not approved by the FDA, when done in accord with medical judgment and with no illegal purpose.⁹

Drugs currently being used "off-label" to block puberty or to further or induce cross-sex transition for gender identity purposes include Histrelin Acetate, Leuprolide Acetate (puberty blockers); Estradiol, Premarin (estrogen); Androderm, Testosterone Enanthate or Cypionate, Axiron, Testopel, Striant (testosterone); Goserelin Acetate (LHRH antagonists); Depo-Provera, Provera, Prometrium (progestins).

The side effects and harms of these drugs include:

Permanent infertility Serious mental health effects Venous thrombosis/thromboembolism Increased risk of cardiovascular disease

Weight gain
Decreased libido
Hypertriglyceridemia
Elevated blood pressure
Decreased glucose tolerance
Gallbladder disease
Benign pituitary prolactinoma
Lower HDL and elevated triglycerides
Increased homocysteine levels
Hepatotoxicity
Polycythemia
Sleep apnea
Insulin resistance
Chronic pelvic pain
Increased cancer and stroke risk. 10

The side effects of surgical interventions for sex-reassignment purposes such as hysterectomy, oophorectomy, metoidioplasty, orchiectomy, penectomy, phalloplasty, vaginoplasty, and mastectomy are serious and include some of the above as well as many others associated with major surgery including increased risk of death.

Finally, it is well known that symptoms of gender dysphoria in children naturally resolve with little to no intervention in 61-98% of cases and that once a child is placed on transition, including through medical intervention, the odds of persistence skyrocket.¹¹

In terms of any potentially offsetting mental health benefits of medical gender transition interventions, such as greater psychic well-being and reduced suicide rates, there is insufficient rigorous data to recommend such interventions as a federally-recognized standard of care. On August 30, 2016, the Centers for Medicare & Medicaid Services (CMS) declined to issue a National Coverage Determination on sex-reassignment surgery for Medicare beneficiaries with gender dysphoria "because the clinical evidence is inconclusive." CMS determined, "[b]ased on an extensive assessment of the clinical evidence," that "there is not enough high quality evidence to determine whether gender reassignment surgery improves health outcomes for Medicare beneficiaries [which include non-seniors] with gender dysphoria and whether patients most likely to benefit from these types of surgical intervention can be identified prospectively."

Similarly, in a 2018 Department of Defense (DOD) report on the diagnosis of gender dysphoria, which included input from both transgender individuals and medical professionals with experience in the care and treatment of individuals with gender dysphoria, DOD found that there is "considerable scientific uncertainty and overall lack of high quality scientific evidence demonstrating the extent to which transition-related treatments, such as cross-sex hormone therapy and sex reassignment surgery—interventions which are unique in psychiatry and medicine—remedy the multifaceted mental health problems associated with gender dysphoria." 13

In 2020 the Office for Civil Rights at the U.S. Department of Health and Human Services (HHS), addressed whether Section 1557 of the Affordable Care Act required health insurers to cover transgender procedures and treatments and doctors to perform and administer them. ¹⁴ HHS again concluded that there is no federally-recognized or required standard of medical necessity for transgender procedures undertaken to ameliorate symptoms of gender dysphoria. ¹⁵

Off-label prescription of FDA-approved drugs, while a fairly common practice, does put medical practitioners at significantly greater risk of liability for any resultant harms, especially where there has not been a standard of care established for such off-label usage. ¹⁶ Transgender drugs and surgeries resulting in permanent and dramatic physical, psychological, and behavioral changes should still be considered experimental given the paucity of long-term studies on their effects with respect to adults and given the mixed results of the studies that do exist. These deficiencies are doubly magnified with respect to children. ¹⁷

Indeed, some countries that pioneered "gender-affirming" medical interventions are now scaling back due to the widespread harms they have inflicted on children. For example, the Karolinska Hospital in Sweden has ended the practice of prescribing puberty blockers and cross-sex hormones to gender-dysphoric patients under the age of 18 after having been a world-leading provider of such treatments. ¹⁸ State medical authorities in Finland revised treatment guidelines in

June 2020 to disfavor medical interventions for treatment of gender dysphoria in minors. ¹⁹ And in the United States, Arkansas recently passed a law²⁰ prohibiting administration of drugs or surgeries for gender transition purposes as a treatment for gender dysphoria, and Tennessee passed a more narrow law²¹ prohibiting pre-pubescent youth from being administered transgender hormones. ²²

Conclusion

While not dispositive to the question presented, your office should consider that there are currently no federally-recognized or federally-required standards of care with respect to lifealtering transgender treatments generally—and certainly not with respect to children—that would preclude competent state authorities from deeming such treatments excessively risky, harmful, and not medically indicated based on their independent analysis of the best available medical evidence.

Dear Aaron,

I see that my colleague Fr. Mark Hodges has already reached out to you about being our guest on the Dr. J Show. He did much more background research on you than I did! I had no idea that you were involved in all the issues he outlined.

My name is Fr. Mark Hodges, and I am an Orthodox Christian archpriest. I work for <u>The Ruth Institute</u> as producer/scheduler for "<u>The Dr. J Show</u>," an hour-long interview with experts hosted by <u>Dr. Jennifer Roback Morse</u>.
