Having been advised by Jeff Stein, LPI, BAI, CCDI, V.S.M., that he is a Private Investigator conducting an investigation on behalf of David Satchell, I freely and voluntarily make this statement. No offer of any benefit or reward has been made to me and no one has threatened or forced me to make this statement.

On May 20th, 2007, I was sitting on the steps and I saw three males coming down the block with guns, I saw them and 2 other people start shooting. David Satchell was not any of the 5 males that I saw shooting. I was never questioned on the day of this incident. In fact, I was not questioned until several months later while I was being interviewed about an unrelated matter. I was already in custody pending a VOP hearing. I was brought down to homicide from SCI - Graterford. I was interviewed by detective Pitts, Hesser and Rodden for 2 straight days. I was only fed once and I was isolated for long periods of time in the same room. Detective Pitts kept threatening me. He was grabbing me and spiting in my face while screaming at me. He told me that I had to say that David Satchell and Rasheem Hall were shooting that day or I would get charged, so after two days of being tormented by the detectives, I told Detective

Pitts what he wanted me to say. Even though I did not see either Hall or Satchell shooting any guns that night. I was scared for my life and wanted to go home and after the two days of being abused verbally and physically by the detectives, I said David Satchell was shooting. When in fact I did not see David Satchell shooting a gun that day, I saw David Satchell running away when the shooting started.

The day I testified at David Satchell's trial ADA Richard Sax told me, that since I was testifying, I would get help at my VOP Hearing because of my testifying.

I am willing to testify to this in an open court. No Threats or Promises were made for me to give this statement.

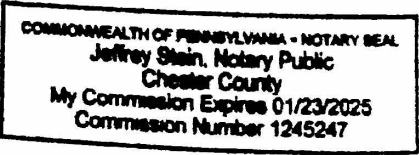

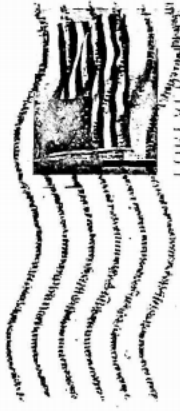
