SECTION II - ALLEGED VIOLATOR

Section 19 of the Animal Welfare Act (7 U.S.C. & 2131 et seq.), authorizes the Secretary of Agriculture to assess a civil penalty of not more than \$2,500 for each violation and to suspend or revoke the license of any dealer, exhibitor, or operator of an auction sale subject to section 12 of the Act, after notice and opportunity for a hearing.

You may waive the hearing and agree to pay the specified civil penalty in settlement of this matter. If you do not wish to pay the specified civil penalty to waive hearing, a complaint may be issued charging you with the violation(s) and affording you an opportunity for a hearing. However, the civil penalty offered to settle this matter at this time shall not be relevant in any respect to the civil penalty which may be assessed after a hearing.

I acknowledge that I have been given an opportunity for a hearing and waive such hearing; and as a civil penalty in full settlement of this matter, I agree to pay the sum of \$500.00.

Dear Sirs:

Our investigation shows that you violated the Animal Welfare Act of the Federal Animal and Plant Health Regulations as described on the enclosed Civil Penalty Stipulation Agreement form. These regulations provide for criminal penalties up to \$2,500 and/or 1 year in jail or civil penalties up to \$2,500 for each violation.

The Secretary of Agriculture may assess a civil penalty for such violations after notice and an opportunity for a hearing. **However, you may waive your** right to a hearing and settle this matter by paying \$500 and completing Section II of the agreement form. You may voluntarily enter this agreement to avoid further action.
