Our investigation shows that you violated the Animal Welfare Act of the Federal Animal and Plant Health Regulations as described on the enclosed Civil Penalty Stipulation Agreement form. These regulations provide for criminal penalties up to \$2,500 and/or 1 year in jail or civil penalties up to \$2,500 for each violation.

The Secretary of Agriculture may assess a civil penalty for such violations after notice and an opportunity for a hearing. However, you may waive your right to a hearing and settle this matter by paying \$500 and completing Section II of the agreement form. You may voluntarily enter this agreement to avoid further action.
