On August 4, 2015, at 0311 hours 911 dispatch received an emergency call from a 79 year old female victim who said she had been sleeping and was home alone when she heard a noise, but was not sure where it came from. She said she heard a loud bang and believed someone was inside her home. While on the phone with dispatch, a suspect opened her bedroom door and the victim said, "oh!" The suspect then fired one round towards the victim and took off running. The victim heard several more shots being fired and then it became quiet. The victim described a grey four door coupe parked in her driveway. Dispatch remained on the phone with her until deputies arrived at 0318 hours. The suspect vehicle was not present when deputies arrived. I was called out and responded to 6704 Donlon Road. Crime Scene Investigator Genynne Vasquez also responded to process the scene.

Upon arrival, I received information from Indian River County Sheriff's Office that one of their deputies, Sam Earman, responded to 2380 10th Road SW, in reference to a criminal mischief. This call came to them on August 4, 2015, at 0327 hours. When D/S Earman arrived he had a black male, wearing a black t-shirt and blue jeans run in front of his patrol car. A foot chase ensued, but the subject was not located. A witness/complainant, Jason Mitts said he was awakened by some loud banging coming from the parking lot. He looked outside and observed two black males standing behind a four door grey car, with the trunk lid open. He yelled at the subjects, thinking they were breaking into cars. When he yelled, the two subjects took off running. Mitts told deputies he has never seen this vehicle and it does not belong there. D/S Earman received the BOLO in reference to the grey four door car involved in my Burglary and notified us of his findings. I would estimate the driving time from the crime scene, 6704 Donlon Road to 2380 10th Street, where the vehicle was located to be 3 to 5 minutes. A Google search revealed the driving time to be 8 to 10 minutes, normal driving. I had our Sheriff's Office tow truck respond and take possession of the vehicle. Due to the time frame between the two incidents and the matching description provided to me by the victim, this vehicle was towed to the St. Lucie County Sheriff's Office vehicle compound. The vehicle doors were locked, so an inventory was not complete at this time. I did observe, in plain view, a locked metal suitcase and some gas cans in the trunk of the vehicle. I observed several articles of clothing, a Crown Royal bag which contained unknown items and several Lottery Tickets which were sitting on the seats and could be seen through the windows.

Back at 6704 Donlon, I spoke with the victim, Mary Bauer who was visibly shaken over this incident. She told me she does not know why someone would want to do this to her. She said she lives alone and has not had any visitors in her home. She explained she does perform karaoke at the AmVet, but has not spoken to anyone there about her personal life. She said she does not think the suspects were able to take anything from her residence. She again described the person who shot at her as being stocky build, with muscular legs. He was also wearing something on his head, so

she was unable to say if he was white or black. She was able to see the suspect vehicle, which was parked in her driveway and described it as being a grey four door coupe. She explained further, the suspect vehicle was, "Not shiny, but older looking."

I was able to walk through the scene and determine the suspect took a concrete landscape brick and throw it through the rear sliding glass door. He made entry and went to the victim's bedroom door, which was closed. When he opened the bedroom door, the victim had already crouched down on the opposite side of the bed, the suspect fired one round across the bed and above the victim's head. The projectile entered the dresser drawer. Once he fired that round he ran back towards the sliding door and fired three more rounds back towards the bedroom. The suspect then ran to the front driveway, where the suspect vehicle was parked and fired at least two more rounds towards the front of the residence, before leaving the scene. Investigator Vasquez processed the scene and was able to locate 6 shell casings, all were PMC brand 380 caliber casings. She was only able to locate 3 projectiles, one from the bedroom dresser, one in a china hutch, which was located in the living room and the third in the living room, under the front window. She also informed me she has collected a hair sample and possibly a blood stain from the curtain which covered the sliding glass door and was the point of entry. Investigator Vasquez collected samples of the broken glass from the sliding door, some potting soil, which had been in a plastic rooster, but was broken and contents spilled, and some bird seed, which fell out of the victim's bird cage when the glass was broken. Upon reviewing the 911 audio tape, which recorded this incident, it was determined there were actually two rounds fired in the master bedroom. The second round was located and recovered from the bed mattress.

It was determined the registered owner of the suspect vehicle is Kaytrina Humphrey Williams who resides at 4760 47th Court, Vero Beach, Florida. Detective Clay Mangrum responded to this address and made contact with Williams. She said she purchased that vehicle for her son, Dennis Earl Williams and his girlfriend, Destinee Scott. Mrs. Williams said they live in St. Lucie County, in Sabal Chase Apartments. Detective Mangrum discovered Scott lived at 102 Calypso Drive. He responded to this address where he was able to make contact with Scott. She said her boyfriend Williams left with the vehicle at about 0100 hours this morning. She said she did not see anyone with him when he left. She said at about 0530 hours, this morning Williams came home, briefly and left again. She said she could not say who he was with or how he got there. She was asked where Williams was, but she said she did not know. She spontaneously said she was concerned for Williams because she heard about a shooting on Oslo Road. She told Detective Mangrum she heard about this on a site called Police Scanner. Detective Mangrum was able to obtain written consent from Scott to search her apartment. A 380 caliber PMC shell casing was found under the couch cushion, in the living room. Detective Mangrum also collected a pair of men's shoes, which were located in Scott's bedroom. The shoes were still damp with moisture and appeared to have recently been worn. Scott told Mangrum these shoes belonged to her boyfriend, Dennis Williams. This casing and shoes were collected and placed into evidence. This casing is the same brand and caliber as the casings recovered from the scene.

The shell casings recovered from the crime scene along with the casing recovered from the apartment were sent to the Indian River Crime Lab and analyzed by Mark Chapman. Chapman was able to confirm that the casings from the crime scene were fired from the same firearm as the casing collected from the apartment. Investigator Vasquez and I were able to view the recovered shoes. In the lugs of the shoes there appeared to be a long, gray hair. Scott or Williams do not have long gray hair, but my victim does have long gray hair. Also noticed in the lugs of the shoes is what appears to be some type of dark potting soil and what looks like some type of bird seed.

On August 5, 2015, I was able to obtain a search warrant to search the vehicle. During the search the vehicle was vacuumed for trace evidence, DNA swabs were gathered and the vehicle was dusted for latent prints. I also recovered several items of clothing, one being a white t-shirt with what appears to be blood, a Vaultz CD case, containing numerous music CD's, a Swatch brand watch, an LG cell phone, a single left handed glove, two pawn transaction slips, one transaction by Williams and the other by Akeem Juwon Emory and several Lottery scratch off tickets. All items were documented, bagged and placed into evidence. Investigator Vasquez analyzed the stain on the white t-shirt and told me the stain tested positive for human blood. The stain on the curtain recovered from the crime scene also tested positive as being human blood.

On August 6, 2015, I made contact with Destinee Scott and asked if she would be willing to respond to the Sheriff's Office and speak with me further. She agreed and did respond to my office. Scott said herself, her boyfriend, Dennis Williams, "King" Akeem Juwon Emory and a black male only known as "G-Money" were hanging out at her apartment. At about 2330 hours, Emory and G-Money left, leaving her and Williams at the apartment. She said her and Williams had been watching a movie and began to argue. Williams asked to use her vehicle, which she agreed. She said she needed her vehicle the following morning to go to school. Williams left the apartment sometime between 0100 and 0120 hours on August 4, 2015. She said he did not say where he was going. She told me at around 0530 hours Williams returned. She said she knew he did not have the vehicle because her vehicle is loud with some mechanical problems and you can hear it. She claims she did not ask where her vehicle was because she had been asleep. Williams apparently left again and she did not see him again that day. I asked if she called him that morning because she needed the car to go to school. She said Williams does not have a cell phone, so she did not speak to him again. I explained to her that seemed a little odd and asked her how she communicates with him. She claims she does not communicate with him. I asked her if I could look at her cell phone to verify her story that she does not speak with Williams. She denied, saying she does not want me going through her phone. I asked her if she has a Facebook site she utilizes. She said she does have a Facebook account, but again she refused to allow me to view this account.

On August 20, 2015, I was informed that Indian River County Sheriff's Office arrested Dennis Earl Williams on the charge of Burglary, criminal mischief and possession of burglary tools. He was incarcerated in the county jail. I spoke with Indian River County Philective who provided me a copy of their report from this burglary. Upon reviewing this report, I noted Williams used the same Method of Operation (MO) in this burglary as compared to my case. The MO is throwing a yard brick through a rear window and the Indian River burglary was at 0247 hours and mine was at 0311 hours. Detective Mangrum and I responded to the Indian River County Jail, where I was able to speak with Williams. Williams was read his Miranda

Warnings and asked if he understood. He said he did understand and would speak with me. Inevitably, Williams denied involvement and asked for a lawyer. The interview was concluded.

In summary the registered owner of the vehicle says she bought the suspect vehicle for her son and his girlfriend, Dennis Williams and Destinee Scott. Scott admits that on August 4, 2015, Williams left her apartment in the vehicle between 0100 and 0120 hours. Williams then returned to the apartment at about 0530 hours without the vehicle. A written consent search form was signed by Scott to search the apartment. A shell casing was recovered from the couch, in the living room and a pair of damp, recently worn shoes were collected from Scott's bedroom. Scott admits these shoes belong to her boyfriend Williams. These shoes had what appears to be dark potting soil, seed which is consistent with bird seed and a long gray hair, which resembles the victim's long gray hair. Neither Scott nor Williams has gray hair. At the crime scene, when the suspect broke the sliding glass door he also broke a planter pot, causing a large amount of potting soil to be left on the ground and mixed in with the broken glass. As the suspect entered the house the victim's bird cage was knocked over causing bird seed to spill all over the floor, in the path of the entry/exit point. The suspect would have had to run through the potting soil, broken glass and bird seed upon exiting the residence. It was verified by Indian River Crime Lab, Mark Chapman the recovered shell casing from the apartment was fired by the same firearm as the casings recovered from the crime scene. I was also informed by Investigator Vasquez she has recovered a latent print from the steering wheel of the vehicle, from which she was able to match to Dennis Earl Williams. There was also a CD case, which was located in the trunk of the vehicle, which a latent print was recovered. This print was also matched to Dennis Williams.

I am requesting arrest warrants for Dennis Earl Williams on the charges of Attempted Felony Murder FS. 782.051 (1) and Burglary with an Assault or Battery, FS. 810.02 (2) (a).
