We received your 300 Freedom of Information Act (FOIA) requests on 21 December 2021 seeking: 1) Significant Activity ("SIGACT") Reports; 2) Commander's Situational Reports ("SITREP"); 3) After-Action Reports ("AAR") or Unit After-Action Reports ("Unit AAR"); 4) Serious Incident Reports ("SIR"); 5) Administrative investigation reports, including but not limited to AR 15-6 reports, JAGMAN investigations, Command Directed Investigation ("CDI") reports, and any related records, attachments, memoranda, statements, etc.; 6) Fatality Investigation Reports and related records, attachments, memoranda, statements, etc.; 7) Criminal Investigation reports and related records, attachments, memoranda, statements, etc.; 8) Defense Casualty Information Processing System-Forward ("DCIPS-CF") reports; 9) Medevac Nine-Line transcripts; 10) Medevac Assault Support Requests; 11) Intelligence Directorate (S-2, G-2, and CJ-2) Operations Watch Highlights reports; 12) Intelligence Directorate (S-2, G-2, and CJ-2) Intelligence Summaries ("INTSUM") for the day of and the day following each Attack; 13) Multi-National Force-Iraq (MNF-I) Battle Update Assessment ("BUA") briefing slides; 14) IED or other explosives/weapons reports; 15) IED-Event or other explosives/weapons storyboards; 16) CIDNE Reports; 17) IED Post-Patrol Debrief (64-Liner) reports; 18) Weapons Intelligence Team ("WIT") reports; 19) Composite Timeline reports; 20) Incident and Operational Reports ("OPREP"); 21) Battle Damage Assessment Reports ("BDAREP"); 22) Explosive Ordinance Disposal ("EOD") Reports; 23) Combined Explosives Exploitation Cell ("CEXC") Reports; 24) Terrorist Explosive Device Analytical Center ("TEDAC") Reports; 25) Task Force Troy Reports; 26) Line of Duty ("LOD") Investigation Reports/Determinations; 27) Real-Time Regional Gateway ("RTRG") Reports; 28) Lessons Learned Reports; 29) Preliminary Inquiry Reports; and 30) Sworn Statements. In accordance with the Department of Defense (DoD) Manual 5400.07, DoD FOIA Program, U.S. Central Command (USCENTCOM) aggregated your 300 requests into one since these requests clearly involve related matters. Additionally, you requested information that is service specific; therefore, you should contact each service who may have records pertinent to your request which were not shared with USCENTCOM. Your requests are being processed in accordance with Title 5 U.S.C. § 552 Freedom of Information Act and Privacy Act, and Executive Order 13526. The actual processing time for these documents will depend upon consultation with other DoD components, stateside, overseas, or other agencies.

Before USCENTCOM can provide the requested information, you need to provide identity documentations for the release of Personally Identifiable Information (PII). In accordance with the DoD Privacy Act Program, 5400.11-R, when PII in a record is requested by the subject of the record or the subject's attorney, notarization of the request, or a statement certifying under the penalty of perjury that their identity is true and correct may be required (See Attachment).

Additionally, written consent of the subject of the record is required for disclosure from a Privacy Act System of records, even to the subject's attorney. A first party access request must cite both the Privacy Act of 1974 and the FOIA.

Therefore, we request that you provide the documentation and submit your perfected FOIA/Privacy Act request for processing. If a response is not received by 10 March 2022, your request will be administratively closed.

We placed your requests (assigned FOIAs 22-0063 through 22-0362) in our queue at #s 3041 through 3340. Each request requires multiple searches for the various records you requested. This has prompted us to provide you with additional information regarding our Command and the records you seek.

USCENTCOM is one of eleven combatant commands of the United States armed forces subordinate to the DoD; it directs and enables military operations and activities with allies and partners to increase regional security and stability in support of enduring United States interests within its Area of Responsibility (AOR). At present, USCENTCOM's AOR includes 20 nations in the Middle East, Central and South Asia, and the strategic waterways that surround them. Like all combatant commands, USCENTCOM constitutes a headquarters element without any military units permanently assigned to it; USCENTCOM operates with component commands within its AOR—one for each of the U.S. armed services, along with a joint special operations component and a number of subordinate joint task forces.

Per your requests, records managers will execute searches for each of your requests. The searches are completed through document content key word searches of electronic files on USCENTCOM's Secure Internet Protocol Router Network, Micro Focus Content Manager, for potentially responsive information. Micro Focus Content Manager is USCENTCOM's indexed records management system containing over 131 million war records, including those retrieved from headquarters elements serving in Afghanistan and Iraq. We anticipate these searches will generate potentially responsive records requiring manual review prior to beginning the declassification review process. In our experience, the names of your clients may appear in many types of records, such as draft and finalized casualty reports, memorials to those wounded or killed, primary next of kin (PNOK) memoranda, unit rosters, public news releases, and line of duty reports. These records do not contain the type of substantive information that the FOIA requests appear to be seeking. If you are willing to agree to exclude any or all of these categories of documents from the scope of your broad requests, the remainder of the records you have requested could be produced more quickly. Likewise, if you have any additional information specific to the records you seek, such as grid coordinates of incidents, report numbers, unit of assignment, synopsis of incident, etc., please provide this information to assist manual reviewers to identify the records you seek.

While our Operations and Intelligence directorates will also have to execute required searching in their separate systems, it is possible that USCENTCOM will not have records corresponding to some of the incidents that you have identified in your requests. The records you seek include a wide array of records pertaining to incidents that took place in the USCENTCOM AOR over decades of war fighting. While combat operations in Iraq and Afghanistan during this timeframe were within USCENTCOM's AOR, the particular role and structure of the combatant command does not mean that each and every record generated by each of the component

commands (and their subordinate units) during that lengthy and ongoing conflict necessarily are located within USCENTCOM's recordkeeping systems. Moreover, despite the significant, and often tragic, nature of the incidents identified in your requests, myriad factors dictated what types of records were generated as a result of a particular incident, and whether those records ultimately were stored in databases or other archives within the custody and control of USCENTCOM, as opposed to another component of the Department of Defense, or another federal agency entirely.

For example, you requested investigations into the death or injury of your clients. Investigations of this type are typically service specific law enforcement records that would not be within the records systems of USCENTCOM, or are overseen by unit commanders at various levels, and each service component is responsible for PNOK and casualty assistance procedures. In death cases, the deceased service member's PNOK should have received a copy of any investigation, if requested, from the Command that prepared the investigative report. USCENTCOM does not normally direct these investigations, nor require copies be provided for maintenance within our records management system. I recommend you request such records directly from the military service in which your clients were assigned.

In addition, the Combined Explosives Exploitation Cell (CEXC) database is maintained by NSWC Indian Head EOD Technology Division, 2008 Stump Neck Road, Building 2172, Indian Head, MD 20640-5070.

USCENTCOM will have subject matter experts searching the Combined Information Data Network Exchange (CIDNE) for the Significant Activity (SIGACT) reports you requested. Typically, these searches are facilitated by searching for grid coordinates or CIDNE report keys obtained by requesters from records already in their possession. Pinpointing your requested report with little more than a date and general geographic location requires manual review of every SIGACT on the day — which can include hundreds of reports. In addition, recording of grid coordinates during incidents is not an exact method for recovery of records related to an incident. If you have grid coordinates, report keys, or any further information to scope your separate requests, please provide them as being associated to the particular FOIA number.

You have the right to appeal to the appellate authority, Ms. Joo Chung, Assistant to the Secretary of Defense for Privacy Civil Liberties, and Transparency (PCLT), Office of the Secretary of Defense, at: 4800 Mark Center Drive, ATTN: PCLFD, FOIA Appeals, Mailbox #24, Alexandria, VA 22350-1700. Your appeal must be postmarked within 90 calendar days of the date of this response. Alternatively, you may email your appeal to osd.foia-appeal@mail.mil. If you use email, please include the words "FOIA Appeal" in the subject of

the email. Please also reference FOIA case numbers 22-0063 through 22-0362 in any appeal correspondence.

The USCENTCOM FOIA Requester Service Center receives numerous FOIA requests and has a substantial number of pending FOIA cases. Therefore, we process requests in a multi-track processing system based on the date of receipt and complexity of the request. The FOIA does not require agencies to respond to questions, to do research, compile or analyze data, summarize, or conduct surveys for members of the public. You should be aware that the FOIA only provides the means by which the public can request specific documents from USCENTCOM.
