The Organization conducted media and public presentations covering judicial and executive branch nominations, Supreme Court vacancies, major Supreme Court cases being considered, previews of the upcoming term, and principles of federalism and civic accountability. All these activities have helped to strengthen the rule of law, reinforce the view of a fair and impartial judiciary, promote fidelity to the principles of federalism and civic accountability.**
