Dear Senator Fonfara, Representative Scanlon, Senator Martin, Representative Cheeseman and Secretary Beckham:

Pursuant to Conn. Gen. Stat. § 12-458h, the Commissioner of Revenue Services is required, on or before June 15, 2022, to calculate the applicable tax rate per gallon of diesel fuel for the fiscal year beginning July 1, 2022. In accordance with this statutory obligation, I am hereby notifying you that, effective July 1, 2022, the tax rate on diesel fuel will be 49.2 cents per gallon. As you are aware, this rate will remain in effect until June 30, 2023.

For your information, I have included a summary sheet showing the calculation for determining the tax rate that is prescribed by Conn. Gen. Stat. § 12-458h.

The Department will post information regarding the new tax rate on its website.
