AAF is staffed by experienced researchers and public affairs officials who would analyze and disseminate the information. Further, AAF qualifies as a "representative of the news media" and utilizes the websites its own websites AmericanAccountabilityFounation.com and BidenNoms.com to publicly distribute the original research stemming from the documents requested free of charge. Additionally, AAF maintains close relationships with reporters and policy makers who would amplify the findings associated with the requested documents.

For these reasons stated above, AAF satisfies the criteria for a fee waiver.

#### **EXPEDITED PROCESS**

The AAF requests expedited processing pursuant to 5 U.S.C. § 552 (a)(6)(E) based on a "compelling need" for these records. As defined by 5 U.S.C. § 552(a)(6)(E)(v)(II), there is an "urgen[t]" need for the information requested because AAF is primarily engaged in disseminating information with "urgency to inform the public concerning actual or alleged Federal Government activity."

(1) AAF is an organization primarily engaged in disseminating information to the public concerning actual or alleged government activity.

The AAF is an organization primarily engaged in disseminating information in order to bring transparency regarding actual or alleged government activity directly to the public. It is critical to the mission of the AAF and for transparency regarding government activities to obtain information,

scrutinize the information, and widely publish that information for the public consumption. The information obtained about government activity is directly published on our websites americanaccountabilityfoundation.com and bidennoms.com, and widely disseminated through social media platforms.

#### Additionally, the AAF publishes its findings and original analysis on its blogs

https://www.bidennoms.com/news and https://www.americanaccountabilityfoundation.com/blog. Examples of posts include an original report on donations to the Republican Governors Association, an investigation into no-bid contracts given to political cronies at DHS, and alleged insider trading allegation involving Biden Administration nominee.<sup>1</sup> The AAF also directly disseminates findings obtained through FOIA requests with the press through press releases and through interviews with print, digital, and tv news outlets.<sup>2</sup> This is an ongoing effort to provide timely, educational resources to the American public on the activities of government officials.<sup>3</sup>

(2) The records requested are urgently needed to disseminate information to the public on actual or alleged government activity.

These records are urgently needed to inform the public about actual or alleged government activity. Specifically, requested records relating to the past and ongoing activity of the Department of Justice on election related items including, but not limited to, activities to protect the integrity of elections, voting rights, early voting, vote by mail, access to voting, and the right of eligible voters to vote. As mentioned in August 2021, Attorney General Garland expressed the urgency to act "on relatively short notice" to ensure we have safe elections in the United States.<sup>4</sup> Additional measures taken by the Department of

Justice in June 2021 also reveal their actions to "protect civil rights" through ongoing review of postelection audits when they stated, "We are scrutinizing new laws that seek to curb voter access, and where we see violations, we will not hesitate to act" indicating that decisions are made in real time as the need arises.<sup>5</sup> Audits in several states, including Arizona and Wisconsin, maintain strict review periods that require the need for public access to information of activities undertaken by the Department of Justice while election audit and post-audit activities occur.<sup>6</sup>

28 C.F.R. § 16.5(e) expanded expedited processing to include requests for records involving the loss of substantial due process rights or matters of widespread and exceptional media interest in which there exist possible questions about the government's integrity that affect public confidence. Election administration and voting access necessarily implicates due process rights. See Griffin v. Burns, 570 F.2d 1065 (1st Cir. 1978); Roe v. Alabama, 68 F.3d 404 (11th Cir. 1995).

Trust in our Republic and its democratic election processes are of enormous public concern and require immediate dissemination of accurate information to the public on what the activities of their government leaders. As Attorney General Garland stated, "...there has been a dramatic rise in legislative efforts that will make it harder for millions of citizens to cast a vote that counts. So far this year, at least fourteen states have passed new laws that make it harder to vote. And some jurisdictions, based on disinformation, have utilized abnormal post-election audit methodologies that may put the integrity of the voting process at risk and undermine public confidence in our democracy."<sup>7</sup> Watchdog groups like the AAF facilitate as their primary mission the dissemination of information and unique analysis on government activities that help promote public confidence in the democratic process.

In accordance with 5 U.S.C 552(a)(4)(A)(iii), American Accountability Foundation also requests a waiver of all fees because the disclosure of the requested information is in the public interest and would contribute significantly to the public's understanding of the decision making at the Department of Justice and who the Attorney General meets from outside the organization, how they coordinate with Department of Justice leadership, and what influence they may have on the actions and policies as a direct result of their interactions. Much as the ethics offices conduct investigations, it is vital that the public through journalists and watchdog groups be enabled to conduct similar investigations.

### 5 U.S.C 552(a)(4)(A)(iii):

(iii) Documents shall be furnished without any charge or at a charge reduced below the fees established under clause (ii) if disclosure of the information is in the public interest because it is likely to contribute significantly to public understanding of the operations or activities of the government and is not primarily in the commercial interest of the requester."

The American Accountability Foundation (AAF) is a charitable and educational organization recognized by the Internal Revenue Service under section 501(c)3 of the Internal Revenue Code that conducts nonpartisan research and fact-checking so Americans can hold their public leaders accountable. AAF is staffed by experienced researchers and public affairs officials who would analyze and disseminate the information. Further, AAF qualifies as a "representative of the news media" and utilizes the websites its own websites AmericanAccountabilityFounation.com and BidenNoms.com to publicly distribute the original research stemming from the documents requested free of charge. Additionally, AAF maintains close relationships with reporters and policy makers who would amplify the findings associated with the requested documents.

For these reasons stated above, AAF satisfies the criteria for a fee waiver.

### **EXPEDITED PROCESS**

The AAF requests expedited processing pursuant to 5 U.S.C. § 552 (a)(6)(E) based on a "compelling need" for these records. As defined by 5 U.S.C. § 552(a)(6)(E)(v)(II), there is an "urgen[t]" need for the information requested because AAF is primarily engaged in disseminating information with "urgency to inform the public concerning actual or alleged Federal Government activity."

(1) AAF is an organization primarily engaged in disseminating information to the public concerning actual or alleged government activity.

The AAF is an organization primarily engaged in disseminating information in order to bring transparency regarding actual or alleged government activity directly to the public. It is critical to the

mission of the AAF and for transparency regarding government activities to obtain information, scrutinize the information, and widely publish that information for the public consumption. The information obtained about government activity is directly published on our websites americanaccountabilityfoundation.com and bidennoms.com, and widely disseminated through social media platforms.

Additionally, the AAF publishes its findings and original analysis on its blogs

<u>https://www.bidennoms.com/news</u> and <u>https://www.americanaccountabilityfoundation.com/blog</u>. Examples of posts include an original report on donations to the Republican Governors Association, an investigation into no-bid contracts given to political cronies at DHS, and alleged insider trading allegation involving Biden Administration nominee.<sup>1</sup> The AAF also directly disseminates findings obtained through FOIA requests with the press through press releases and through interviews with print, digital, and tv news outlets.<sup>2</sup> This is an ongoing effort to provide timely, educational resources to the American public on the activities of government officials.<sup>3</sup>

(2) The records requested are urgently needed to disseminate information to the public on actual or alleged government activity.

These records are urgently needed to inform the public about actual or alleged government activity. Specifically, requested records relating to the past and ongoing activity of the Department of Justice on election related items including, but not limited to, activities to protect the integrity of elections, voting rights, early voting, vote by mail, access to voting, and the right of eligible voters to vote. As mentioned in August 2021, Attorney General Garland expressed the urgency to act "on relatively short notice" to

ensure we have safe elections in the United States.<sup>4</sup> Additional measures taken by the Department of Justice in June 2021 also reveal their actions to "protect civil rights" through ongoing review of postelection audits when they stated, "We are scrutinizing new laws that seek to curb voter access, and where we see violations, we will not hesitate to act" indicating that decisions are made in real time as the need arises.<sup>5</sup> Audits in several states, including Arizona and Wisconsin, maintain strict review periods that require the need for public access to information of activities undertaken by the Department of Justice while election audit and post-audit activities occur.<sup>6</sup>

28 C.F.R. § 16.5(e) expanded expedited processing to include requests for records involving the loss of substantial due process rights or matters of widespread and exceptional media interest in which there exist possible questions about the government's integrity that affect public confidence. Election administration and voting access necessarily implicates due process rights. See Griffin v. Burns, 570 F.2d 1065 (1st Cir. 1978); Roe v. Alabama, 68 F.3d 404 (11th Cir. 1995).

Trust in our Republic and its democratic election processes are of enormous public concern and require immediate dissemination of accurate information to the public on what the activities of their government leaders. As Attorney General Garland stated, "...there has been a dramatic rise in legislative efforts that will make it harder for millions of citizens to cast a vote that counts. So far this year, at least fourteen states have passed new laws that make it harder to vote. And some jurisdictions, based on disinformation, have utilized abnormal post-election audit methodologies that may put the integrity of the voting process at risk and undermine public confidence in our democracy."<sup>7</sup> Watchdog groups like the AAF facilitate as their primary mission the dissemination of information and unique analysis on government activities that help promote public confidence in the democratic process.

Over a three-day period starting October 25, 2021, you initiated sixty-one (61) Freedom of Information Act requests to the Department of Justice, Civil Rights Division (CRT). Additionally, thirty-two (32) revisions were received through which you asked for alterations to some but not all of the sixty-one (61) original requests. In total, approximately eighty-two (82) distinct pieces of correspondence were received by the Division through which you hope to describe those agency records you seek.

Approximately 21 of these requests seek the complete email correspondence logs of 21 CRT employees for an approximate 10-month period. These 21 requests are not limited to any specific topic, subject matter or issue and in essence seek a complete accounting of all email traffic to and from these custodians. Exceedingly conservative estimates of 250 emails sent each week as well as 250 emails received, would translate into your request seeking approximately a half-million data lines to be reviewed for privileges and exemptions.

An additional 19 requests seek a full reproduction of all calendar entries for 19 custodians for an approximate 10-month period. These 19 requests are not limited to any specific topic, subject matter, issue or meeting attendee and in essence seek a complete accounting of the calendared day-to-day activity for these custodians for nearly a year. Exceedingly conservative estimates of a single calendar/schedule entry per hour, would translate into your request seeking an additional approximate thirty-thousand data lines to be reviewed for privileges and exemptions.

Finally, an additional 21 of these requests are for copies of emails, text messages, and written or email correspondence between at least 21 CRT employees with 26 individuals and 24 organizations. Additionally, these employees are in multiple sections of the Division in various positions including an administrative assistant, trial attorneys, managers, and political appointees. The requests for emails and correspondence between CRT employees with 50 individuals and organizations are set forth below:

A request under the FOIA must be one that reasonably describes [the requested] records." See 5 U.S.C. § 552(a)(3)(A). The unfocused and blanket nature of your request, untied to any discrete subject matter or issue, is far removed from the accepted functions and purposes of FOIA. Courts have explained that the rationale for this rule was not intended to reduce government agencies to full-time investigators on behalf of requesters, or to allow requesters to conduct "fishing expeditions" through agency files. Immanuel v. Sec'y of the Treasury, No. 94-884, 1995 WL 464141, at 1 (D. Md. Apr. 4, 1995), aff'd 81 F. 3d 150 (4th Cir. 1996). In addition to the "reasonably described" inquiry, courts have held that agencies are not required to conduct wide-ranging "unreasonably burdensome" searches for records. AFGE v. U.S. Dep't of Commerce, 907 F.2d 203, 209 (D.C. Circ. 1990)(holding that while plaintiff's requests might identify the documents requested with sufficient precision to enable the agency to identify them . . . it is clear that these requests are so broad as to impose an unreasonable burden upon the agency, because the agency would have to locate, review and redact a vast quantity of material.) Also see Am. Ctr. For Law & Just. v. DHS, No. 21-01364, 2021 WL 5231939 (D.D.C. Nov. 10 2021) (McFadden, J.) After carefully reviewing your requests, I have determined that you did not reasonably describe the subject of your requests. You have not identified a subject matter or case in which you are interested. Thus, in additional to the hundreds of thousands of data lines to be reviewed your request further impacts potentially hundreds of individual DJ case files which must be reviewed for responsive documents. This task entails review of potentially thousands of documents in case files to identify these particular individuals and organizations. There is not an electronic method to search correspondence in case files without a manual page by page review.

We note a majority of the 32 revisions to the 61 FOIA requests filed with the Civil Rights Division asked our office to *disregard* the first bullet of your request pertaining to: "a list of cookies, bookmarks, history and feeds from (individuals) internet browsers." You so aptly recognized these were not Agency records subject to the FOIA. Similarly, agency records are distinguishable from personal records such as personal emails and use of private email servers. Absent a distinct reason to believe that a custodian availed themselves of private email servers to conduct Agency business, in direct contravention of Agency policy, there is no obligation under FOIA to search those private email servers as they are not under Agency control or custody. Further and especially absent a subject matter informing this search, a review of government-issued cellphone text messages is impossible without phone numbers associated with the individual recipients you are interested in.

Additionally, you have requested expedited processing of your request pursuant to the Department's standard permitting expedition for requests involving "[a]n urgency to inform the public about an actual or alleged federal government activity, if made by a person primarily engaged in disseminating information." See 28 C.F.R. § 16.5(e)(1)(ii) (2018). Based on the information you have provided, I have determined that your request for expedited processing under this standard should be denied. This Office cannot identify a particular urgency to inform the public about an actual or alleged federal government activity beyond the public's right to know about government activities generally.

The Civil Rights Division is committed to ensuring an informed citizenry and safeguarding the statutory right of public access to Executive Branch information by making agency records available to the public to the fullest extent prescribed by law. However, this obligation does not extend to furnishing requesters complete registers of all agency records unbound by subject matter or topic nor allowing a "fishing expedition" of voluminous records to identify specific individuals or organizations. It would be helpful if you made a clearer request and identified the particular subject matter or case in which you are interested, the name of the subject or victim, specific dates of an incident, the location and nature of investigation, etc. Please note that the Division is not denying you access to particular records at this time, but requesting that you identify particular records with greater specificity. The Division will maintain your various requests in active status pending receipt of your supplemental clarification. However, at this juncture the Division is not prepared to search, collect and review entire catalogues of communication uncoupled from any distinct cognizable subject matter nor is the Division under any FOIA obligation to search records not under the Agency's custody or control.

If you are not satisfied with my response to this request, you may administratively appeal by writing to the Director, Office of Information Policy, United States Department of Justice, Sixth Floor, 441 G Street, NW, Washington, DC 20530-0001, or you may submit an appeal through OIP's FOIA STAR portal by creating an account following the instructions on OIP's website: https://www.justice.gov/oip/submit-and-track-request-or-appeal. For these reasons stated above, AAF satisfies the criteria for a fee waiver.

#### **EXPEDITED PROCESS**

The AAF requests expedited processing pursuant to 5 U.S.C. § 552 (a)(6)(E) based on a "compelling need" for these records. As defined by 5 U.S.C. § 552(a)(6)(E)(v)(II), there is an "urgen[t]" need for the information requested because AAF is primarily engaged in disseminating information with "urgency to inform the public concerning actual or alleged Federal Government activity."

(1) AAF is an organization primarily engaged in disseminating information to the public concerning actual or alleged government activity.

The AAF is an organization primarily engaged in disseminating information in order to bring transparency regarding actual or alleged government activity directly to the public. It is critical to the mission of the AAF and for transparency regarding government activities to obtain information,

scrutinize the information, and widely publish that information for the public consumption. The information obtained about government activity is directly published on our websites americanaccountabilityfoundation.com and bidennoms.com, and widely disseminated through social media platforms.

#### Additionally, the AAF publishes its findings and original analysis on its blogs

https://www.bidennoms.com/news and https://www.americanaccountabilityfoundation.com/blog. Examples of posts include an original report on donations to the Republican Governors Association, an investigation into no-bid contracts given to political cronies at DHS, and alleged insider trading allegation involving Biden Administration nominee.<sup>1</sup> The AAF also directly disseminates findings obtained through FOIA requests with the press through press releases and through interviews with print, digital, and tv news outlets.<sup>2</sup> This is an ongoing effort to provide timely, educational resources to the American public on the activities of government officials.<sup>3</sup>

(2) The records requested are urgently needed to disseminate information to the public on actual or alleged government activity.

These records are urgently needed to inform the public about actual or alleged government activity. Specifically, requested records relating to the past and ongoing activity of the Department of Justice on election related items including, but not limited to, activities to protect the integrity of elections, voting rights, early voting, vote by mail, access to voting, and the right of eligible voters to vote. As mentioned in August 2021, Attorney General Garland expressed the urgency to act "on relatively short notice" to ensure we have safe elections in the United States.<sup>4</sup> Additional measures taken by the Department of

Justice in June 2021 also reveal their actions to "protect civil rights" through ongoing review of postelection audits when they stated, "We are scrutinizing new laws that seek to curb voter access, and where we see violations, we will not hesitate to act" indicating that decisions are made in real time as the need arises.<sup>5</sup> Audits in several states, including Arizona and Wisconsin, maintain strict review periods that require the need for public access to information of activities undertaken by the Department of Justice while election audit and post-audit activities occur.<sup>6</sup>

28 C.F.R. § 16.5(e) expanded expedited processing to include requests for records involving the loss of substantial due process rights or matters of widespread and exceptional media interest in which there exist possible questions about the government's integrity that affect public confidence. Election administration and voting access necessarily implicates due process rights. See Griffin v. Burns, 570 F.2d 1065 (1st Cir. 1978); Roe v. Alabama, 68 F.3d 404 (11th Cir. 1995).

Trust in our Republic and its democratic election processes are of enormous public concern and require immediate dissemination of accurate information to the public on what the activities of their government leaders. As Attorney General Garland stated, "...there has been a dramatic rise in legislative efforts that will make it harder for millions of citizens to cast a vote that counts. So far this year, at least fourteen states have passed new laws that make it harder to vote. And some jurisdictions, based on disinformation, have utilized abnormal post-election audit methodologies that may put the integrity of the voting process at risk and undermine public confidence in our democracy."<sup>7</sup> Watchdog groups like the AAF facilitate as their primary mission the dissemination of information and unique analysis on government activities that help promote public confidence in the democratic process.

In an attempt to treat each requester fairly, we have adopted a policy of processing requests in the approximate order of receipt. - XX We have to consult with other offices in the Civil Rights Division to conduct a search and locate records which may be responsive to your request. Because of the need to examine a voluminous amount of records, we can respond only after consulting with the other offices. Thus, there may be some delay in the processing of your request as a result. Accordingly, your request falls within "unusual circumstances." See 5 U.S.C. 552 § (a)(6)(B)(i)-(iii). Because of these unusual circumstances, we are extending the time limit to respond to your request beyond the ten additional days provided by the statute. The time needed to process your request will necessarily depend on the volume and complexity of the records located. For your information, this Office assigns incoming requests to one of three tracks: simple, complex, or expedited. Each request is then handled on a first-in, first-out basis in relation to other requests in the same track.
