






Establishment of Slavery

Creating a Nation

- Priority of the Founders is to unite the states.
- 2/3 of the Founders held slaves
 even those that held slaves did not defend the institution.
 - In November 1789, Benjamin Franklin described slavery as, "an atrocious debasement of human nature."

"It being among my first wishes to see some plan adopted, by which slavery in this country may be abolished by law."


"The abolition of domestic slavery is the great object of desire in those colonies where it was unhappily introduced in their infant state."





Stepping Stones Put in Place to End Slavery

- Gradual abolition laws Pennsylvania,
 Massachusetts, Connecticut, New York and New Jersey.
- Articles of Confederation (1781 1789).
 - Northwest Ordinance (1787).
- U.S. Constitution (1789 Present).
 - OAtlantic Slave Trade outlawed in 1808.
 - "A tax or duty may be imposed on such importation, not exceeding ten dollars for each person." – U.S. Constitution, Article I, Section 9.

- President Abraham Lincoln, January 1861.
- "A word fitly spoken is like apples of gold in pictures of silver."
- The principles of the Declaration and the purpose of the Constitution.





Gettysburg Address – New Birth of Freedom

- "Four score (20) and seven years ago" = 87 years.
- The "proposition" that all men are equal – put out there for proof.
- Self-government is emphasized at the end as he stated, "and that government of the people, by the people, for the people, shall not perish from the earth."



"This is the Fourth of July. It is the birthday of your national independence and of **your** political freedom."




