I have personal knowledge of the facts listed in the statement of facts as I was involved in the underlying investigation and/or arrest.

I have knowledge of the facts listed in statement of facts based on my review of available Columbus Division of Police Reports, which were completed by Columbus Division of Police Officers acting in their official capacity and as a part of their official duties.

**Summary Statement of Facts in Support of Probable Cause:**

On June 22, 2022 a Columbus Police report was generated for Rape-Child Under 15 listing HVN age 10 as the victim. On July 6, 2022 HVN referenced Gerson Fuentes M/H 4/05/1995 as the suspect who raped her. On July 12, 2022 Detectives Jeffrey Huhn #745 and David Phillips served Gerson Fuentes with a search warrant for a Buccal Swab (saliva) DNA. After obtaining the buccal swab Detectives brought Gerson Fuentes to police headquarters for an interview where he confessed to raping HVN.
