Responsive records would include letters, memos, emails, email attachments, text messages, telephone call logs, calendar entries, meeting notices and agendas and any handwritten or electronic notes or summaries of oral communication.

The request period is from Jan. 1, 2018 to the present.

See 5 U.S.C. § 552(a)(8). I request a waiver of all fees for this request. Disclosure of the requested information to me is in the public interest because it is likely to contribute significantly to public understanding of the operations or activities of the government and is not primarily in my commercial interest.
