Dear Ms. Younes:

This acknowledges receipt of your April 14, 2022, Freedom of Information Act (FOIA) request, submitted to the Department of Health and Human Services (HHS), FOI/Privacy Acts Division concerning "... request copies of of certain records and documents of the Department of Health and Human Services (HHS) related to the Surgeon General's demand, made on March 3, 2022 ... (See Attach)". We received your request on April 15, 2022.

Because you seek records which require a search in another office, "unusual circum stances" apply to your request, automatically extending the time limit to respond to your request for ten additional days. See 5 U.S.C. 552 § (a)(6)(B)(i)-(iii) (2012 & Supp. V. 2017). Further, we estimate needing more than 10 additional days to respond to your request and so, in the next paragraph of this letter we are offering you an opportunity to narrow your request, in case narrowing the request would enable us to respond to the request sooner. The actual time needed to process your request will depend on the complexity of our records search and on the volume and complexity of any material located. For your information, this Office assigns incoming requests to one of three tracks: simple, complex, or expedited. Each request is then handled on a first-in, first-out basis in relation to other requests in the same track. Our current workload is approximately 3000 cases.

Your request is assigned to the complex track. In an effort to speed up our records search, you may wish to narrow the scope of your request to limit the number of potentially responsive records or agree to an alternative time frame for processing, should records be located. You may also wish to await the completion of our records search to discuss either of these options.

I regret the necessity of this delay, but I assure you that your request will be processed as soon as possible. To Whom It May Concern:

I am writing in response to a letter sent to me via email on April 15, 2022, from Ms. Arianne Perkins, Director of Initial FOIA Requests. That letter constituted an acknowledgment of my FOIA request, assigned the above number, and explained that the request had been received on April 15 and that it was deemed "complex," permitting additional time for compliance.

While the letter states that my request was made on April 14 and received on April 15, 2022, I had submitted the initial request much earlier, on March 11, 2022. I sent the request as an attachment to an email, at the address provided on the HHS website pertaining to FOIA requests (HHS_FOIA_Public_Liaison@hhs.gov) (as opposed to using the online portal). We will stipulate that the initial request should be designated as "misdirected" under the FOIA, which provides for an additional ten (10) days so that a request may be re-directed to the appropriate component of the agency. *See* 5 U.S.C. § 552(a)(6)(A)(ii). The initial date to comply under the misdirection provision would have been April 22, 2022.

We believe that the initial request is sufficiently narrow as to render the "complex" classification unwarranted. We provided specific search terms, identified particular individuals likely to be in possession of the records, offered the opportunity for rolling production, and have limited the records search to a period of less than a year. Thus, we do not intend to further narrow the request. However, even if we were to concede that the request is appropriately designated "complex," and consenting to the additional 10 days requested, the operative date for compliance is Friday, May 20, 2022. Thus, we expect to receive the records on or by that date.
