GIVE BRIEF DESCRIPTION OF WHAT HAPPENED:

On Tuesday December 29, 2020, your affiant Officer (J. Middleton #1766) was assigned to assist in the investigation for 22-1404 falsely impersonating public officer of minister, 50-2201.05b Fleeing from a law enforcement officer in a motor vehicle, and 22-4504. Carrying concealed weapons; possession of weapons during commission of crime of violence.

On November 14, 2020, at approximately 1145 hours, plain cloths Officer K. Veruchi (#2259) and Officer M. Amaturio (#1738) noticed an individual in the 1300 block of G St., NW, Washington DC., standing next to a blue Ford Taurus resembling an unmarked police cruiser with blue emergency lights activated. The vehicle was parked on the north side, in the center of the 1300 block of G St. In addition to the blue emergency lights, the vehicle had a barrier separating the front passenger compartment from the rear, resembling a police prisoner transport vehicle. There was also a laptop computer mount in the front dash, emergency light controller, and a spotlight on the driver's side "A" pillar, consistent with those in police cruisers. The vehicle was bearing DC tag (EA3699). The tag described appeared to be doctored or counterfeit due to the font in the lettering of the numbers appearing bolder than usual DC tags, and more elongated than usual DC tags.

The individual was a black male, approximately 25-30 years old, approximately 5'7-5'9, 145-155 pounds, short brown hair, and a black baseball cap. The individual was wearing a black t-shirt with "Federal Agent" in large font printed on the front and back of the t-shirt, in addition to smaller "Federal Agent" markings on the sleeves. The Individual had a full police duty belt on to include handcuffs, a pistol, two magazines, and a radio with earpiece attachment.

When the plain cloths officers doubled back on 13th street to further inspect the vehicle and police markings, they noticed that this individual's magazine pouch was located on his shooting hand side behind his firearm, which is unusual behavior for trained law enforcement. The individual's badge on his waist was unrecognizable, and the font on the license plates appeared more unusual at a closer distance.

The individual was being thanked by pedestrians for his service and acknowledging praise for being out there with the crowd. The individual appeared to take notice of the plain cloths officers watching him, and got into the vehicle and drove it west on G Street, to the corner of 14th St. Plain cloths officers continued to monitor the individual, and when they once again moved to the vicinity of this individual he took notice, returned to his car and drove it east on G St., towards 13th St. In doing so he moved to the south side of the street and positioned his vehicle at the corner with emergency lights activated.

While being monitored they noticed the individual maintaining a distance from the DC Metropolitan Police

Department Officers in the area. The plain cloths officers did not know of any other federal law enforcement agencies assisting with the demonstrations that day. The plain cloths officers notified the United States Secret Service Joint Operations Center and requested to have uniformed officers challenge the individual to verify credentials at approximately 1218 hours.

At approximately 1239 hours, Officers N. Neumann (#513), R. King (#2237), R. Chase (#2132), B. Barfield (#2075), and K. Aurelio (#986) arrived on scene and held with the individual. Officer K. Aurelio mistakenly ran a registration check on the wrong DC tag (ED3699) that returned surrendered in 2015 to a 2012 Honda; however he did observe the correct tag. Officer N. Neumann was talking to the individual that was in the driver seat of the blue Ford Taurus and requested the individual present his credentials. The individual pointed to the badge on his belt and stated that he is "FBI." When asked again for his credentials the individual stated that he "did not have them on him." At approximately 1240 hours, the individual started his car, engaged the emergency lights on his car, and drove off at a high rate of speed. The individual turned north onto 13th St., at a high rate of speed. He then turned east onto K St., and north onto 12th St. Officer Neumann lost sight of the vehicle at the intersection of 13th St. and Massachusetts Ave. NW. The correct DC Tag (EA 5699) was run by the Joint Operations Center after the individual fled and returned not on file via NCIC/WALES.

As an addition to the above information provided by the author of the SAR, it is important to note that the following officers approached the unknown subject and the vehicle in question: Officer N. Neumann (driver side contact and gave chase to the vehicle); Officer B. Barfield (driver side contact); Officer K. Aurelio (rear of the vehicle, ran the tag); Officer R. Chase (passenger side contact); Officer R. King (also covered the rear of the vehicle, provided overwatch, and maintained communications with the Joint Operations Command). The unknown subject identified himself as an FBI Agent to Officers Neumann and Barfield.

Officer Chase advised that the individual presented a police badge to the officers as they approached the vehicle and subsequently ignored all lawful orders to stop and remain in place. Officer Neumann advised that he gave chase to the vehicle on his electric bicycle, and was able to keep up with the vehicle for a few blocks while traveling at approximately 35 miles per hour (MPH). After a few blocks, the subject accelerated to an even higher rate of speed. Officer Neumann discontinued the pursuit for the officer safety reasons.

In addition to the previously mentioned information, the SAR contained a photo of an unknown subject (UNSUB), later identified as Sterling Devion Carter (DOB 05/05/1997), dressed in police attire to include a short sleeve "Federal Agent" t-shirt and duty belt that included a holster with firearm black in color and two additional spare magazines. The firearm and magazines were located on the right side of the UNSUB's waistband. The SAR also contained a photo of a blue in color Ford Taurus with DC tags (EA3699). This case was assigned to U.S. Secret Service Special Agent A. Pascual #12337 on 11/16/2020 and is being tracked under USSS case # 127-671-0011562-1. This case was a joint effort between the United States Secret Service (USSS), United States Capitol Police (USCP), Federal Bureau of Investigations (FBI), and the Metropolitan Police Department (MPDC).

USSS SA Pascual became aware that UNSUB could potentially be wearing a t-shirt manufactured by 13Fifty Apparel and located the t-shirt in question on their website. The federal agent t-shirt available for purchase on their website resembled the t-shirt worn by UNSUB of the USSS Uniformed Division SAR.

On 11/18/2020, USSS SA Pascual contacted 13Fifty Apparel telephonically and spoke with the owner of the company. SA Pascual emailed a photo of UNSUB to the owner of the company, who confirmed that the t-shirt was a 13Fifty Apparel t-shirt. The owner of the company advised that, based on the photo, he believed the shirt was either a small or medium size. Additionally, the owner of the company advised that the woven 13FA logo that is shown in the photo was added to the t-shirt's sleeve approximately 1.5 years ago. The owner of the company later provided USSS SA Pascual purchaser information for individuals who purchased a black short sleeve federal agent t-shirt from the 13Fifty Apparel website between 08/30/2017 and 11/09/2020. Of the 399 individuals listed, approximately 21 individuals listed a billing or shipping address in the Washington DC, Maryland, or Virginia area.

On 11/23/2020, SA Pascual contacted USSS CSD officer who authored the SAR to confirm the description of the unknown subject. The USSS CSD officer advised that UNSUB was approximately 5'7" with a skinny build around 150 pounds. The USSS CSD officer advised that he believed the license plate looked fake due to the font of the letters and numbers appearing unusually bolder than standard DC tags.

Based on photos, race, and other demographic information provided by the aforementioned open source searches the database queries, SA Pascual was able to narrow the group down to 3 individuals. One individual, Sterling Carter met the description of UNSUB in the SAR.

A USSS Investigative Analyst conducted a NCIC DL query on Sterling Carter, DOB 05/05/1997.

Driver's license information and a photo of Mr. Carter was provided, describing him as a black male, 5'05", and approximately 150 pounds.

On 11/30/2020, SA Pascual contacted DC DMV and was advised that the tag in question appears in their system as a legitimate tag that has yet to be issued to the general public. DC DMV provided a photo of the tag for comparison purposes. DC DMV employees reviewed a photo of the tag in question and stated that it appeared fake and confirmed it was not a law enforcement/ ghost tag.

USSS SA Pascual visited signsandtagsonline.com and provided their customer service with a photo of the tag in question. The customer service representative provided an order invoice for the tag in question in their shipping software. Saleem confirmed with the US Capitol badging office that Sterling Carter (DOB 05/05/1997) works as an entry level staffer for a US Congressperson. Furthermore USCP U. Saleem advised the Mr. Carter has an ID that gives him general access on the Capitol grounds and requires that he be screened before entering any buildings.

On 01/07/2021 Department of Forensic Sciences Firearms Examination Unit conducted an examination and functions test of the recovered Glock 19 (Serial Number BNKD613). The results indicated that the Glock 19 is functional and can be fired.

On 01/11/2021 Officer J. Middleton provided a photo of the black in color handgun in holster found in Mr. Carters residence to the CSD officers that witnessed Mr. Carter on 11/14/2020. Both CSD officers confirmed that the handgun and holster appeared to be the one on Mr. Carter.

Mr. Carter was given the option to resign or be terminated from his position at the Capitol for various performance issues, this impersonation incident, and his parents contacting his work to get in contact with him. The resignation phone call was made from his personal cell phone, and he has not returned his government work phone.

It is unknown if Mr. Carter has returned to his residence since the execution of the search warrant. Mr. Carter's parents have not been in contact with him since Christmas of 2020. This lead Mr. Carter's father to contact MPD and request the multiple welfare checks.

U.S. Secret Service Special Agent A. Pascaul #12337 was assigned to identify UNSUB-1. SA Pascaul was able to identify UNSUB-1 threw the following:

- Sterling CARTER purchased a size SMALL Federal Agent shirt from the company 13FiftyApparel. The owner of the company verified that the shirt in the photo belonged to his company and indicated that it is one of the newer versions with the label on the sleeve. Furthermore, the owner of the company indicated that the shirt was probably a SMALL or a MEDIUM.
- According to Jared Rowe, of Signsandtagsonline.com, a query of their shipping software revealed that a Mr. Sterling CARTER purchased replica DC tag (EA3699) and had it shipped to 1914 3rd St NW #2 Washington, DC (the same address listed in TLO for the Sterling CARTER who purchased the SMALL "Federal Agent" shirt from 13FiftyApparel.com.)
- CARTER matches the description of the UNSUB-1. The UNSUB-1 is described in the USSS UD generated SAR as a black male, 5'07 to 5'09, approximately 145 to 150 pounds. According to DL info and photo, CARTER is described as a black male, 5'05, 150 pounds.
- SA A. Pascaul sent the DMV photo of CARTER to UC-2 (M. Amaturro), that authored the SAR. UC-2 advised that it is difficult to say whether or not CARTER is the UNSUB-1 due to the fact that the UNSUB wore a baseball cap and mask during the incident. However, UC-2 advised that Carter's eyes and ears are similar to the eyes and ears of the UNSUB-1.

Both witnesses advised CARTER told them the Ford Taurus was his "work vehicle" and asked if he could park in the driveway. W-1 has seen CARTER upon said vehicle on two or three occasions.
- When shown a photo of the "unknown subject" from the SSF, W-1 verbally confirmed that he believes UNSUB-1 to be his neighbor, Mr. Sterling Carter. W-1 provided a written statement on the SSF 119 witness statement form.
- Secret Service personnel observed the blue Ford Taurus matching the description of the vehicle that fled in the rear driveway of the residence with no tags on the vehicle.

Due to the facts and circumstances outlined above this affiant submits there is probable cause for the Impersonating a Law Enforcement Officer and respectfully requests that a warrant be issued for Sterling Carter.
