After careful review of the entire record, the Court now rules as follows:

The Court finds that the Petitioner has met the burden of proof that is required. The Petitioner has proven the case by a Preponderance of the Evidence under CCP Sec. 527.6 et seq. **Therefore**, **the request for injunction is GRANTED**.

The Court's decision is based on the law that governs CCP 527.6 et seq. Petitioner is told that if an extension beyond the expiration date is requested the Petitioner must make that request at least three months prior to the expiration of the restraining order.

Restraining order as requested against Jeff Smith is granted with a 150 yards stay away order to expire 7/06/2025.


