AFFIDAVIT FOR ARREST WARRANT OR CAPIAS

BEFORE ME, the undersigned authority, on this day personally appeared the undersigned affiant who, after being duly sworn by me, on oath stated;

My name is S. Snad Deranjic, and I am a peace officer of the City of Lancaster, Dallas County, Texas.

I have good reason to believe and do believe that on or about 08/13/22 one

TALIB, YAQUB SALIK B/M 04/08/83

did then and there in the City of Lancaster, Dallas County, Texas, commit the offense of MURDER, a violation of Section 19.02(c), of the PENAL CODE, a FELONY 1ST.

My belief is based upon the following facts and information:

S. DERANJIC #4180, Investigator, Lancaster Police Department, who participated in the investigation of the alleged offense, furnished to me, the Affiant, on 08/13/22, the following information: On 08/13/22 at 2009 hours, Officers were dispatched to 1749 Jefferson St (Lancaster Community Park) in regards to a shooting in progress. Prior to arrival, Officers were informed a person had been shot multiple times and was laying on the football field and that the suspects were fleeing the area. Upon arrival, officers found a victim suffering from multiple gunshot wounds and no suspects in the area. The victim was transported to the Methodist Central for emergency medical care however succumbed to his injuries and was declared deceased at 2047 hours. The victim sustained gunshot wounds to his chest, back and forearm. During the shooting investigation, multiple eyewitnesses were interviewed and all stated witnessing a male who was identified as Talib, Yaqub (BM 04/08/83) shoot the victim multiple times with a black semi-automatic handgun during an argument over the score at the youth football game. The witnesses knew Talib personally due to him being involved in the youth football league and was widely known by most of the coaching staff on both teams. Due to Talib shooting the victim and causing his death, Talib is being charged with Murder under E2239712.

I believe this information furnished by a fellow peace officer is credible.

WHEREFORE, Affiant requests that an arrest warrant or capias be issued for the above accused individuals(s) in accordance with the law.
