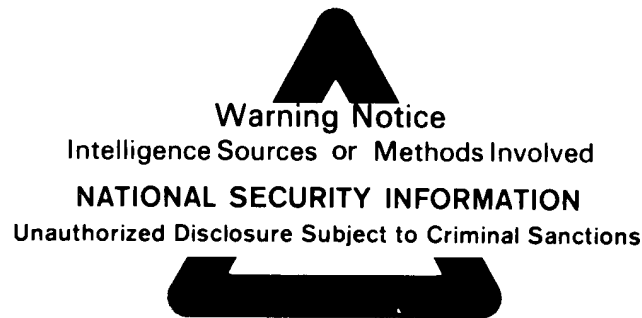

1. SIGNIFICANCE: A NEW IRANIAN COMMAND POST IS IDENTIFIED IN THE AL BASRAH AREA. (SWN)

2. REMARKS: A NEW REVETTED IRANIAN COMMAND POST (CP), INCLUDING ONE LARGE GUYED ANTENNA, AT LEAST TWO SMALLER ANTENNAS, ONE LARGE PARTIALLY UNDERGROUND COMMAND BUNKER, NUMEROUS SUPPORT BUILDINGS/STRUCTURES, AND LOGISTICAL MATERIALS, IS NEAR 31-20N 047-57E. THIS CP WAS PRESENT [Redacted] (SWN)

THE HAWK SITE AT 31-C9N 047-53E REMAINS UNOCCUPIED. THE 25 BUSES, IN THE VICINITY OF THE LOGISTICS AREA [Redacted] NEAR THE NEWLY OCCUPIED IRANIAN HAWK SITE AT 31-17N 047-56E (WHICH IS NOT IMAGED TODAY), ARE NO LONGER PRESENT. MUCH OF THE LOWLANDS IMMEDIATELY SOUTHEAST OF THIS AREA HAVE REMAINED INUNDATED [Redacted] (SWN)
