I. FACTUAL BACKGROUND

On March 22, 2022, our law firm's client, Dr. Martin Julius Murray, submitted a FOIA request to the Federal Bureau of Investigation (FBI) that sought, among other things, records relating to the Students for a Democratic Society (SDS) from September 1, 1967 to December 31, 1974. The request is attached as Exhibit 1.

On May 5, 2022, the FBI issued a final responded to Dr. Murray's request stating that responsive records were located on the FBI's website "The Vault." The FBI's response is attached as Exhibit 2. After using the search terms "Students for a Democratic Society" and "SDS", no responsive records were returned. Attached as Exhibit 3 are the results of the searches which returned no responsive records as of June 28, 2022. The FBI's final response stated "[f]or records responsive to this request, please enter Students for a Democratic Society, [or] SDS" into the search function. Exhibit 2.

Dr. Martin Julius Murray formally appeals on two grounds. First, on the grounds that the FBI failed to conduct an adequate search, and second on the grounds that the FBI failed to produce all responsive records.

II. THE FREEDOM OF INFORMATION ACT

The purpose of FOIA is to "open agency action to the light of public scrutiny." *Dep't of the Air Force v. Rose*, 425 U.S. 352, 372 (1976). Former President Obama reinforced FOIA's strong presumption of disclosure with regard to all FOIA decisions. *See* Presidential Memorandum for Heads of Executive Departments and Agencies Concerning the Freedom of Information Act, 74 Fed. Reg. 4683 (Jan. 21, 2009) (directing agencies to administer FOIA under a presumption that, "[i]n the face of doubt, openness prevails"). Former Attorney General Eric Holder issued FOIA guidelines that reinforce a commitment to open government, encouraging federal agencies to both "make discretionary releases of information" and to "make partial disclosures" when an agency determines full disclosure is not possible. *See* Former Attorney General Eric Holder's Memorandum for Heads of Executive Departments and Agencies (Mar. 19, 2009).

In his memo, the Former Attorney General also announced a "foreseeable harm" standard for defending agency decisions to withhold information under FOIA. *See id.* Thus, the DOJ will defend an agency's denial of a FOIA request "only if (1) the agency reasonably foresees that disclosure would harm an interest protected by one of the statutory exemptions, or (2) disclosure is prohibited by law." *Id.* These authorities have not been changed by the current Administration and remain in effect.

FOIA "mandates a policy of broad disclosure of government documents" and carries a strict disclosure mandate that requires federal agencies to expeditiously disclose requested records to requesters. *See* 5 U.S.C. § 552, *Church of Scientology v. Dep't of the Army*, 611 F.2d 738, 741 (9th Cir. 1980). Consequently, any inquiry under FOIA brings with it a "strong presumption in favor of disclosure." *U.S. Dep't of State v. Ray*, 502 U.S. 164, 173 (1991). To that end, nothing in FOIA should be read to "authorize withholding of information or limit the availability of records to the public, except as specifically stated." *See* 5 U.S.C. § 552(c). Congress recognized that in certain limited instances, records may be exempt from FOIA's broad disclosure mandate, and thus created nine categories of exemptions. § 552(b). These exemptions, however, "must be narrowly construed in light of FOIA's dominant objective of disclosure, not secrecy." *Maricopa Audubon Soc'y. v. U.S. Forest Serv.*, 108 F.3d 1082, 1085 (9th Cir. 1996).

Accordingly, because FOIA carries a presumption in favor of disclosure, and indeed, because, "FOIA requesters face an information asymmetry given that the agency possesses the requested information and decides whether it should be withheld or disclosed," *COMPTEL v. U.S. Federal Comm 'n.*, 910 F. Supp. 2d 100, 111 (D.D.C. 2012) (internal citations omitted), agencies bear the

burden of justifying the withholding of any records that are responsive to a FOIA request. 5 U.S.C. §552 (a)(4). An agency must provide "a relatively detailed justification, specifically identifying the reasons why a particular exemption is relevant and correlating those claims with the particular part of a withheld document to which they apply." *See King v. Dept. of Justice*, 830 F.2d 210, 219 (D.C. Cir. 1987) (agency must provide); *see also Coastal States Gas Corp. v. Dep't of Energy*, 617 F.2d 854, 861 (D.C. Cir. 1980) (holding an agency's disclosure of "who wrote the [document], to whom it was addressed, its date, and a brief description" was "patently inadequate" to establish exemption under FOIA).

Under the FOIA Improvement Act of 2016, agencies are prohibited from denying requests for information under FOIA unless the agency reasonably believes release of the information will harm an interest that is protected by the exemption. *See* FOIA Improvement Act of 2016 (Public Law No. 114-185), codified at 5 U.S.C. § 552(a)(8)(A).

III. FOIA REQUIRES THAT AN AGENCY PROVIDE RECORDS RESPONSIVE TO THE REQUEST

After a valid request has been made to the agency, that agency must "make reasonable efforts to search for records." 5 U.S.C. § 552 (a)(3)(A).

FOIA requires that a records responsive to the request be provided to the requester. *Id.* Here, the FBI stated in its final response letter that the search terms "Students for a Democratic Society" and "SDS" would return responsive records on "The Vault." The terms did not return any results. The response is as if they had mailed a final response that stated "we have included records responsive to this request with this final response letter," but failed to provide any records in the letter. This is clearly in contravention of FOIA as the FBI has admitted they have located responsive records but failed to produce them under the search terms they have laid out.

VI. CONCLUSION

As described above, the FBI has failed to conduct a reasonable search in response to a FOIA request that specifically describes the documents sought.

Accordingly, the FBI must conduct an adequate search for responsive records and produce all responsive records by a date certain. In so doing, the FBI must also provide an estimated date of completion of its release of the records. 5 U.S.C. § 552 (a)(7)(B).

A. REQUEST

7. All records mentioning Martin Murray and Temporary Restraining Order issued 21 May 1971, Plaintiff: The State of Texas for and Ex Rel the Board of Regions of the University of Texas System, Defendant Martin Wiginton et al [Martin Murray];

8. All records showing, depicting or providing information on the many SDS protests which took place on the South Mall of the University of Texas, including the Freedom Movement Rally held in that location in 1967; rally to protest Cambodian invasion May 1970 and subsequent march to Capitol Building, downtown Austin;

9. All records showing, depicting or providing information on any SDS protests at the University of Texas Austin; including "sit-in" to protest Marine Recruiters, October 1967, anti-ROTC demonstrations, and the Chuck Wagon Riot fall 1969;

10. All records showing, depicting or providing information on persons from Texas who attended anti-Vietnam War protests or demonstrations in the Washington, DC area including the Pentagon;

11. All records, including photographs, audio tape recordings, video tape recordings, transcripts of audio or video, and DVDs, made by the FBI or police or informants about SDS activities in the Austin, Texas area; including undercover police informants Nicolaus Dykema, Barbara Roseman, Jo Landrum, and Myron Bloom;

12. All records mentioning Martin Murray and George Carlson (Head of Security, University of Texas System, Lt. Burt Gerding (Austin Police Department), Allan Hamilton, Security Division, University of Texas at Austin;

13. All records mentioning Martin Murray and the SDS National Convention, June 1969;

14. All records showing, depicting, or providing information on the Gerard Winstanley Memorial Caucus (Department of Sociology, UT Austin), New Left Education Project.

B. TIME FRAME OF THIS REQUEST

The time frame for this request includes records created or received on or after September 1, 1967 to December 31, 1974.

C. INFORMATION HELPFUL TO THE FBI IN FULFILLING THIS REQUEST

My client, Martin Julius Murray was a student at the University of Texas in Austin, Texas. He was active in the University of Texas Chapter of Students for a Democratic Society (SDS). He organized and participated in numerous meetings and protests. His brother, Mark Francis Murray, and his friend, Martin Alexander Wiginton (now deceased) also participated in meetings and protests. All three of them traveled to Washington, DC for protests Justice Department and National Capitol in May 1971.

My client has signed DOJ Form 361 and has signed a Declaration of Martin Julius Murray. These documents are attached to this request.

My client's brother, Mark Francis Murray, has signed DOJ Form 361 and has signed a Declaration of Mark Francis Murray. These documents are attached to this request.

Martin Alexander Wiginton, born February 4, 1933 and died March 10, 1992, is a deceased well known public figure, active in the anti-war movement, nightclubs and the business community of Austin, Texas. Articles about him and his public work are in a number of Austin and Texas publications.

Finally, Mark Francis Murray made a request to the FBI for records. The records received by him are attached to assist the FBI in responding to the present request.

D. HOW RESPONSIVE RECORDS SHOULD BE PROVIDED

My client requests copies of the responsive records for this FOIA request be provided in a digital format, either via email, or stored on a thumb drive, CD or other electronic data storage device. See 5 U.S.C. (a)(3) B). Providing these records in an electronic format will save agency staff processing time, as well as reducing the cost of making paper copies of all responsive records.

E. RECORDS FOR PUBLIC AWARENESS CAMPAIGN; PROCESSING FEES

My client is a professor at the University of Michigan. He has earned his Ph.D. in Sociology, at University of Texas Austin, in 1975. Writing and research are integral to his work. He has published papers on his experience in the anti-war movement in Austin ("Building Fires on the Prairie," in Radical Sociologists and the Movement) and scholarly books on global urbanism and Johannesburg (South Africa). His academic resume is attached.

My client is writing a book about his experiences as an activist in SDS, New Left Education Project, Gerard Winstanley Memorial Caucus, the Armadillo Mayday Tribe, and other organizations, and the deplorable conduct of the FBI and other agencies in suppressing the Assembly Rights Americans should enjoy under the First Amendment to our Constitution.

My client has the ability to get the information he receives analyzed and summarized so that current policy makers and media do not make the mistakes of the past. His story weaves the personal relationships he developed during the period with the documented abuses of the FBI and law enforcement. He has contacted a number of potential publishers of this work (Temple University Press, University of Texas Press, Dolph Briscoe Center for American History (University of Texas) Press. He has plans to publish his recollections of this period of political repression in popular and scholarly articles in various outlets.

My client is entitled to and requests a waiver of all copying, duplication and processing fees. His work is in the public interest and, because he is writing a book, he has media status for this request.

My client's efforts, once he receives the records, will lead to increased public awareness of the waste of taxpayer money that was involved in the improper and unethical and illegal attacks on the freedoms of Vietnam War protesters. He is particularly interested in writing about efforts of undercover police informants to lure unsuspecting activists into illegal acts via methods of entrapment.

As an academic, my client is eligible for a fee waiver for this request.

He has the ability to properly process, summarize and analyze the records he hopes to receive here. My client plans to have a website where he will release all records to the public once he receives them. This will further foster public understanding of what happened to Vietnam War protesters.

My client is pre-authorizing payments up to \$30 for the processing of this request but only if the FBI complies with all statutory deadlines in FOIA. Congress amended FOIA in 2007. An effect of the 2007 Amendments was to impose consequences on agencies that fail to comport with FOIA's requirements. See S.Rep. No. 110-59. To underscore Congress's belief in the importance of the statutory time limit, the 2007 Amendments declare that "[a]n agency shall not assess search fees ... if the agency fails to comply with any time limit" of FOIA. § 552(a)(4)(A)(viii) (emphasis added). Bensman v National Park Service, 806 F.Supp.2d 31 (DCD 2011).

F. POLICY AND LEGAL DIRECTION FOR OPEN GOVERNMENT

Disclosure of the above referenced agency records are also sought in order to promote government transparency, and to reflect the Administration's policy to support our nation's fundamental commitment to open government. As the Supreme Court has observed, "virtually every document generated by an agency is available in one form or another, unless it falls within one of the Act's nine exemptions." NLRB v. Sears, Roebuck & amp; Co., 421 U.S. 132, 136 (1975). FOIA was designed to "pierce the veil of administrative secrecy and to open agency

action to the light of public scrutiny," see, e.g., Dept. of the Air Force v. Rose, 425 U.S. 352, 361 (1976), and in order "to ensure an informed citizenry, vital to the functioning of a democratic society, needed to check against corruption and to hold the governors accountable to the governed." NLRB v. Robbins Tire & amp; Rubber Co., 437 U.S. 214, 242 (1978); see also Judicial Watch, Inc. v. Rossotti, 326 F.3d 1309, 1310 (D.C. Cir. 2003); United States Dept. of Justice v. Reporters Comm. for Freedom of the Press, 489 U.S. 749, 773 (1989).

The above-described agency records are subject to disclosure under FOIA, and are not otherwise exempt from disclosure pursuant to FOIA's nine statutory exemptions. See 5 U.S.C. § 552(b)(1) - (9). To the extent that a determination is made by your FOIA office staff that any limited portions of the records listed above will be withheld from disclosure for this request, FOIA expressly requires all agencies to disclose "[a]ny reasonably segregable portion of a recordafter deletion of the portions of the record which are exempt." 5 U.S.C. §552(b). See, e.g., Oglesby v. U.S. Dept. of Army, 79 F.3d 1172, 1178 (D.C. Cir. 1996); see also Abdelfattah v. U.S. Dept. Of Homeland Security, 488 F.3d 178, 186-187 (3rd Cir).







ARMADILLO MAY DAY TRIEE (AMDT)

<u>SA T-2 (4/21/71)</u>

The AMDT is an organization comprised of representatives from various antiwar groups at Austin, Texas, and individuals from the University of Texas, Austin, Texas Student Community. It was organized primarily to coordinate and direct activities at Washington, D. C., during May, 1971, sponsored by the People's Coalition for Peace and Justice (PCPJ).

The AMDT was one of the more militant and violence-prone organizations participating in the FCPJ demonstrations at Washington, D. C., in May, 1971. Its members actively participated in civil disobedience at that time.

PEOPLE'S COALITION FOR PEACE AND JUSTICE (PCPJ)

The PCPJ has described itself as being headquartered at 1029 Vermont Avenue, N.W., Washington, D. C., and as consisting of over 100 organizations which are using massive civil disobedience to combat racism, poverty, repression and war.

On May 17, 1971, a meeting of the AMDT was held at 2831 Pearl Street, Austin, with approximately 25 people, including the subject, in attendance. They discussed plans for the demonstration to be held on May 22, 1971, protesting the dedication of the LBJ Library. (U)

SA T-5 (5/19/71)

On May 19, 1971, a meeting of the AMDT was held in Eastwood Park, Austin, with approximately 150 people in attendance. MARK MURRAY was one of those present. The purpose of the meeting was to finalize plans for the demonstration at the LBJ Library dedication. (U)



MARK MURRAT is a twin brother of MARTIN MURRAY. During a meeting held on the UT campus MARK MURRAY stated that he had arrived from Omaha, and that he was a twin brother of MARTIN, a former active participant in the Students for a Democratic Society at UT. MARK MURRAY stated that he considered himself a student riot-type leader. However, he did not want to become involved in any confrontation inasmuch as fi could lead to his arrest for treasing state lines to participate in a riot. MARK MURRAY invinced that he was possibly wanted in Omaha or the State of Nebraska on other charges.







- (ii) Intelligence Records. To the extent your request seeks records of intelligence sources, methods, or activities, the FBI can neither confirm nor deny the existence of records pursuant to FOIA exemptions (b)(1), (b)(3), and as applicable to requests for records about individuals, PA exemption (j)(2) [5 U.S.C. §§ 552/552a (b)(1), (b)(3), and (j)(2)]. The mere acknowledgment of the existence or nonexistence of such records is itself a classified fact protected by FOIA exemption (b)(1) and/or would reveal intelligence sources, methods, or activities protected by exemption (b)(3) [50 USC § 3024(i)(1)]. This is a standard response and should not be read to indicate that any such records do or do not exist.

Part 2: The standard responses below apply to all requests for records on individuals:

- (i) Requests for Records about any Individual—Watch Lists. The FBI can neither confirm nor deny the existence of any individual's name on a watch list pursuant to FOIA exemption (b)(7)(E) and PA exemption (j)(2) [5 U.S.C. §§ 552/552a (b)(7)(E), (j)(2)]. This is a standard response and should not be read to indicate that watch list records do or do not exist.
- (ii) Requests for Records about any Individual—Witness Security Program Records. The FBI can neither confirm nor deny the existence of records which could identify any participant in the Witness Security Program pursuant to FOIA exemption (b)(3) and PA exemption (j)(2) [5 U.S.C. §§ 552/552a (b)(3), 18 U.S.C. 3521, and (j)(2)]. This is a standard response and should not be read to indicate that such records do or do not exist.
- (iii) Requests for Records for Incarcerated Individuals. The FBI can neither confirm nor deny the existence of records which could reasonably be expected to endanger the life or physical safety of any incarcerated individual pursuant to FOIA exemptions (b)(7)(E), (b)(7)(F), and PA exemption (j)(2) [5 U.S.C. §§ 552/552a (b)(7)(E), (b)(7)(F), and (j)(2)]. This is a standard response and should not be read to indicate that such records do or do not exist.

Part 3: General Information:

- (i) Record Searches and Standard Search Policy. The Record/Information Dissemination Section (RIDS) searches for reasonably described records by searching systems, such as the Central Records System (CRS), or locations where responsive records would reasonably be found. The CRS is an extensive system of records consisting of applicant, investigative, intelligence, personnel, administrative, and general files compiled by the FBI per its law enforcement, intelligence, and administrative functions. The CRS spans the entire FBI organization, comprising records of FBI Headquarters, FBI Field Offices, and FBI Legal Attaché Offices (Legats) worldwide; Electronic Surveillance (ELSUR) records are included in the CRS. The standard search policy is a search for main entity records in the CRS. Unless specifically requested, a standard search does not include a search for reference entity records, administrative records of previous FOIPA requests, or civil litigation files.
 - a. Main Entity Records created for individuals or non-individuals who are the subjects or the focus of an investigation
 - b. Reference Entity Records- created for individuals or non-individuals who are associated with a case but are not known subjects or the focus of an investigation
- (ii) FBI Records. Founded in 1908, the FBI carries out a dual law enforcement and national security mission. As part of this dual mission, the FBI creates and maintains records on various subjects; however, the FBI does not maintain records on every person, subject, or entity.
- (iii) Requests for Criminal History Records or Rap Sheets. The Criminal Justice Information Services (CJIS) Division provides Identity History Summary Checks often referred to as a criminal history record or rap sheet. These criminal history records are not the same as material in an investigative "FBI file." An Identity History Summary Check is a listing of information taken from fingerprint cards and documents submitted to the FBI in connection with arrests, federal employment, naturalization, or military service. For a fee, individuals can request a copy of their Identity History Summary Check. Forms and directions can be accessed at www.fbi.gov/about-us/cjis/identity-history-summary-checks. EXPLANATION OF EXEMPTIONS

SUBSECTIONS OF TITLE 5, UNITED STATES CODE, SECTION 552

- (b)(1) (A) specifically authorized under criteria established by an Executive order to be kept secret in the interest of national defense or foreign policy and (B) are in fact properly classified to such Executive order;
- (b)(2) related solely to the internal personnel rules and practices of an agency;
- (b)(3) specifically exempted from disclosure by statute (other than section 552b of this title), provided that such statute (A) requires that the matters be withheld from the public in such a manner as to leave no discretion on issue, or (B) establishes particular criteria for withholding or refers to particular types of matters to be withheld;
- (b)(4) trade secrets and commercial or financial information obtained from a person and privileged or confidential;
- (b)(5) inter-agency or intra-agency memorandums or letters which would not be available by law to a party other than an agency in litigation with the agency;
- (b)(6) personnel and medical files and similar files the disclosure of which would constitute a clearly unwarranted invasion of personal privacy;
- (b)(7) records or information compiled for law enforcement purposes, but only to the extent that the production of such law enforcement records or information (A) could reasonably be expected to interfere with enforcement proceedings, (B) would deprive a person of a right to a fair trial or an impartial adjudication, (C) could reasonably be expected to constitute an unwarranted invasion of personal privacy, (D) could reasonably be expected to disclose the identity of confidential source, including a State, local, or foreign agency or authority or any private institution which furnished information on a confidential basis, and, in the case of record or information compiled by a criminal law enforcement authority in the course of a criminal investigation, or by an agency conducting a lawful national security intelligence investigation, information furnished by a confidential source, (E) would disclose techniques and procedures for law enforcement investigations or prosecutions, or would disclose guidelines for law enforcement investigations or prosecutions if such disclosure could reasonably be expected to risk circumvention of the law, or (F) could reasonably be expected to endanger the life or physical safety of any individual;
- (b)(8) contained in or related to examination, operating, or condition reports prepared by, on behalf of, or for the use of an agency responsible for the regulation or supervision of financial institutions; or
- (b)(9) geological and geophysical information and data, including maps, concerning wells.

SUBSECTIONS OF TITLE 5, UNITED STATES CODE, SECTION 552a

- (d)(5) information compiled in reasonable anticipation of a civil action proceeding;
- (j)(2) material reporting investigative efforts pertaining to the enforcement of criminal law including efforts to prevent, control, or reduce crime or apprehend criminals;
- (k)(1) information which is currently and properly classified pursuant to an Executive order in the interest of the national defense or foreign policy, for example, information involving intelligence sources or methods;
- (k)(2) investigatory material compiled for law enforcement purposes, other than criminal, which did not result in loss of a right, benefit or privilege under Federal programs, or which would identify a source who furnished information pursuant to a promise that his/her identity would be held in confidence;
- (k)(3) material maintained in connection with providing protective services to the President of the United States or any other individual pursuant to the authority of Title 18, United States Code, Section 3056;
- (k)(4) required by statute to be maintained and used solely as statistical records;
- (k)(5) investigatory material compiled solely for the purpose of determining suitability, eligibility, or qualifications for Federal civilian employment or for access to classified information, the disclosure of which would reveal the identity of the person who furnished information pursuant to a promise that his/her identity would be held in confidence;
- (k)(6) testing or examination material used to determine individual qualifications for appointment or promotion in Federal Government service the release of which would compromise the testing or examination process;
- (k)(7) material used to determine potential for promotion in the armed services, the disclosure of which would reveal the identity of the person who furnished the material pursuant to a promise that his/her identity would be held in confidence.
