Dear Mr. Perrusquia:

This responds to your request under the Freedom of Information Act ("FOIA"), 5 U.S.C. § 552, dated January, 30, 2022. You requested salary and total compensation for each of TVA's four regional vice presidents. Your request was processed under tracking number #22-FOI-00081.

We are unable to provide the salary and compensation information you request because it is protected from disclosure by FOIA exemptions. FOIA exemption 5 allows the government to withhold, among other things, confidential business information if the release of such information would harm the government's commercial or financial interests or prevent an agency from performing its mission. Public disclosure of the detailed and personally identifiable compensation information you request would cause TVA harm by allowing competitors insight into confidential pay and business plans and practices.

While most compensation for federal employees is set in accordance with the General Schedule, TVA has its own compensation plan. The 2005 amendment to the TVA Act required the TVA Board to set a competitive compensation plan for employees "based on an annual survey of the prevailing compensation for similar positions in private industry, including engineering and electric utility companies, publicly owned electric utilities, and Federal, State, and local governments." Unlike the General Schedule, which is publicly available, TVA's compensation information is proprietary and is kept confidential.

FOIA exemption 6 is also applicable to the requested information. Exemption 6 protects information that would constitute an unwarranted invasion of personal privacy. When TVA receives FOIA requests that impact an individual's privacy interest, TVA must determine if the public interest in the information clearly warrants the invasion of privacy that would result from a disclosure. Other than a statement that "this information is vital to the public", your request provided no information on how the public interest would be served by release of the information you requested; therefore, there is no basis for intruding on TVA employees' privacy by disclosing personally identifiable compensation information.

While we cannot provide the specific compensation information you requested, you can access detailed information about certain TVA officers in TVA's Annual Report on Form 10-K ("10-K"), which is filed with the Securities and Exchange Commission. The 10-K also includes a discussion of TVA's compensation philosophy. The 10-K is available at
