This is in response to your Freedom of Information Act (FOIA) request, dated 4 March 2013, that was originally submitted to the Federal Bureau of Investigation (FBI) FBI FOI/PA #1211348-000. During the processing of your request, AFOSI documents were identified and forwarded to our office for processing and direct response to you. We received your request on 15 May 2014 and assigned tracking number AF 2014-04667-F.

Information from AFOSI criminal investigative records are exempt from release under the Privacy Act, Title 5 United States Code (USC) Section 552(a)(J)(2). In order to provide you the maximum amount of releasable information, we are processing your request under the FOIA. Since portions of the information requested are also exempt from disclosure under the FOIA, we have inserted the exemptions below in the attached documents.

- a. Exemption b1 protects from disclosure information about "matters specifically authorized under criteria established by an Executive order to be kept secret in the interest of national defense or foreign policy" and which has in fact been "properly classified pursuant to such Executive order."
- b. Exemption b6 permits the withholding of all information about individuals in "personnel and medical files and similar files" when the disclosure of such information "would constitute a clearly unwarranted invasion of personal privacy."
- c. Exemption b7c provides protection for personal information in law enforcement records the disclosure of which "could reasonably be expected to constitute an unwarranted invasion of personal privacy."

The authority for the exemptions used can be found in 5 USC § 552 and in Air Force Manual 33-302, which can be accessed via the Air Force FOIA page at http://www.foia.af.mil/.



This is in response to your Freedom of Information Act (FOIA) request, dated 30 June 2014, on behalf of your client, Kenneth Russell Davis, Jr. You requested a copy of an investigation into Mr. Davis' alleged involvement in espionage. We received your request on 11 July 2014 and assigned tracking number AF 2014-05157-F.

After conducting a search, our records indicated that Mr. Davis originally submitted a duplicate request to the Federal Bureau of Investigations (FBI), tracking number FBI FOI/PA #1211348-000, on 4 March 2013. During the processing of his request, relevant AFOSI documents were identified and forwarded to our office for processing. We received the FBI request on 2 June 2014.

On 20 November 2014, we completed the AFOSI portion of the response to Mr. Davis' request to the FBI, and we sent copies of the relevant AFOSI documents (properly redacted) directly to Mr. Davis. The FBI request was a duplicate of your request on behalf of your client, and we do not process the same request more than once. Therefore, we are administratively closing your request.
