Dear Ms. Walters:

On behalf of Wiley Rein LLP, we hereby request, under the Freedom of Information Act ("FOIA"), the disclosure of the following two cables sent by the U.S. embassy in Ankara, Turkey to the U.S. Department of State: • Cable 02ANKARA8594, Uncertainty for Pending and Existing BOT/TOR Projects In Turkey (Nov. 25, 2002); and • Cable 06ANKARA2877, Hopes and Fears in Turkey's Electricity Sector (May 22, 2006).

· Cable boalthadazorr, hopes and rears in furkeys Electricity Sector (May 22, 2006).

These documents are currently in the public domain on the Internet, but do not appear to be available from any official U.S. Government source.

The information in these cables demonstrates that the Turkish government is providing a subsidy in the form of electricity for more than adequate remuneration to its domestic power industry. The U.S. steel industry requires this information for purposes of the U.S. Department of Commerce's ("Commerce") currently ongoing countervailing duty ("CVD") investigation of imports of steel concrete reinforcing bar from Turkey.

We emphasize that the above-described documents do not contain U.S. government-classified information, Cable 02ANKARA8594 clearly states that it was declassified as of November 20, 2012.1 Such a declassification date is consistent with the U.S. Government's general policy of declassifying information after a ten-year period (with the exception of only the most sensitive documents).2 Cable 06ANKARA2877 clearly identifies the document's classification status as "unclassified."3

Because a compelling need for this information exists, we request expedited treatment of this disclosure request.4 The information contained in the cables described above is critical to the domestic industry's case in the CVD investigation on steel concrete reinforcing bar from Turkey. Commerce's CVD Investigation is already underway, and the U.S. steel industry needs this information as soon as possible, in order to ensure that it will be considered in the investigation. In particular, Commerce has declined to initiate the domestic industry's allegation of a subsidy provided by the Turkish government, based largely on a lack of information to value the subsidy, which these cables provide.

We will pay the FOIA fees associated with this request up to, and including, \$1000.
