The Jurors of the Grand Jury of the State of Ohio, within and for the body of the County aforesaid, being duly impaneled and sworn and charged to inquire of and present all offenses whatever committed within the limits of said County, on their oaths, IN THE NAME AND BY THE AUTHORITY OF THE STATE OF OHIO,

**COUNT ONE**

DO FIND AND PRESENT, that **TIMOTHY D. LUNA** on or about the 17th day of December, 2021 through the 25th day of June, 2022, in a continuing course of conduct in the Counties of Summit and Cuyahoga and State of Ohio aforesaid, did commit the crime of **RAPE** in that he did engage in sexual conduct with [REDACTED] who was not the spouse of the offender, whose age at the time of the said sexual conduct was less than thirteen years of age, to wit: 6, whether or not the offender knew the age of [REDACTED] in violation of Section 2907.02(A)(1)(b), 2907.02(B) of the Ohio Revised Code, a **FELONY OF THE FIRST DEGREE**, contrary to the form of the statute in such case made and provided and against the peace and dignity of the State of Ohio.

FURTHERMORE, the victim was less than ten years of age.

**SPECIFICATION ONE TO COUNT ONE O.R.C. 2941.148(A)**  
**SEXUALLY VIOLENT PREDATOR SPECIFICATION**

The Grand Jurors further find and specify that Timothy D. Luna is a sexually violent predator, in violation of Section 2941.148(A) of the Ohio Revised Code, contrary to the form of the statute in such case made and provided and against the peace and dignity of the State of Ohio.

**COUNT TWO**

And the Grand Jurors of the State of Ohio, within and for the body of the County of Summit aforesaid, on their oaths in the name and by the authority of the State of Ohio, DO FURTHER FIND AND PRESENT, that **TIMOTHY D. LUNA** on or about the 17th day of December, 2021 through the 25th day of June, 2022, in a continuing course of conduct in the Counties of Summit and Cuyahoga and State of Ohio aforesaid, did commit the crime of **RAPE** in that he did engage in sexual conduct with [REDACTED] who was not the spouse of the offender, whose age at the time of the said sexual conduct was less than thirteen years of age, to wit: 6, whether or not the offender knew the age of [REDACTED], in violation of Section 2907.02(A)(1)(b), 2907.02(B) of the Ohio Revised Code, a **FELONY OF THE FIRST DEGREE**, contrary to the form of the statute in such case made and provided and against the peace and dignity of the State of Ohio.  
FURTHERMORE, the victim was less than ten years of age.

**SPECIFICATION ONE TO COUNT TWO O.R.C. 2941.148(A)**  
**SEXUALLY VIOLENT PREDATOR SPECIFICATION**

The Grand Jurors further find and specify that Timothy D. Luna is a sexually violent predator, in violation of Section 2941.148(A) of the Ohio Revised Code, contrary to the form of the statute in such case made and provided and against the peace and dignity of the State of Ohio.

**COUNT THREE**

And the Grand Jurors of the State of Ohio, within and for the body of the County of Summit aforesaid, on their oaths in the name and by the authority of the State of Ohio, DO FURTHER FIND AND PRESENT, that **TIMOTHY D. LUNA** on or about the 17th day of December, 2021 through the 25th day of June, 2022, in a continuing course of conduct in the Counties of Summit and Cuyahoga and State of Ohio aforesaid, did commit the crime of **RAPE** in that he did engage in sexual conduct with [REDACTED] who was not the spouse of the offender, whose age at the time of the said sexual conduct was less than thirteen years of age, to wit: 6, whether or not the offender knew the age of [REDACTED] in violation of Section 2907.02(A)(1)(b), 2907.02(B) of the Ohio Revised Code, a **FELONY OF THE FIRST DEGREE**, contrary to the form of the statute in such case made and provided and against the peace and dignity of the State of Ohio.  
FURTHERMORE, the victim was less than ten years of age.

**SPECIFICATION ONE TO COUNT THREE O.R.C. 2941.148(A)**  
**SEXUALLY VIOLENT PREDATOR SPECIFICATION**

The Grand Jurors further find and specify that Timothy D. Luna is a sexually violent predator, in violation of Section 2941.148(A) of the Ohio Revised Code, contrary to the form of the statute in such case made and provided and against the peace and dignity of the State of Ohio.

#### COUNT FOUR

And the Grand Jurors of the State of Ohio, within and for the body of the County of Summit aforesaid, on their oaths in the name and by the authority of the State of Ohio, DO FURTHER FIND AND PRESENT, that **TIMOTHY D. LUNA** on or about the 17th day of December, 2021 through the 25th day of June, 2022, in a continuing course of conduct in the Counties of Summit and Cuyahoga and State of Ohio aforesaid, did commit the crime of **RAPE** in that he did engage in sexual conduct with [REDACTED] who was not the spouse of the offender, whose age at the time of the said sexual conduct was less than thirteen years of age, to wit: 6, whether or not the offender knew the age of [REDACTED], in violation of Section 2907.02(A)(1)(b), 2907.02(B) of the Ohio Revised Code, a **FELONY OF THE FIRST DEGREE**, contrary to the form of the statute in such case made and provided and against the peace and dignity of the State of Ohio.

FURTHERMORE, the victim was less than ten years of age.

LUNA** on or about the 17th day of December, 2021 through the 25th day of June, 2022, in a continuing course of conduct in the Counties of Summit and Cuyahoga and State of Ohio aforesaid, did commit the crime of **GROSS SEXUAL IMPOSITION** in that he did have sexual contact with [REDACTED] not his spouse, when [REDACTED] was less than thirteen years of age, whether or not the offender knew the age of that person, in violation of Section 2907.05(A)(4), 2907.05(C)(2) of the Ohio Revised Code, a **FELONY OF THE THIRD DEGREE**, contrary to the form of the statute in such case made and provided and against the peace and dignity of the State of Ohio.

#### COUNT SIX

And the Grand Jurors of the State of Ohio, within and for the body of the County of Summit aforesaid, on their oaths in the name and by the authority of the State of Ohio, DO FURTHER FIND AND PRESENT, that **TIMOTHY D. LUNA** on or about the 17th day of December, 2021 through the 25th day of June, 2022, in a continuing course of conduct in the Counties of Summit and Cuyahoga and State of Ohio aforesaid, did commit the crime of **GROSS SEXUAL IMPOSITION** in that he did have sexual contact with [REDACTED] not his spouse, when [REDACTED] was less than thirteen years of age, whether or not the offender knew the age of that person, in violation of Section 2907.05(A)(4), 2907.05(C)(2) of the Ohio Revised Code, a **FELONY OF THE THIRD DEGREE**, contrary to the form of the statute in such case made and provided and against the peace and

dignity of the State of Ohio.

### **COUNT SEVEN**

And the Grand Jurors of the State of Ohio, within and for the body of the County of Summit aforesaid, on their oaths in the name and by the authority of the State of Ohio, DO FURTHER FIND AND PRESENT, that **TIMOTHY D. LUNA** on or about the 1st day of October, 2018 through the 15th day of October, 2018, in the County of Summit and State of Ohio aforesaid, did commit the crime of **RAPE** in that he did engage in sexual conduct with [REDACTED] who was not the spouse of the offender, whose age at the time of the said sexual conduct was less than thirteen years of age, to wit: 9, whether or not the offender knew the age of [REDACTED] in violation of Section 2907.02(A)(1)(b), 2907.02(B) of the Ohio Revised Code, a **FELONY OF THE FIRST DEGREE**, contrary to the form of the statute in such case made and provided and against the peace and dignity of the State of Ohio.

FURTHERMORE, the victim was less than ten years of age.

#### **SPECIFICATION ONE TO COUNT SEVEN O.R.C. 2941.148(A)** **SEXUALLY VIOLENT PREDATOR SPECIFICATION**

The Grand Jurors further find and specify that Timothy D. Luna is a sexually violent predator, in violation of Section 2941.148(A) of the Ohio Revised Code, contrary to the form of the statute in such case made and provided and against the peace and dignity of the State of Ohio.

### **COUNT EIGHT**

LUNA** on or about the 1st day of October, 2018 through the 15th day of October, 2018, in the County of Summit and State of Ohio aforesaid, did commit the crime of **RAPE** in that he did engage in sexual conduct with [REDACTED] who was not the spouse of the offender, whose age at the time of the said sexual conduct was less than thirteen years of age, to wit: 9, whether or not the offender knew the age of [REDACTED] in violation of Section 2907.02(A)(1)(b), 2907.02(B) of the Ohio Revised Code, a **FELONY OF THE FIRST DEGREE**, contrary to the form of the statute in such case made and provided and against the peace and dignity of the State of Ohio.

FURTHERMORE, the victim was less than ten years of age.

#### **SPECIFICATION ONE TO COUNT EIGHT O.R.C. 2941.148(A)** **SEXUALLY VIOLENT PREDATOR SPECIFICATION**

The Grand Jurors further find and specify that Timothy D. Luna is a sexually violent predator, in

violation of Section 2941.148(A) of the Ohio Revised Code, contrary to the form of the statute in such case made and provided and against the peace and dignity of the State of Ohio.


**COUNT NINE**




**COUNT TEN**

And the Grand Jurors of the State of Ohio, within and for the body of the County of Summit aforesaid, on their oaths in the name and by the authority of the State of Ohio, **DO FURTHER FIND AND PRESENT**, that **TIMOTHY D. LUNA** on or about the 8th day of June, 2021, in the County of Summit and State of Ohio aforesaid, did commit the crime of **IMPORTUNING** in that he did recklessly solicit online username: thunderslaying, not the spouse of the offender, to engage in sexual conduct with Timothy D. Luna who was eighteen years of age or older, to wit: 03/19/1997, and was four or more years older than online username: thunderslaying, and the victim was thirteen years of age or older but less than sixteen years, to wit: age 13, whether or not the offender knew the age of the victim, in violation of Section 2907.07(B)(1), 2907.07(F)(3) of the Ohio Revised Code, a **FELONY OF THE FIFTH DEGREE**, contrary to the form of the statute in such case made and provided and against the peace and dignity of the State of Ohio.
