RESULTS / INTERPRETATIONS

Items 1, 2, 3, 5, 7--9, 10, 11, 14--18, 20, 22, 23, 25, 27--32, 35, and 39 were processed with latent prints of value for comparison developed. Items 4, 6, 12, 13, 19, 21, 24, 26, 33, 36, 38 and 40 were processed with no latent prints of value for comparison developed.

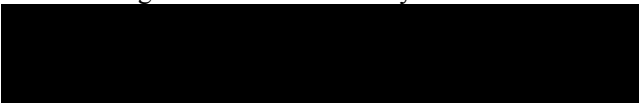
One hundred eighteen (118) latent prints were compared to the fingerprint and palm print records of Fuentes, submitted as item 47.
