Hello all,

Thank you for sending this production. As you are aware, CIR previously indicated it would commence litigation today if USCIS did not fulfill this overdue FOIA request.

Please note that Item #15 of Mr. Aminy's request has not yet been fulfilled. We also found that a prior spreadsheet regarding HP applicants' fee waiver requests (attached for reference) had the same data query error as in the second production: i.e., the data only reflected HP applications received as of February 1, 2022.

As I wrote in my prior email, CIR's position remains that it is appropriate for USCIS to update both spreadsheets — (1) HP application status and (2) HP fee waivers — to reflect applications received <u>as of July 15, 2022 (or the day the queries are run)</u>.

If USCIS agrees to update both spreadsheets (including all tabs) with this timeframe by the end of the week, CIR will delay commencing litigation.

Please advise on USCIS's position regarding the above. And feel free to give me a call if you desire to discuss this matter further.



I just left a voicemail with Mr. Panter because it has been a week since we last received any update from USCIS. I will attempt to reach Mr. Pinkerton and Mr. Hodes by phone. Please give me a call today with the agency's position: 510-809-3165.

To reiterate: both portions of Mr. Aminy's request — (1) the HP data, and (2) training documents — remain unfulfilled. We agreed to delay litigation based on a commitment from USCIS to provide, at **minimum**, the HP data by July 8. USCIS has not upheld that portion of its commitment.

Hello all,

After speaking with Mr. Hodes, I will again clarify CIR's position as to the HP data: at absolute minimum, USCIS must provide all requested HP data up to May 1, 2022.

As I noted in my email last week (July 20), the attached spreadsheet regarding HP applicants' fees and fee waivers only goes up to February 1, 2022. If USCIS provides the next three months of data up to May 1 — as it did for the HP application status data — the entire HP data portion of this FOIA request will be completed.

Given CIR's patience, CIR's multiple attempts to obtain USCIS's position on this matter, and USCIS's demonstrated ability to quickly rectify errors in data query timeframe, this is a reasonable way to avoid litigation.

Please advise immediately regarding USCIS's position and if CIR can provide any additional clarification. Here again is my cell: 510-809-3165.




