THE JURORS OF THE GRAND JURY OF THE STATE OF OHIO, within and for the body of the County aforesaid, on their oaths, in the name and by the authority of the State of Ohio, do find and present that:

#### COUNT ONE **SEXUAL BATTERY**

On or about April 03, 2021, in Butler County, Ohio, Ashley Ra-Nae Rison did engage in sexual conduct with another, not the spouse of the offender, when the offender is a teacher, administrator, coach, or other person in authority employed by or serving in a school for which the state board of education prescribes minimum standards pursuant to division (D) of section 3301.07 of the Revised Code, the other person is enrolled in or attends that school, and the offender is not enrolled in and does not attend that school, which constitutes the offense of SEXUAL BATTERY, a Third Degree Felony, in violation of R.C. §2907.03(A)(7), and against the peace and dignity of the State Of Ohio.

#### **COUNT TWO SEXUAL BATTERY**

On or about April 03, 2021, in Butler County, Ohio, Ashley Ra-Nae Rison did engage in sexual conduct with another, not the spouse of the offender, when the other person is a minor, and the offender is the other person's athletic or other type of coach, is the other person's instructor, is the leader of a scouting troop of which the other person is a member, or is a person with temporary or occasional disciplinary control over the other person, which constitutes the offense of SEXUAL BATTERY, a Third Degree Felony, in violation of R.C. §2907.03(A)(9), and against the peace and dignity of the State Of Ohio.

#### COUNT THREE **SEXUAL BATTERY**

On or about April 06, 2021, through April 11, 2021, in Butler County, Ohio, Ashley Ra-Nae Rison did engage in sexual conduct with another, not the spouse of the offender, when the offender is a teacher, administrator, coach, or other person in authority employed by or serving in a school for which the state board of education prescribes minimum standards pursuant to division (D) of section 3301.07 of the Revised Code, the other person is enrolled in or attends that school, and the offender is not enrolled in and does not attend that school, which constitutes the offense of SEXUAL BATTERY, a Third Degree Felony, in violation of R.C. §2907.03(A)(7), and against the peace and dignity of the State Of Ohio.

### COUNT FOUR SEXUAL BATTERY

On or about April 06, 2021, through April 11, 2021, in Butler County, Ohio, Ashley Ra-Nae Rison did engage in sexual conduct with another, not the spouse of the offender, when the other person is a minor, and the offender is the other person's athletic or other type of coach, is the other person's instructor, is the leader of a scouting troop of which the other person is a member, or is a person with temporary or occasional disciplinary control over the other person, which constitutes the offense of SEXUAL BATTERY, a Third Degree Felony, in violation of R.C. §2907.03(A)(9), and against the peace and dignity of the State Of Ohio.

## COUNT FIVE SEXUAL BATTERY

On or about April 12, 2021, through April 23, 2021, in Butler County, Ohio, Ashley Ra-Nae Rison did engage in sexual conduct with another, not the spouse of the offender, when the offender is a teacher, administrator, coach, or other person in authority employed by or serving in a school for which the state board of education prescribes minimum standards pursuant to division (D) of section 3301.07 of the Revised Code, the other person is enrolled in or attends that school, and the offender is not enrolled in and does not attend that school, which constitutes the offense of SEXUAL BATTERY, a Third Degree Felony, in violation of R.C. §2907.03(A)(7), and against the peace and dignity of the State Of Ohio.

## COUNT SIX SEXUAL BATTERY

On or about April 12, 2021, through April 23, 2021, in Butler County, Ohio, Ashley Ra-Nae Rison did engage in sexual conduct with another, not the spouse of the offender, when the other person is a minor, and the offender is the other person's athletic or other type of coach, is the other person's instructor, is the leader of a scouting troop of which the other person is a member, or is a person with temporary or occasional disciplinary control over the other person, which constitutes the offense of SEXUAL BATTERY, a Third Degree Felony, in violation of R.C. §2907.03(A)(9), and against the peace and dignity of the State Of Ohio.

# COUNT SEVEN SEXUAL BATTERY

On or about April 24, 2021, through April 25, 2021, in Butler County, Ohio, Ashley Ra-Nae Rison did engage in sexual conduct with another, not the spouse of the offender, when the offender is a teacher, administrator, coach, or other person in authority employed by or serving in a school for which the state board of education prescribes minimum standards pursuant to division (D) of section 3301.07 of the Revised Code, the other person is enrolled in or attends that school, and the offender is not enrolled in and does not attend that school, which constitutes the offense of SEXUAL BATTERY, a Third Degree Felony, in violation of R.C. §2907.03(A)(7), and against the peace and dignity of the State Of Ohio.

#### COUNT EIGHT SEXUAL BATTERY

On or about April 24, 2021, through April 25, 2021, in Butler County, Ohio, Ashley Ra-Nae Rison did engage in sexual conduct with another, not the spouse of the offender, when the other person is a minor, and the offender is the other person's athletic or other type of coach, is the other person's instructor, is the leader of a scouting troop of which the other person is a member, or is a person with temporary or occasional disciplinary control over the other person, which constitutes the offense of SEXUAL BATTERY, a Third Degree Felony, in violation of R.C. §2907.03(A)(9), and against the peace and dignity of the State Of Ohio.

## COUNT NINE TAMPERING WITH EVIDENCE

On or about May 01, 2021, through May 03, 2021, in Butler County, Ohio, Ashley Ra-Nae Rison did knowing that an official proceeding or investigation is in progress, or is about to be or likely to be instituted, alter, destroy, conceal, or remove any record, document, or thing, with purpose to impair its value or availability as evidence in such proceeding or investigation, which constitutes the offense of TAMPERING WITH EVIDENCE, a Third Degree Felony, in violation of R.C. §2921.12(A)(1), and against the peace and dignity of the State Of Ohio.

# COUNT TEN FURNISHING ALCOHOL TO AN UNDERAGE PERSON

On or about March 21, 2021, through April 25, 2021, in Butler County, Ohio, Ashley Ra-Nae Rison did sell beer or intoxicating liquor to an underage person or did buy beer or intoxicating liquor for an underage person or did furnish it to an underage person, when the person furnishing such alcohol was not a physician, acting in the regular line of the physician's practice and such alcohol was not given for established religious purposes and the underage person is not supervised by a parent, spouse who is not an underage person, or legal guardian., which constitutes the offense of FURNISHING ALCOHOL TO AN UNDERAGE PERSON, a Minor Misdemeanor, in violation of R.C. §4301.69(A), and against the peace and dignity of the State Of Ohio.
