We recently concluded a series of meetings in the Capitol that have had to have happened if we were to be able to give Aerotropolis and the rest of the eco-devo measures a chance of passing. Earlier yesterday, the bill was considered by most, including most ardent supporters, to have no chance.

A day of contentious legislative activity concluded with refusals of the legislative chambers to look at each others eco-devo/credit reform proposals. We were dead.

Rep. John Diehl contacted me late last night which led to a meeting between Tracy and I with House Leadership regarding differences in the House and Senate versions of tax credit reform and how it had hamstrung the eco-devo package. The Senate and House were too far apart at this point to agree to anything.

During that meeting we stressed the importance of engaging in communication to try to resurrect any chance of resolution of differences and passage of Aerotropolis and asked if House leaders would meet with the key Senators. We arranged a meeting between Diehl, Speaker Tilley, Sen. Schmitt, and Sen. Lager. Luckily our insomniac Steve Stone was still in the Capitol and was able to participate. This was very productive to get earnest discussions about positions on the issues, \$ amounts of reforms, what was on/off the table, etc. Very detailed discussion with tangible takeaways related to differences in the 2 bodies' views on reform to research and work on for another meeting tomorrow at 9 am. While there are still differences and tensions, there was significant meaningful progress that revived the issue and put us back in the realm of possibility of legislative consideration tomorrow on the last day of session.

We had follow-up meetings with House and Senate Leadership. It is obvious there is a level of skepticism and mistrust between the House and Senate on a variety of issues this year, higher than I recall in past sessions. During those meetings we were able to keep the discussion going with some pretty exhausted people. Steve was able to have a conversation with Sen. Purgason, an absolutely key figure in this debate. He imparted to Steve a positive message that gave us hope for tomorrow. I'll let Steve add to that, but it is obvious that a lot of these folks are working very hard to get a positive outcome on this, many more than we had thought.

No sugar-coating. We have a long way to go, but we were dead a few times already but we have a long shot to get this done now. The smallest of problems could still blow this up, but we're in the game.

Social justice and Aerotropolis

As the EYE hit deadline, the Missouri Legislature was in a scrum over several controversial pieces of legislation with great interest to St. Louis that had become intertwined through end-of-session dealmaking. The so-called Aerotropolis legislation, which would provide \$360 million in tax credits to invest in making the St. Louis airport an international cargo hub, had been bundled in a larger economic development bill that had been targeted by Senate Republicans. Senate Republicans had been delaying a vote on the local control bill to pressure House Republicans to peg down the tax credits offered in the bill that includes the Aerotropolis incentives.

The wrangling of Missouri Republicans in Jefferson City over tax credits at the expense of St. Louis is to be expected. It was surprising, however, to see a newspaper that claims to advance the business interests of St. Louis sling rocks at the Aerotropolis legislation while the ticklish deal was in the making. The issue raised was the allegedly hefty fees being collected by attorney Steve Stone, who crafted the Aerotropolis legislation and masterminded the China Hub concept. Members of Stone's family (the Perrys) were among the first European capitalists to do business with Communist China, and their connections provided the indispensable entry for the Midwest China Hub Commission, chaired by Mike Jones, senior policy advisor to County Executive Charlie A. Dooley.

This mainstream publication was joined in its rock-throwing by veteran attorney/activist Eric E. Vickers. Vickers - who is notorious for sending scathing emails to public officials that copy a long string of journalists and activists - called out Mike Jones for allegedly enabling Steve Stone in his "hustle," as Vickers phrased it. Vickers and Stone have some history. Last year, Vickers and a client joined the lawsuit that successfully derailed, at least momentarily, the Northside Regeneration tax credit deal that Stone's firm had negotiated with the City of St. Louis on behalf of Paul McKee Jr.

However, Jones and Vickers have an even longer history. Jones reminded Vickers of this shared activist past while pointedly taking exception to almost everything Vickers said and suggested about himself, the commission he chairs, the Aerotropolis legislation and Steve Stone.

The EYE can provide no better contribution to this discussion than to quote Mike Jones at great length.

Mike Jones writes:

As always in life there are macro forces over which you have no control, but you always are in control of your tactical responses which can influence how those forces play out.

I appreciate your thoughtful inquiry regarding the consulting arrangements of the Midwest China Hub Commission (MCHC) and I will attempt to address each point you have raised. You and I are both Serious Brothers and have always had an intellectually honest relationship. With that in mind I'll explain my reasoning, which you may still disagree with, but I will not hustle you.

My involvement in this project rests upon certain assumptions. First, St Louis is a failed city. It's financially bankrupt and structurally obsolete and the leadership, has neither the vision, the capacity or the will to fix this condition. Secondly, the St. Louis region is and has been in a steady 50-year decline toward economic irrelevance

While we have not always tactically agreed on specific public policy, I think both of us have our politics based upon the principle that social justice is the highest value of any society and that without it any other values the society purports to embrace rest upon a foundation of sand.

The MCHC was created to facilitate repositioning St. Louis as a major gateway for international

air cargo with the Chinese airline industry being the foundation for that. I would argue we have done our job. Lambert is in the final phase of negotiating a hub deal with China Eastern, and the Missouri General Assembly is within a week of creating a framework that can influence industry behavior to take advantage of the Chinese airline connection. If properly executed (we still have to prove we have the culture and capacity), this idea could erase 150 years of terrible strategic decisions, starting with the transcontinental railroad tragedy through the Columbia Waterloo airport debacle, and give us a at shot at a viable future in a 21st century global economy.

I will not insult your intelligence or mine with some superstitious nonsense about trickle-down economics (if rich folks have all the money, by extension working and poor people will do well). I would argue, in fact, that value of whatever is produced in any economy is a primarily function of the labor required to produce it and not the financial capital invested. Therefore, a just society would recognize the claim of labor to an equitable share of that value. But we can talk about that problem later.

Now we are both committed to the welfare of the Black Community. In fact, over the almost 40 years we've know each other, we have gone from young men to old men in that struggle. The solutions to the myriad of problems facing the Black Community will be a function of the physical conditions of the St. Louis region. It is with that perspective that I will address your concerns about the MCHC.

The success of this initiative would dramatically change the economic trajectory of St. Louis and create economic conditions that could possibly lead to new and effective solutions to the issues of race, opportunity and income disparity. Now this alone would not be enough to change the fate of the Black Community in St. Louis. We would also need effective and visionary black leadership to take advantage of the new paradigm. It's not a question of either/or, but of both.

Now to Steve Stone. I stand by my comments that \$15,000 per month was the cap the MCHC paid Mr. Stone. Of the \$400,000 you reference, over \$200,000 of that was paid by the City of St. Louis and the RCGA. The MCHC had no involvement with or prior knowledge of these two arrangements. Therefore, any questions about the rationale for the arrangements should be addressed to the Mayor's Office and the RCGA. Again, the amount I mentioned of \$5,000 is what Mr. Stone has billed the MCHC since December of 2010.

If you have questions or objections to what Mr. Stone purports to be his hourly billing rates or his claims about the level of underwriting his firm gave to this project, I suggest you take those up with him, as those are his representations, not mine. In addition, however Mr. Stone spends his income is also his business and not mine.

I will address an underlying rationale for the MCHC's relationship with Mr. Stone by referring to my comments to the Post-Dispatch Sunday a week ago. That is simply this: no Stone, no Perry, no Chinese, no Chinese, no deal. If we are successful, then the money was a bargain, and if we fail we paid too much. Simple as that!

I take seriously the issue of public accountability, as opposed to public approval. As a serious public commentator, I think I'm honor-bound to address your inquiry into my actions and statements. However, the only approval I need is my own. As always, I will stand by my record, and others have to stand by theirs.

Suggs urges region to embrace Aerotropolis

The St. Louis region is at a potential turning point, Donald M. Suggs, publisher of The St. Louis American, told about 400 people gathered for FOCUS St. Louis' 2011 "What's Right with the Region!" award ceremony at the Sheldon Concert Hall on May 5.

And if regional leaders aren't careful, Suggs said, they could "blow it" - just like their predecessors who decided to forego railroad development in the 1860s and airport expansion in the 1970s.

"St. Louis has had a history of being bold at times - such as funding Charles Lindbergh's historic

transatlantic flight back in 1927, and the bold move to construct the Arch, which was topped out in 1965 after over two decades of civic effort," Suggs said.

"St. Louis also has had other great opportunities in the past - and blew them."

Suggs received the 2011 Leadership award, FOCUS St. Louis' highest honor, for being an "effective agent for change."

This is the 14th year that local nonprofit FOCUS St. Louis has given awards to groups creating regional solutions through community leadership, as its mission outlines.

The 16 other award winners this year included longtime Harris-Stowe State University President Dr. Henry Givens Jr., Judge Jimmie M. Edwards, the 24:1 initiative led in North County by Beyond Housing and the Midwest China Hub group.

"I am mindful that any small positive contribution I may have been a part of over the years has been largely due to the work of so many others - and my colleagues at The American and members of many of the region's non-profits, in particular," Suggs said in his acceptance speech.

Then Suggs put on his "executive editor's hat," he said, and gave a brief "editorial" about the opportunity at hand for the region: namely, to make Lambert-St. Louis International Airport an air-cargo hub for trade with China.

"Something magical is in the process in the Missouri Legislature, and it's happening as we speak," Suggs said.

"For years, this area has been at a total standoff on any new tools for economic development. Last week, the Missouri Senate stepped up and approved the so-called Aerotropolis legislation, the Missouri Science and Innovation Reinvestment Act, called MOSIRA, and a number of other economic development tools, along with what appears to be a compromised version of tax credit reforms."

The Aerotropolis legislation projects to generate tens of thousands of new jobs and over \$22 billion in new economic benefits for the region and state, he said. It would also show China this region's commitment to making Lambert its new U.S. cargo hub.

In the 1860s and '70s, the region's decision to forego developing railroads was driven by the self-interests of business leaders, Suggs said.

"St. Louis ended up building the Eads Bridge too late in the game to matter for winning the railroads for St. Louis," he said, and the opportunity went to Chicago.

Then in the 1970s, following years of planning and efforts to build the nation's next mid-

continent international airport in our region at Columbia-Waterloo in Illinois with federal funds, "we once again stubbed our civic toe," he said.

"Once again, St. Louis snatched defeat from the jaws of victory and missed the opportunity to build the nation's next mid-continental mega international airport - and subsequently Denver stepped up to build Denver International Airport, filling that need," he said.

Midwest China Hub Chairman Mike Jones, an award winner in the "Fostering Regional Cooperation" category, said the region has a good chance at sealing the China hub deal. However, it takes cooperation.

"We had to take 'I' out of team and put on our 'we' cap," Jones said.

Suggs also addressed the region's journey in equality, as "Improving racial equality and social justice" was an award category.

"I was born and came into adulthood in an era of Jim Crow, a time of de facto racial separation - of separate, but unequal - when people would reject you for no other reason than your race; when to be black was to be under assault," Suggs said.

"But I am also reminded of and encouraged by how much change one can experience in a lifetime, and FOCUS St. Louis has contributed so much to positive transformative change in our region over the years."

The other 2011 "What's Right with the Region!" award winners included: Crossroads College Preparatory School, The Magic House, Marian Middle School, Healthy Kids Express - Pediatric Mobil Health Program, Simone Bernstein, St. Louis Bread Co. Cares Café, Healthy Eating with Local Produce, Peter & Paul Community Services, St. Louis Healthy Families, William M. Fogarty Jr., M.D., Educational Equity Consultants, The Haven of Grace, Youth in Need, Francie Broderick and Places for People, Paraquad, and Wings of Hope.

Lambert in talks about Latin America cargo flights

Even as talks continue about turning St. Louis' under-used airport into a "Gateway to the East," the people who run it are looking to the south as well.

Lambert-St. Louis International Airport last week signed an agreement with a fledgling Texas-based airline to explore the prospect of freight routes to Latin America. The deal between Lambert and Brownsville-based Pan American Airways Inc. is very preliminary. But it's the clearest sign yet that the region's long-discussed China Hub project - which will come to a head in the Missouri Legislature this week - in fact has more global ambitions.

"I think we'll see more and more of this sort of thing if the Chinese decide to come here," said Lambert director Rhonda Hamm-Niebruegge.

Despite its famous name, this Pan Am is basically a startup.

It's run by a man named Robert Hedrick who owns a company that builds pools for resorts and amusement parks, and another that ships equipment for those pools around the world. He says he has been working for several years on developing a new U.S. gateway for Latin American air cargo - most of which now flies through Miami - and has raised \$75 million to finance his effort. He plans to lease planes to run flights through Brownsville, and Lambert, where he sees a chance to connect with the Chinese, and plug Latin American goods into the center of the Midwest.

"We're going to spend a considerable amount of money up there, and we think it's going to be worth it," Hedrick said.

He's been talking with Lambert since November, and last week the two sides signed a memorandum of understanding laying out a plan. The non-binding document calls for Pan Am to invest \$50 million in facilities at the airport and occupy about 250,000 square feet of hangar and warehouse space. The airline would put its primary maintenance facility at Lambert and fly cargo to at least 18 other U.S. airports from St. Louis. And it would likely tap the incentives Lambert offers new carriers and potentially the Aerotropolis tax credits now being considered by Missouri legislators.

Hedrick said he hoped to start flights by fall, and that he envisioned demand for flying flowers from Central and South America to the Midwest. He said he would take a wait-and-see approach on other items.

"Nothing's hard and fast," he said. "We're looking to St. Louis to tell us what you want us to do."

The idea isn't new. St. Clair County spent \$2.8 million on refrigerating a warehouse at struggling MidAmerica airport in Mascoutah to attract cargo flights of flowers from South America. The venture was short-lived, ending last year.

Lambert officials said Hedrick's plan had promise, and fit well with their broader goals to connect China and Latin America. But they also sounded a cautious note.

"It's important not to overplay it," Hamm-Niebruegge said. "It could be great. But there are still a lot of things to do, a lot of details to work out."

Air China (CA) and Cathay Pacific Airways (CX) announced a formal launch of their joint venture cargo operation on Wednesday. The JV, called Air China Cargo, consolidates the two carriers' airfreight divisions.

Air China is a major (29.99%) stake holder in Cathay Pacific.

The JV was cleared by the Chinese government last year.

While CA will own a majority 51% stake in the consolidated cargo carrier, CX will hold 25% and will also fund an offshore trust will hold 24%.

"This latest collaboration will increase fleet development and strengthen the market position of both airlines. The operation centre in Shanghai will satisfy the market demands of the Yangtze River Delta, which makes up two-thirds of Air China's service area. The cooperation will help Air China Cargo reach all-round global development."

Bob Hedrick, president of Brownsville-based Pan American Airways, said a "memorandum of understanding" he recently signed with the head of Lambert-St. Louis International Airport in Missouri could mean big things for Brownsville economically - unless he decides to set up shop elsewhere.

Hedrick signed the memorandum with Lambert Field director Rhonda Hamm-Niebruegge on Thursday. The document details PAA's plans to establish a cargo hub in St. Louis that would link to Brownsville/South Padre Island International Airport and involve air cargo from China, which is seeking to greatly expand air freight operations to the United States and Latin America.

A PAA hub at Lambert Field would serve to develop "Midwest cargo activity" and also link future PAA flights serving Latin America to "operations serving China," according to the memorandum. St. Louis is on the verge of sealing a deal with China that would make Lambert Field the hub for air cargo between China and the United States. For the deal to become a reality, St. Louis is banking on passage of the \$360 million "Aerotropolis Trade Incentive and Tax Credit Act" currently making its way through the Missouri Legislature. The Missouri State Senate recently

passed its version of the Aerotropolis bill by an overwhelming majority. Now, differences between the Senate and House versions have to be hammered out before the bill can go to the governor for a signature.

The legislation would give tax breaks to companies involved in foreign trade and subsidize construction of more than 27 million square feet of warehouse and factory space in the St. Louis region. Incentives would include \$60 million in credits over eight years for freight forwarders, which, along with other incentives, could benefit cargo companies like PAA.

Hedrick's plan is to invest \$50 million at Lambert Field to help develop its Midwest cargo hub and another \$25 million in Brownsville "to support the connections from the Midwest and China to Latin America," according to the memorandum of understanding - not a legally binding document but rather a formal statement of intent between the two parties. PAA's investments would include maintenance, operations and repair facilities at St. Louis and Brownsville. Hedrick said the \$75 million has already been funded through equity and other forms of financing.

"I've been working on this since November of last year," he said. "All the pieces of the puzzle to make this happen are in place. Now I actually have to write an operational plan."

Hedrick said making Brownsville the "gateway to Latin America" for freight to and from China via St. Louis would have huge ramifications for the local economy thanks to the flood of cargo and jobs created - though he's by no means wedded to Brownsville. Hedrick hasn't forgotten the criticism some city officials, especially City Commissioner Charlie Atkinson, publicly leveled at his company during the recent, messy public debate over Fly Frontera, a proposed deal for passenger air service to Mexico that died after a negative financial report from the Brownsville Economic Development Council. Hedrick had insisted the bidding be opened up to PAA and other aviation companies, while Atkinson was a strong proponent of the Fly Frontera deal.

"I am questioning should I bring the gateway here," Hedrick said. "I need the city to get behind us. I can't do it when I'm fighting everybody."

Hedrick said he'll ask for meetings with Brownsville's aviation board, the city commission, the Brownsville Economic Development Council, and the Greater Brownsville Incentives Corporation - but not until Saturday's election is over.

"I'm going to talk to them," he said. "I'm going to lay it out. If the city can't support this, you need to tell me now."

Lawmakers Face Long To-Do List

The last week of the 2011 Missouri legislative session has arrived. Some major issues have already been resolved. Lawmakers have passed the state budget, forced changes to dog breeding regulations in Proposition B and overridden the governor's veto of the state's congressional redistricting map. But there are still plenty of issues waiting for action.

The biggest battle left to fight appears to be over a wide-ranging economic development bill that includes the so-called Aerotropolis proposal. The House passed it as a stand-alone bill, which would authorize up to 480 million in tax breaks to transform Lambert Airport in St. Louis into an international air cargo hub.

The Senate version shrunk the Aerotropolis bill down to 360 million in incentives, and rolled it into a larger tax credit overhaul measure that would reduce numerous incentives and eliminate others. House Speaker Steven Tilley isn't a fan of the Senate version.

"When we send them a 9-page bill and we get back a 400-page bill, I think we need to look through it before we make any drastic steps," said Tilley.

But there's a group of Senators who continue to push to have all tax credits subject to appropriations, including any new ones under Aerotropolis. Tilley would like to see it pass, but also says if it doesn't, it's not worth calling lawmakers back to Jefferson City for a special session.

"I'd like to see the pro-life bill that our majority leader's the sponsor of I'd like to see drug testing for TANF recipients, I believe that we've got a version of it already over here in the House," said Tilley.

TANF stands for "Temporary Assistance to Needy Families," and is a state-run program. Supporters say failing a drug test would only cost recipients 58 dollars a month, and would not affect their eligibility for federal welfare programs.

Opponents say depriving the poor of even that much money could be financially crippling. In the Senate, the first measure on their to-do list this week is the resolution requiring voters to show photo ID's at the polls. Tom Dempsey of St. Charles is the Senate's Majority Floor Leader.

"My understanding (is) that the amendments the House added that the sponsor is comfortable with them and believes that the support is there in the Senate, and he believes we're ready to go on that legislation, so I'm expecting passage," said Dempsey.

The main amendment would authorize an early voting period in Missouri. If lawmakers pass it,

the resolution would go before voters next year.

The Senate is also scheduled to take up the St. Louis Police local control bill, which has already passed the House. Democrat Maria Chappelle-Nadal of St. Louis County has been blocking it. But she's encouraged by progress in negotiations between Mayor Francis Slay and the city's police officers.

"It's closer than it's ever been it is unfortunate that we have had to go this long in order to have a first and second draft language that I could even accept," said Chappelle-Nadal.

And there appears to be a last-ditch effort to salvage the site permit proposal for a second nuclear reactor at Ameren Missouri's Callaway County plant. House Majority Leader Tim Jones says the measure has been amended onto a Senate energy bill.

"I think it's been very clear from the beginning, although we haven't had a vote (yet), that the House was largely supportive of the site permit issue," said Jones, "However, the sponsor of the bill knows that that issue is extremely toxic, to put it lightly, in the Senate."

The nuclear plant language would likely be stripped from the energy bill if it endangers its passage.

Time is also running out on bills that would limit worker's compensation lawsuits, mandate English-only driver's license exams, and extend the texting-while-driving ban to motorists over the age of 21.

The 2011 session ends Friday at 6 p.m.

Missourians, your legislators are about to place a huge and ill-advised bet on the so-called "Midwest China Hub" or "Aerotropolis." It appears that the House may give final approval to the bill this week.

Legislators are trying to award \$300 million in tax credits to St. Louis warehouse developers, under the guise of encouraging international trade. In reality, those subsidies will end up paying for business as usual at the poorly managed St. Louis airport.

A handout of \$300 million will subsidize the construction of cargo warehouses around the St. Louis airport. The city airport is already carrying about \$900 million in debt. Is it really wise for the state to invest hundreds of millions more in this debt sinkhole instead of lowering taxes for all Missourians?

Sen. Ron Richard has said that he is willing to "take a chance" on this legislation, as are numerous other legislators who instead should be wisely overseeing the revenues generated by the labor of Missourians. To date, no firm commitment from China to increase trade with Missouri has been made available or announced publicly, and no feasibility study has been produced to demonstrate that the construction of more warehouses could benefit the state economy.

Instead of waiting for a commitment and a comprehensive study, legislators are ready to roll the dice.

Here is what you need to know:

- . Private developers could receive tax credits for building warehouses that process hardly any international cargo. The new legislation drastically reduces how much international cargo activity that a warehouse owner must process in order to be eligible for state tax credits. According to this version of the bill, a warehouse could be eligible for state subsidy if as little as 10 percent of its operations consisted of sending cargo to international destinations.

- . The state government is already short on funds, and it cannot afford to give away hundreds of millions on the project. Tax credits are not free money. Every dollar that the state gives away in tax credits is a dollar it doesn't have to spend on education, roads or other state government programs. This \$300 million will have to be cut from other state programs, or made up by increasing taxes.

- . This money would be considered an entitlement. If the state has to cut its budget in the future, it could not cut this \$300 million. If the state economy suffers a downturn, this money will be

paid, while everyone else tightens their belts. What is so special about the construction of warehouses that deserves this abnormally high level of protection from the state?

. Residents throughout the rest of Missouri will bear the burden of the St. Louis-based China Hub. Revenue lost to tax breaks for favored industries would need to be replaced by increased debt, reduced government spending or - more likely - imposing a higher tax rate for all of Missouri's less fortunate taxpayers. As the bill stands now, legislators are poised to take \$57 million in tax credits from the low-income elderly who rent their residences, to pay instead for warehouse construction in St. Louis.

. The government should stop trying to picking winners and losers in the economy. The China Hub bill rests on the flawed notion that legislators are all-knowing and have the ability to shape the economic activities in the state. Why should state government try to pick an economic winner, when it has such a poor track record for successfully doing so?

The best way for Missouri to grow the economy is to foster a business climate that encourages individuals to develop new ideas, and to stop awarding these special handouts. Entrepreneurs in Missouri will seize upon the opportunities around them as soon as the government gets out of their way

. Drug testing: Requires testing for welfare recipients suspected of using illegal drugs. (HB73)

. Drivers licenses: Requires that drivers license tests be administered only in English or American Sign Language. (HB167)

. Concealed guns: Lowers the minimum age to obtain a concealed-gun permit. House version lowers it from age 23 to 21; Senate lowers it to 18. (HB294)

. Charter schools: Broadens areas where charter schools can be located and who can sponsor them. (HB473)

. Voter ID: Authorizes a public vote in 2012 for a constitutional amendment requiring photo IDs at the polls. (SB3, SJR2)

. Meth/prescriptions: Requires a prescription to purchase some cold and allergy medications with pseudoephedrine, an ingredient used in making meth. (HB658)

. Senior RX: Renews a prescription drug subsidy program for the elderly and disabled, which expires this summer. (SB322)

Lambert Covered Up To \$830 Million In Damages

The Lambert Airport Commission met Wednesday, for the first time since the Good Friday tornado. And the topic on everyone's mind, was how long it could take for repairs to be completed.

An upbeat positive tone was set in the meeting, with the news of 4-6 months before windows restored. The new windows will have to be specially fabricated.

The first few windows could be installed by Friday and overall, 9 months before all repairs and reconstruction completed.

The meeting highlighted Lamberts insurance policy, which is covering up to \$830 million in damages, with a \$100,000 deductible.

Three days after tornado, the insurance co. brought a \$10 million dollar check to Lambert. Damage estimates are expected to go beyond \$10 million.

Concourse C remains closed, with extensive roof damage, stores, restaurants and operational areas damaged.

Insurance company engineers are working hand in hand with Lambert engineers on the complex project, but a final estimate on the damages is not yet complete. It's not yet known when survey will be completed.

Lambert is not eligible for FEMA grants because insurance policy too good and will cover damages including things like interruption of services, concession, parking and terminal landing fees.

Passengers are still noticing boarded up windows, but air traffic is 100 percent.

Brownsville-based carrier in talks with St. Louis airport on air cargo deal

Bob Hedrick, president of Brownsville-based Pan American Airways, said a "memorandum of understanding" he recently signed with the head of Lambert-St. Louis International Airport in Missouri could mean big things for Brownsville economically - unless he decides to set up shop elsewhere.

Hedrick signed the memorandum with Lambert Field director Rhonda Hamm-Niebruegge on Thursday. The document details PAA's plans to establish a cargo hub in St. Louis that would link to Brownsville/South Padre Island International Airport and involve air cargo from China, which is seeking to greatly expand air freight operations to the United States and Latin America.

A PAA hub at Lambert Field would serve to develop "Midwest cargo activity" and also link future PAA flights serving Latin America to "operations serving China," according to the memorandum. St. Louis is on the verge of sealing a deal with China that would make Lambert Field the hub for air cargo between China and the United States. For the deal to become a reality, St. Louis is banking on passage of the \$360 million "Aerotropolis Trade Incentive and Tax Credit Act" currently making its way through the Missouri Legislature. The Missouri State Senate recently passed its version of the Aerotropolis bill by an overwhelming majority. Now, differences between the Senate and House versions have to be hammered out before the bill can go to the governor for a signature.

The legislation would give tax breaks to companies involved in foreign trade and subsidize construction of more than 27 million square feet of warehouse and factory space in the St. Louis region. Incentives would include \$60 million in credits over eight years for freight forwarders, which, along with other incentives, could benefit cargo companies like PAA.

Hedrick's plan is to invest \$50 million at Lambert Field to help develop its Midwest cargo hub and another \$25 million in Brownsville "to support the connections from the Midwest and China to Latin America," according to the memorandum of understanding - not a legally binding document but rather a formal statement of intent between the two parties. PAA's investments would include maintenance, operations and repair facilities at St. Louis and Brownsville. Hedrick said the \$75 million has already been funded through equity and other forms of financing.

"I've been working on this since November of last year," he said. "All the pieces of the puzzle to make this happen are in place. Now I actually have to write an operational plan."

Hedrick said making Brownsville the "gateway to Latin America" for freight to and from China via St. Louis would have huge ramifications for the local economy thanks to the flood of cargo and jobs created - though he's by no means wedded to Brownsville. Hedrick hasn't forgotten the criticism some city officials, especially City Commissioner Charlie Atkinson, publicly leveled at his company during the recent, messy public debate over Fly Frontera, a proposed deal for passenger air service to Mexico that died after a negative financial report from the Brownsville Economic Development Council. Hedrick had insisted the bidding be opened up to PAA and

other aviation companies, while Atkinson was a strong proponent of the Fly Frontera deal.

"I am questioning should I bring the gateway here," Hedrick said. "I need the city to get behind us. I can't do it when I'm fighting everybody."

Hedrick said he'll ask for meetings with Brownsville's aviation board, the city commission, the Brownsville Economic Development Council, and the Greater Brownsville Incentives Corporation - but not until Saturday's election is over.

"I'm going to talk to them," he said. "I'm going to lay it out. If the city can't support this, you need to tell me now."

Oakland Mayor Jean Quan heads east to boost trade and business for Port of Oakland

Oakland Mayor Jean Quan rarely misses an opportunity to promote her hometown, and now the city's most fervent cheerleader is taking her boosterism to an international stage: China.

Quan left Friday and will join Oakland Port Executive Director Omar Benjamin on a whirlwind three-city trade mission designed to increase export trade through the Port of Oakland, generate new investments from Chinese businesses and build partnerships that will create jobs and new revenue for Oakland.

The team also hopes to interest the Hainan Group, whose HNA holdings include the large carrier Hainan Airlines and hotels, in a direct Oakland-China air service at Oakland International, Quan said. They'd like the company to make Oakland its base for tourism in Northern California.

"Oakland is pretty central to what most foreign visitors want to see in Northern California," Quan said. "They tend to do a day in Monterey, a day in Yosemite, a day in the wine country and a day or two in San Francisco. We're centrally located (for all of that) and our hotels are \$100 cheaper than San Francisco."

Quan's November election, as Oakland's first female and first Asian-American mayor, was big news around the country and particularly in China, where both her parents were born. The mayor has granted hundreds of interviews, including many with Asian journalists via Skype.

Benjamin recognized that significance and wasted no time inviting her to join him in the trade mission. He even joked earlier this year that Quan could be his secret weapon in establishing lucrative relationships with Chinese industries that benefit the Port of Oakland.

"In China and the world, successful economic development and jobs are created by business and government working hand in hand," Benjamin said at the start of the trade mission. "We are excited by Mayor Quan's leadership on this trade mission, which leverages the Port of Oakland -- our global asset -- to explore and foster new business opportunities and relationships."

According to U.S. Census data, \$14 billion worth of goods (import and export) moved between the Port of Oakland and China last year. For the first time the Oakland Port's overall exports exceed imports, and Quan and other mayors in the Bay Area have accepted President Barack Obama's challenge to double U.S. exports by 2015.

Doubling exports at the Port of Oakland would create 5,000 new jobs, Quan said.

Joining Quan and Benjamin on the 12-member trade mission are Oakland City Council President Larry Reid; Maisha Everhart, Quan's senior policy adviser; port commissioners Pamela Calloway and Michael Lighty; Deborah Ale-Flint, the port's director of aviation; James Kwon, port director of maritime; and port staff. Travel costs are being paid by the Port of Oakland's enterprise fund.

Quan and Reid have been to China several times, but not together and not since Quan was elected mayor and achieved something akin to "rock star" status, Reid said. The mayor acknowledged the interest her election has generated and said she hoped to capitalize on it.

"We hope to promote our exports and get more publicity and put a different take on the Port of Oakland for the Chinese," Quan said. "After the inauguration when I went to the White House there was a rash of publicity, so we're hoping my being here will give our port a little more high profile."

The itinerary starts in Beijing on Monday. The group will meet with potential investors and tenants in Port of Oakland infrastructure projects. Quan said there could be interest in building a cold storage facility at the port to accommodate wine and agricultural exports to China.

The group then heads to Shenzhen, a major industrial hub that is also home to several U.S. manufacturers. The group will meet with representatives of the port, shipping, airline and trucking administrations. The visit includes tours of the airport and passenger and airfreight facilities, as well as the maritime facilities of China Merchants Holdings International, a partner at the Port of Oakland.

The group will also meet with Mayor Xu Qin, of Shenzhen, and attend a reception of business and government leaders.

Next stop is Hong Kong, where the group will meet with China Merchants Holdings, tour airfreight facilities and attend an American Chamber breakfast briefing. Quan will also do her best to promote Oakland wineries on this leg of the trip. China is a growing market for California wines, and the Port of Oakland handles 90 percent of the exports.

The group plans to tour the Hong Kong Convention and Exhibition Center where Oakland winery Dashe Cellars has a display. A case of wine containing bottles produced by six Oakland vintners has been shipped to California Vintage, a wine bar and restaurant in Hong Kong that is owned by 22 California wineries. The Oakland wines will be added to the tasting menu when the group visits the wine bar on the last day of the trade mission.

Quan says it's all part of making over Oakland's image and using every tool to promote international business for the Port of Oakland that benefits the entire region.

Jeff Cohn, JC Cellars owner and winemaker, said he appreciated the mayor's support of Oakland wineries and hoped it would further his winery's efforts to be included in tasting room on a regular basis.

"I'm excited to be part of it," he said.

Airlines to blame for almost half of all flight delays <<http://china.globaltimes.cn/society/2011-05/652097.html>>

More than 40 percent of flight delays last year resulted from problems within the airline companies themselves, not because of limited airspace in China, according to the Civil Aviation Administration of China (CAAC).

The 2010 Report on China's Civil Aviation Development was released on the CAAC website Wednesday, saying that there were 1.88 million flights by the major airline companies in China last year and 457,000 had been delayed.

The CAAC said that 41.1 percent of those delays resulted from problems within China's commercial airline industry, not because the military restricts limited air space for passenger jets in China. The report said 27.6 percent of the flight delays were attributed to airport flow control, 19.5 percent resulted from weather problems and 11.8 percent were caused by other reasons.

The Beijing News on Thursday quoted an unnamed ground service manager for a major

domestic airline as saying that the company's problems with ground service, scheduling and technology created less than 2 percent of the delays and that most of the late flights were caused by flow control and weather problems.

The manager said that when flight arrivals are delayed by bad weather, the jetliners are often unable to take off on time for the next leg of the trip.

"The reasons for the flight delays are complicated, but basically result from insufficient civil airspace in China, which directly lead to the authorities' flow control," Zou Jianjun, a professor with the Civil Aviation Management Institute of China, told the Global Times on Thursday. He noted that 70 percent of China's airspace is controlled by the military while in the US, only 30 percent of the total airspace is reserved for military flights.

Xia Xinghua, vice minister of the the CAAC, said to the Xinhua News Agency in April that there were anywhere from 52,000 to 65,000 flights a day in the US and the European Union respectively, while in China there were about 10,000 flights each day.

Zou said that the airline companies were not blameless for the flight delays because many passenger carriers failed to book the flights effectively in the limited airspace for civil aviation.

"In order to compete with other companies, some airlines have blindly applied for flight numbers, which are not needed by most travelers and waste and occupy the limited airspace," Zou told the Global Times.

The CAAC report showed that in 2010, the administration had received 1,334 complaints, 245 fewer than 2009. The number of effective complaints in 2010 were 243,153 fewer than 2009.

The report said consumer complaints over air service in March this year focused more on lost or broken luggage rather than flight delays, which account for 23.53 percent of the total numbers of complaints. Luggage handling complaints make up 41.18 percent.

The report contradicts data released by the China Consumers' Association earlier, which showed that complaints over air service in 2010 had risen 89.3 percent compared with 2009, the Beijing News reported.

I know the Governor's ag trip is the priority. Based on our call this week, I believe Steve S and Mike J are reaching out to the Governor to confirm dates. It will be hard enough just to get dates from him this far in advance. I do not know the background to the Aerotropolis legislation but if it does not now pass in its entirety then there is little prospect of the route happening .

I do not know who has done what , or why the Embassy has become cautious but it has happened . CAAC and the Ministry of Foreign Affairs have ceased communicating with China Cargo . Why ? Not clear . That goes to the core as the Ministry were the source of support for the subsidies from CAAC . I think they are waiting to see what the State does . If the Bill fails then I do not think Missouri or St Louis has much future in China .

Shanghai city postponed their visit , and so has the Ministry of Commerce . The Ministry of Agriculture has said let's wait ion the seminar as they had no reply on their counter - proposal . I do not know why none of you replied to the Ministry of Agriculture - I guess it has to do with other things and lines .

The best thing you all can do is pass the legislation , negotiate with China Cargo and then , hopefully , move forward . You are close to opening the route and seem intent on risking it all .
