# November 8, 2022 Regular General Election By-Mail Voting Instructions



#### 1. Vote Ballot

### Other side contains RCV instructions


- Fill in the oval next to your choices using blue or black pen.
- Follow the voting instructions on the ballot. The General Election is Ranked Choice where you select your candidates in order of preference. See the reverse side for more instructions.
- If you make a mistake voting, call the elections office below to request a replacement ballot or draw a line through the oval of the candidate or issue you voted, write "no" next to it, and then continue voting by filling in the oval next to your choice.


## 2. Place Ballot Inside the Return Ballot Envelope

- Fold your ballot and place it inside the gray secrecy sleeve.
- Place gray sleeve with your ballot inside the return ballot envelope.



### 3. You MUST Sign the Return Envelope and Provide ONE Identifier

- Sign your Return Ballot Envelope in front of your witness.
- Write ONE of your identifiers on the back of the envelope (Voter number, Alaska driver's or state ID number, date of birth, or last four of SSN).



### 4. You MUST Have Your Signature Witnessed

- Have your signature witnessed by anyone 18 years of age or older.
- Or you may choose to have your signature witnessed by an official if reasonably accessible (Notary public, commissioned officer of the armed forces, district judge or magistrate, registration official, or other person qualified to administer oaths).

# 5. Secure and Mail Your Ballot or Drop Off Your Voted Ballot

- Fold over the flap of the return envelope to cover up your signature, identifier, and witness information and secure it at the top and bottom.
- Apply \$0.84 postage to the front of the envelope.
- Mail your ballot. It MUST be POSTMARKED on or before Election Day, Tuesday November 8, 2022. Return your ballot as soon as possible. To ensure timely postmarks, the division recommends you have the USPS postal clerk hand cancel your ballot at the counter.
- Or you may drop off your ballot at any voting location in Alaska. This includes absentee voting, early voting, and polling place locations. To find a drop off location, visit our website at www.elections.alaska.gov. If you drop off your ballot, it MUST be RECEIVED by 8:00pm on Election Day, November 8, 2022.

#### **Attention Voters**

Once you vote and mail your absentee by-mail ballot, you cannot vote again in any other manner for this election. If you vote again in this election, your votes will not count and you may be committing a crime of voter misconduct in the first degree, which is a class C felony offense. (AS 15.56.040)
