13-1403. Public sexual indecency; classification

A. A person commits public sexual indecency by intentionally or knowingly engaging in any of the following acts, if another person is present, and the defendant is reckless about whether such other person, as a reasonable person, would be offended or alarmed by the act:

1. An act of sexual contact.

C. Public sexual indecency is a class 1 misdemeanor.

13-1401. Definitions; factors

A. In this chapter, unless the context otherwise requires

3. "Sexual contact":

(a) Means any direct or indirect touching, fondling or manipulating of any part of the genitals, anus or female breast by any part of the body or by any object or causing a person to engage in such contact.

SYNOPSIS:

On 10-4-22 at approximately 1640 hours, Randy Gene Kaufman was observed by Maricopa County Colleges PD Officer Gilbreth #00389 in the east parking lot of Rio Salado College Surprise (12535 W. Smokey Drive, Surprise AZ) sitting in a maroon Ford truck knowingly engaging in sexual contact by fondling/manipulating his fully erect nude penis in a reckless manor where a reasonable person viewing his activity would be offended or alarmed by the act. Kaufman was contacted, arrested, and cited for Public Sexual Indecency.

On 10-4-22 I was in full police uniform in a police vehicle conducting routine patrol at Rio Salado College located at 12535 Smokey Drive in Surprise AZ.

At approximately 1629 hours I arrived on site and parked in front of the main building. I exited my vehicle. I looked east and observed a maroon-colored Ford F150 truck parked facing west along the south side of the lot across three spaces. The Ford truck was parked in the lot just inside the east entry off Greasewood Street. I saw that there was a shade screen across the front windshield. I went into the main building to check on staff and students inside.

At approximately 1639 hours I exited the main building. I looked east and saw that the Ford truck was parked in the same position. The way that the truck was parked, positioned across three spaces and shade screened seemed unusual. I got into my vehicle and drove over to the truck to take a closer look.

I parked approximately 20 feet north of the Ford truck from the passenger side. I got out of my vehicle and approached on foot. I heard the engine of the Ford on and running. I saw that the Ford truck has Arizona plate [REDACTED]. My sight of the truck was clear and visible. I saw that the Ford truck had a dark tint on the back cab and rear window. The passenger door windows had a slight tint, but I was able to see into the front of the cab.

As I approached the Ford from the front passenger door side, from approximately six feet away, I observed an adult male identified in this report as AP1 Randy Gene Kaufman sitting in the front driver's seat. AP1 was wearing a green t-shirt and jeans. AP1 appeared to be looking at a cell phone in one hand. I immediately became alarmed as I saw AP1 had his pants down mid-thigh and was exposed showing his fully erect nude penis. AP1 was manipulating his genitals in a masturbatory manor. AP1 was engrossed in his activity and did not see me at the passenger side door. I was further alarmed as I saw a subject on a bicycle pedaling east approximately 8 feet by

AP1's driver's side. I looked southwest approximately 190 feet with a full view of the Wirtzels Preschool and Child Care Center (directly south and next to RSC Surprise) and saw several preschool age children having outdoor activities in the playground. Vehicles were entering and exiting the east drive of the lot passing AP1's vehicle from approximately 6 to 8 feet from the passenger side of the Ford.

I moved to the front driver's side door of the Ford. AP1 looked up, saw me, seemed alarmed and surprised then grabbed a cloth he had on the seat and covered his genitals. AP1 rolled down his window and I instructed him to pull his pants up. I had AP1 exit the Ford truck. I said to AP1; "Seriously?". AP1 said to me "I'm sorry". AP1 spontaneously said to me "I fucked up. I'm really stressed".

AP1 identified himself to me via valid AZ driver's license [REDACTED]

At approximately 1645 hours I read to AP1 his Miranda Warnings via a standard card. AP1 told me he understood his rights by saying "yes".

I had the following conversation with Randy Gene Kaufman (not audio recorded due to inoperable device). The conversation is articulated question in answer format.

Ofc. = Officer Gilbreth

AP1. = Randy Kaufman

Ofc. - Did you not see me walking up to your passenger door?

AP1. - No, I didn't see you until you got to my driver's door.

Ofc. - You realize I saw you with your penis out and you were masturbating, don't you?

AP1. - Yes.

Ofc. - Why would you do that here? I saw a guy on a bike pass by you. If I could see you, don't you think other people could? Cars were passing by you in the lot.

AP1. - I realize that now. I'm just really stressed out. I have a lot of things going on.

Ofc. - Is this something that you normally do?

AP1. No.

Ofc. - I saw you had your phone out while you were doing what you were. What was going on with the phone?

AP1. - I was watching porn.

Ofc. - What kind of porn were you watching?

AP1. - Interracial porn.

Ofc. - When you look around here what do you see?

AP1. - The child center but I didn't notice it until you came up and I got out of my truck. Are you going to put that in a report?

Ofc. - Don't you see how alarming that is? That there are children nearby, people passing on bikes and in cars where they can look and see what you are doing?

AP1. – I fucked up.

Ofc. – Why are you here in this parking lot, what brings you down here?

AP1. – I live in Buckeye, but I came out here to buy rebar nearby, I was stressed and just pulled into the lot.

Ofc. – Do you know that what you were doing is an offense?

AP1. – Yes I do.

Ofc. – Do you work in Buckeye?

AP1. – No, I'm retired.

Ofc. – From where?

AP1. – I worked for the Department of Corrections for twenty-seven years.

Ofc. – At what facility?

AP1. – A lot of them. Florence, Eyman and Lewis. I was a supervisor. I really fucked up; this is bad. You have no idea. Can I say something off the record?

Ofc. – Ok. You can, go ahead and tell me.

AP1. – I know Officer Jim Hill; he works with you guys ... and ... I'm running for the Governing Board for the colleges. I didn't even know this was one of your sites but now I see the signs all over in the parking lot.

I concluded my interview with AP1 and he thanked me for "being polite" and told me "I know you're just doing your job".

I notified my direct supervisor concerning my contact with AP1 and what he told me relating to claiming to know MCCC PD Officer Jim Hill and being a candidate for the Maricopa County Community Colleges District Governing Board.

I conducted a routine person check of AP1 which revealed no wants or warrants.

Based on my observances and AP1 Randy Gene Kaufman's admission to intentionally, knowingly and recklessly engaging in an act of sexual contact in an area where people (society/public) were present and could reasonably be alarmed or offended by the act I told him I would be citing him in lieu of detention for Public Sexual Indecency under A.R.S. 13-1403A1. AP1 told me he understood. I explained to AP1 the citation (#001810), court date/time, had him sign the document then provided him with a copy.

AP1 told me he is not an employee or student at Maricopa County Community Colleges. Because of this and his activity at Rio Salado College Surprise I told him that I would be issuing a No Trespass Order for site and returning could result in further police action. AP1 said he understood.

AP1 was released from the site and left the area.

This concludes this report.
