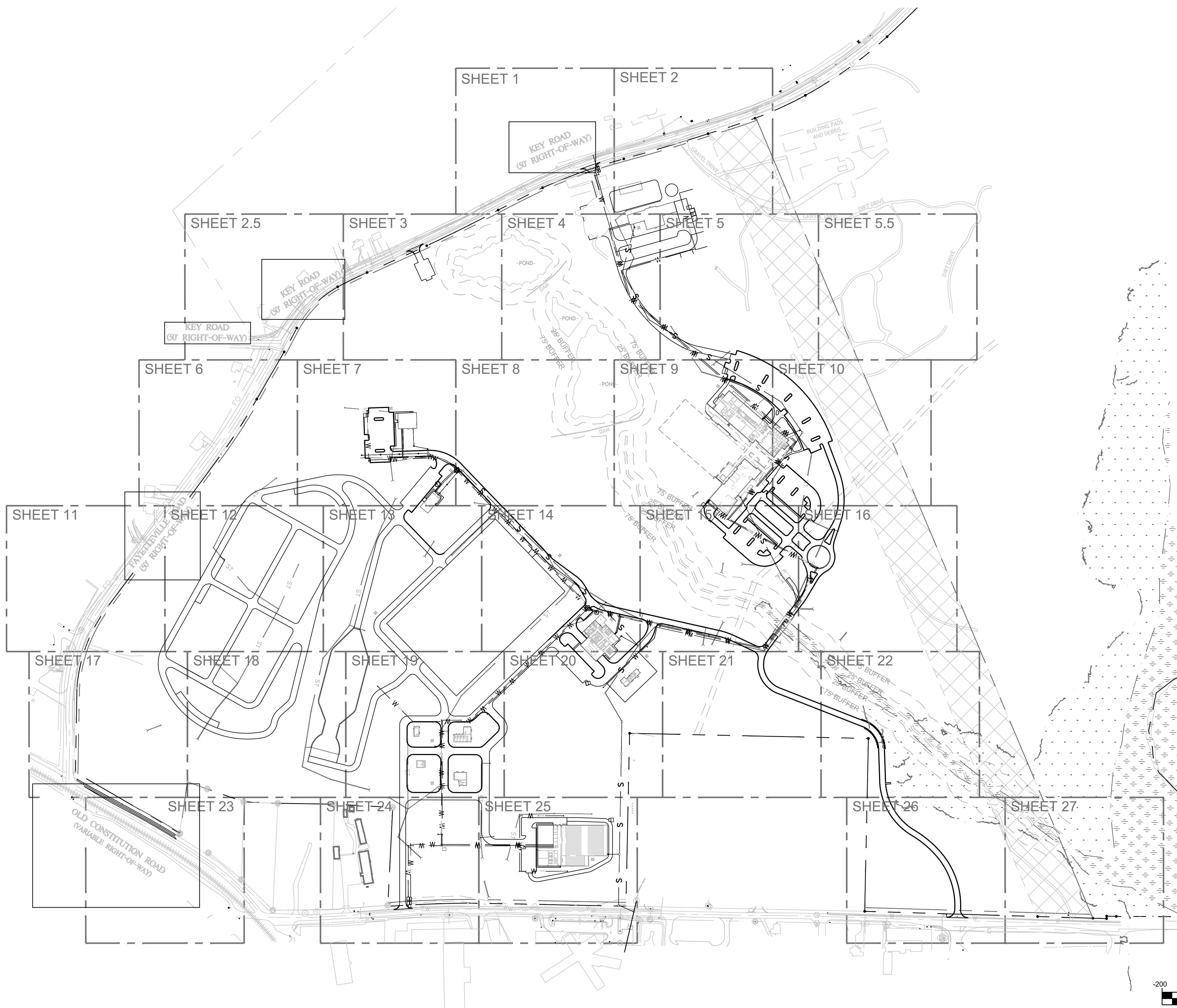


LOCATION MAP
