With this email, we address considerations to the FOIA component of your request. Representatives from the Commission's Privacy Office will follow-up under separate cover to address separate considerations related to the Privacy Act.

I, James Chelmowski ("Requestor"), am writing to appeal to Federal Communication Commission's ("FCC") response to Freedom of Information Act ("FOIA") and Privacy Act ("PA") request FCC 2021-000026 dated through FOIAonline on October 15, 2021 ("FOIA/PA Request") and February 11, 2020 ("FOIA/PA Request Response"). This FOIA/PA Appeal is also pursuant to FCC regulations and policy an FOIA Application for Review for a full Commissioner vote with the names of the Chairman and Commissioners names involved with this FOIA/PA Appeal/Application for Review "Commissioners Memorandum Opinion and Order."

The Requester WILL NOT CONSENT to any informal resolution² for this Application for Review to the Full Commission/FOIA/PA Appeal. As the Commission knows, note to paragraphs (i) & (j) 47 CFR 0.461³ requires the <u>Requester Consent</u> to informally resolve any Appeal/Application for Review ("Appeal/AFR") issues.

The FCC must provide a Commission Memorandum Opinion and Order addressing with legal authority of these four (4) arguments in this Application for Review and FOIA Appeal no later than February 11, 2021. Similar to my FOIA Appeal/AFR which the Commission finally complied with their mandatory duties on providing a Commission Memorandum Opinion and Order FCC 19-28 for the FOIA Appeal/AFR FCC-2019-086.

II. FCC FOIA Email

The Response email with no letter or signature stated the following:

III. Arguments

Argument #1 - FCC Attorney Brendan Email Does Not Comply FOIA Law and FCC Regulations

The FCC regulations 47 CFR 0.461 (m) Staff orders and letters ruling on requests for inspection are signed by the official (or officials) who give final approval of their contents. Decisions of the Commission ruling on applications for review will set forth the names of the Commissioners participating in the decision.

The FCC attorney Brendan McTaggart only provide an email no letter and no signature.

There was required signed letter ruling on this request. This is not a FOIA response by FCC regulations 47 CFR 0.461(m) or requirements in FOIA law.

See other Fee estimate signed letters in Exhibit 4.

See other Aggregating Response signed letters in Exhibit 5.

The FCC Chairman and Commissioner must provide the FCC regulations that an email is a signed letter response and meets ALL FCC FOIA requirements in the FCC regulations, directives, policies and procedures.

The Commissioners Memorandum Opinion Order must state why the FCC Chairman and Commissioners believe this email is a signed fee estimate letter within 20 days not including weekends and federal holidays.

Argument #2 - Fee Estimates Requires A Fee Estimate Amount

The Requester authorized up to \$25 in FOIA fees when he submitted this FOIA and Privacy Act Request.

The FCC provide no fee estimate amount. The FCC did state any amount greater than \$25 either.

This is not a Fee Estimate. See other FCC Fee Estimate Signed Letters in Exhibit 4.

This is clearly a Fraudulent Concealment scheme because as the Requester paid in Advance the FULL ESTIMATE in FCC-2019-171 because the responsive records would prove FCC corruption the FCC then demanded Unlimited Fees to make sure the FCC could fraudulently conceal the records the FCC needed to conceal their corruption no matter how much the Requester authorized or paid.

The FCC Chairman and Chairman must show the LEGALITY and LEGAL Authority of this NEW Fee Demands with no Fee Estimated Fee amount.

Argument #3 - FCC Cannot Demand Specific Language and Parameters in Fee Authorization.

FOIA law only requires the Requester state a maximum Fee amount they authorized which the Requester put on FOIAonline \$25. FOIAonline did not require any other language.

FCC cannot demand specific language and Specific Parameters apparently using threats and intimidations like the FCC and attorney McTaggart stated:

Accordingly, please let us know by reply email within two weeks from the date of this message (by November 6, 2020) if you wish to authorize additional fees to resume the search for responsive documents previously begun and if you authorize the FCC to complete the processing of your aggregated requests. You must unambiguously state that you authorize additional fees and specify the amount of fees you authorize.

To ensure receipt, please send your fee authorization to myself and to Stephanie Kost, copied on this email message. If we do not receive a response from you that meets these parameters by November 6, 2020, we will assume that you do not authorize additional fees and that you no longer seek responsive documents, and we will close FOIA 2021-000026.

The FCC Chairman and Commissioners decision must provide legal authority to demand specific language and parameters. Instead of just a simple maximum amount you authorize per FOIA law and FOIAonline.

The FCC Chairman and Commissioner must also prove this email was not the FCC use of threats and intimidation.

<u>Argument #4 – FCC Cannot Demand a FOIA Requester to RE-Open a FOIA Request that was closed,</u> and an Appeal was Filed with the FCC

The FCC attorney demanded that the Requester re-open FOIA/PA FOIA FCC-2019-000171 after he paid the FULL FEE Estimate through USPS. See Exhibit 7

The FCC closed this FOIA Request with final disposition of Partial Grant / Partial Denial on FOIAonline on March 29, 2019. See Exhibit 8.

The Requester Appealed this Request on or about June 26, 2019. See Exhibit 9. With the following Arguments:

- Argument 1 Inadequate Search and/or Responsive Records being Wrongfully/Improperly Withheld.
- Argument 2 FCC Cannot Charge Search Fees for Records Related to the Requester.
- Argument 3 FCC Cannot Charge Search Fees for Records after Failure to Comply with All Deadlines.
- Argument 4 FCC and the Commission Cannot Use Threats, Intimidation and/or Extortion to Use Only FCC demanded Language in the Requester's Response to the FCC to Deny a Requester's Rights.
- Argument 5. FCC Wrongfully Alleged Combining FOIA/PA Requests to Deny Requesters Rights and Inflated Illegal Search Fees.
- Argument 6. FCC Must Conduct Searches the Most Efficient Way.

The FCC dismissed the Appeal with addressing any of the Application For Review or Appeal Arguments with a Final Disposition of Improper Request for Other Reasons on or about July 22, 2019.

The FCC, FCC Chairman and Commissioners needs to provide Legal Authority for these actions and demands.

IV. Conclusion

The burden of proof is on the defendant agency, which must justify its decision to withhold any information. See 5 USC § 552(a)(4)(B); *Solar Sources, Inc. v. United States*, 142 F.3d 1033, 1037 (7th Cir. 1998)

This is not a duplicate argument the FCC Commission that already made an Appeal/Application for Review to the Full Commission determination in any my prior Appeal/AFR's.

<u>Argument #1 - FCC Attorney Brendan Email Does Not Comply FOIA Law and FCC Regulations</u>
Argument #2 - Fee Estimates Requires A Fee Estimate Amount

The FCC Chairman and Commissioners must comply with their mandatory duties and make their Appeal/Application for Review decision on these four (4) arguments in this FOIA/PA request Appeal/Application for review by February 11, 2021.

The FCC Chairman and Commissioners finally complied with their mandatory duties for the first time on April 4, 2019, in providing a Memorandum Opinion and Order 19-28. Through omission, negligence and/or willful conduct, the FCC and Commission did not provide Memorandum Opinion and Orders for all my other Ten (10) Appeal/AFRs filed prior to this FOIA Appeal / Application for Review, which were their mandatory duties by federal laws, regulations, directives, policy and/or procedures.

THIS REQUESTER <u>WILL NOT CONSENT</u> TO THE FCC GENERAL COUNSEL OR ANYONE ELSE TO INFORMALLY RESOLVING THIS FOIA APPEAL/APPLICATION FOR REVIEW TO THE FULL COMMISSION.

The FCC and FCC Commissioners deadlines by law, regulations and directives of 20 days (excepting Saturdays, Sundays, and legal public holidays for an Appeal/AFR DETERMINATION pursuant to FOIA 5 USC 552(a)(6) with determination by an FCC Memorandum Opinion and Order by the Commissioners pursuant to 47 CFR 0.461 and FCC FOIA Directive 1179.3. No later than February 11, 2021, to comply with the written Determination and Commissioners Memorandum Opinion and Order.

Mr. Chelmowski:

By this letter, we respond to your Application for Review (AFR) dated January 14, 2021, appealing the agency's processing of your request, assigned FOIA 2021-000026, filed under both the Privacy Act and the Freedom of Information Act (FOIA). Through this request you sought "records relating to James Chelmowski," and more specifically "all communications and federal records regarding all details of the FOIA and Privacy Act searches [filed by you,] [i]ncluding but not limited to FCC federal records that show the assignment of searches, the federal records of who performed the searches, all actual search details[,] [i]ncluding but not limited to search terms, search location, records found, number of records found, etc."

Our initial October 23, 2020 response addressed the FOIA component of your request, aggregating it with a number of your previous FOIA requests also seeking records about yourself, and requesting your authorization of additional fees and in a specific amount.³ We closed your request after you failed to respond to our October 23, 2020 email or authorize any additional fees.

In your AFR, you raise several arguments. First, you state that the October 23, 2020 email to you, to the extent that it is considered a staff order or ruling, did not comport with section 0.461(m) of the Commission's rules which requires such orders or letters to be signed by the official (or officials) who provided final approval of the content contained therein. You also argue that the agency must provide a specific estimated fee amount, and that the agency may not require authorization of additional fees over the \$25 you authorized at filing. Finally, you state that aggregation with FOIA

of your request were subsequently assigned control number FOIA 2021-000039.

³ *See* Email from Brendan McTaggart, Office of General Counsel, FCC to James Chelmowski (Oct. 23, 2020 11:44am EDT).

2019-000171, which was processed in part and closed for failure to authorize additional fees, was improper.⁴

In response to your AFR, we reinstate FOIA 2021-000026 and consistent with your status as an "all other requester," we afford you two hours of free search time. We also provide an estimate of the additional fees, if any, required to complete the processing of FOIA 2021-000026. With respect to fees, based upon discussions with Commission staff within the Office of the Managing Director, we expect that the search for records in FOIA 2021-000026 can be accomplished within the two hours afforded to "all other requesters" under the Commission's rules and that any records yielded can be transmitted electronically.

As such, we do not anticipate that you will incur any fees in connection with FOIA 2021-000026 as currently constructed. To the extent that the search for these records takes more than two hours, we would undertake additional searches consistent with the search fees you authorize, including the \$25 authorized initially.

We note that unlike previous fee estimates provided to you which were based on the searches of individual custodians, this estimate was based on an automated search undertaken by the Commission's Information Technology (IT) staff. The Commission currently has limited resources in which to undertake such automated searches. In this particular case, in light of the fact that several of the custodians who likely would have responsive records are no longer employed by the agency, we determined that employing limited IT resources was justified and the only means to effectuate a reasonable search.

We further note that with respect to FOIA 2021-000026, IT has indicated that a Commission-wide search for emails mentioning "Chelmowski" alone yielded more than 97,000 results. We believe the time and resources required for staff to review and process this volume of records likely poses an undue burden on the Commission. Accordingly, we ask that, within 30 days from the date of this letter, you indicate whether you remain interested in pursuing this FOIA request as well as your willingness to narrow the scope of your current request so that it can be processed without posing an undue burden on the agency's resources. Please contact Christopher Santini (christopher.santini@fcc.gov) in the Office of General Counsel to facilitate further discussion on this matter.

By taking these actions and issuing this letter, your AFR is moot. Accordingly, we dismiss your AFR under section 0.251(j) of the Commission's rules.⁶ As stated, FOIA 2021-000026 is now reinstated, pending further input as requested above.

This letter responds to your Freedom of Information Act (FOIA) request for, "all the FCC FOIA consultants and referrals to or from the FCC regarding this [r]equester James Chelmowski provide all communications, the FOIAonline records, and control numbers. These referrals and consultants [sic] including but not limited ones documented from other agencies to the FCC include NARA-NGC-2016-000555, NARA-NGC-2017-000437, NARA-NGC-2018-000455, NARA-NGC-2018-000508, EPA-HQ-2017-005390, EPA-HQ-2017-008255, EPA-HQ-2017-008256, EPA-HQ-2018-007088, EPA-HQ-2019-000357, EPA-2020-006388, ..." Your request has been assigned FOIA Control No. 2021-000341.

The Office of the Managing Director conducted a search and located four pages responsive to your request. Some material on the pages produced has been redacted due to the reasons discussed below. Records responsive to your request were withheld or redacted under FOIA Exemption 5.² Exemption 5 protects certain inter-agency and intra-agency records that are normally considered privileged in the civil discovery context. Exemption 5 encompasses a deliberative process privilege intended to "prevent injury to the quality of agency decisions." To fall within the scope of this privilege the agency records must be both predecisional and deliberative. Predecisional records must have been "prepared in order to assist an agency decision maker in arriving at his decision." Deliberative records must be such that their disclosure "would expose an agency's decisionmaking process in such a way as to discourage candid discussion within the agency and thereby undermine the agency's

We are required by both the FOIA and the Commission's own rules to charge requesters certain fees associated with the costs of searching for, reviewing, and duplicating the sought after information.⁷ To calculate the appropriate fee, requesters are classified as: (1) commercial use requesters; (2) educational requesters, non-commercial scientific organizations, or representatives of the news media; or (3) all other requesters.⁸

Pursuant to section 0.466(a)(8) of the Commission's rules, you have been classified for fee purposes under category (3) as an "all other requester." As an "all other requester," the Commission assesses charges to recover the full, reasonable direct cost of searching for and reproducing records that are responsive to the request; however, you are entitled to be furnished with the first 100 pages of reproduction and the first two hours of search time without charge under section 0.470(a)(3)(i) of the Commission's rules. The production in response to your request required less than two hours of search time, and was provided in electronic form. Therefore, you will not be charged any fees.

If you consider this to be a denial of your FOIA request, you may seek review by filing an application for review with the Office of General Counsel. An application for review must be *received* by the Commission within 90 calendar days of the date of this letter. You may file an application for review by mailing the application to Federal Communications Commission, Office of General Counsel, 45 L Street NE, Washington, DC 20554, or you may file your application for review electronically by e-mailing it to FOIA-Appeal@fcc.gov. Please caption the envelope (or subject line, if via e-mail) and the application itself as "Review of Freedom of Information Action."

This FOIA Appeal is also pursuant to FCC regulations and policy an FOIA Application for Review for a full Commissioner vote with the names of the Chairman and Commissioners names involved with this FOIA/PA Appeal/Application for Review "Commissioners Memorandum Opinion and Order."

The Requester WILL NOT CONSENT to any informal resolution² for this Application for Review to the Full Commission/FOIA/PA Appeal. As the Commission knows, note to paragraphs (i) & (j) 47 CFR 0.461³ requires the **Requester Consent** to informally resolve any Appeal/Application for Review ("Appeal/AFR") issues.

I. The FOIA/PA Request

The FOIA request was filed on March 23, 2021, which included the following:

This is an FOIA and Privacy Act request pursuant to 5 USC 552 and 5 USC 552a request for records regarding the Request for the following:

Provide all the FCC FOIA consultants and referrals to or from the FCC regarding this Requester James Chelmowski provide all communications, the FOIAonline records, and control numbers. These referrals and consultants including but not limited ones documented from other agencies to the FCC include NARA-NGC-2016-000555, NARA-NGC-2017-000437, NARA-NGC-2018-000455, NARA-NGC-2018-000508, EPA-HQ-2017-005390, EPA-HQ-2017-008255, EPA-HQ2017-008256, EPA-HQ-2018-007088, EPA-HQ-2019-000357, EPA-2020-006388, ...

The FCC is required to document and have control numbers for each incoming FOIA consultant and referral

requests from other agencies. Other agencies are required to document and have control numbers for each outgoing FOIA consultant and referral requests from the FCC.

FCC policy and procedures state:

Procedures Upon Receipt of a Referral:

When the FCC receives a referral of documents from another agency, the following steps should be taken to ensure efficiency and accountability.

- (1) Assign the FCC's FOIA tracking number to the referral so that it can be readily tracked.
- (2) Send the FOIA requester an acknowledgment of receipt of the referral and identify the agency that made the referral, subject to the exceptions described below for coordinating a response.
- (3) Include in the acknowledgement both the FCC's FOIA tracking number and the original FOIA request tracking number assigned by the agency making the referral so that the requester can readily link the referred records to his or her original request.
- (4) Provide the FOIA requester with a telephone line or internet service contact information that can be used to obtain information about the status of the referred records.
- (5) Track the referral just as you would an incoming request and include it in the FCC's Annual FOIA Report.
- (6) Always include the original request number from the referring agency as well as our own referral number in any correspondence with the requester regarding the referred documents.
- (7) The referring agency should receive a copy of the response to the requester as appropriate.

Procedures Upon Receipt of a Consultation:

Whenever the FCC receives a consultation request from another agency, it should be mindful of the need to respond as promptly as practicable to the consultation to facilitate the other agency's ability to finalize its response to the request. To ensure greater accountability for the handling of consultations, the Department of Justice created a requirement that agencies include data in their Annual FOIA Reports each year regarding any consultations that they receive. Agencies must report in Section XII of their Annual FOIA Reports the number of consultations received, the number processed, and the number of consultations remaining pending at the end of the fiscal year, including the dates the ten oldest pending consults were received and the number of days those ten oldest consultations have been pending.

Upon receipt of a consultation, agencies should take the following steps:

- 1. The referring agency should receive a copy of the response to the requester as appropriate.
- 2. Assign the consultation a tracking number to facilitate its handling and inclusion in the FCC Annual FOIA Report.
- 3. Promptly provide the FCC's views on the disclosability of the contents of the records to the agency seeking the consultation. Utilize the most time- efficient method for doing so.
- 4. Continuously assess the need and frequency of the consultations so that the FCC can identify ways to streamline or eliminate the need for certain consultations.

Expedition needed.

The Requester will be making these responsive records public records to inform the Public on how the FCC who regulates 1/6 of the economy should be transparent and show its work on how the FCC is performing their mandatory duties pursuant to federal laws, directives, policies, and procedures.

This response will be presented to the Public because:

The former FCC Chairman and current FCC Chairwoman knows the FCC is not transparent in FOIA.

The current Chairwoman Jessica Rosenworcel stated in FCC 18-156 order the following:

The former FCC Chairman Ajit Pai stated in FCC 18-156 order the following:

"[T]hat an agency that regulates one-sixth of the economy should be transparent and 'show its work'"

"In the nearly half-decade preceding this Administration, there arose many, many chances to join what should have been a bipartisan effort to promote openness and transparency at the FCC."

The NARA produced a similar request for expediated in 2017 as an expedited request control # NARA-NGC-2017-000437.

There should be no reason the NARA will not grant this Expediated request see the same expediated request as the one the NARA granted on April 7, 2017. This request falls in both categories #2 and #3 because it is urgent to inform the public about an actual or alleged Federal government activity. and a reasonable expectation of an imminent loss of a substantial due process. This information could expose a cover-up scheme in a delayed FOIA administrative appeal needed in an FOIA lawsuit. That a District court judge and the PUBLIC needs to be aware of immediately and any delay would be an imminent loss of a substantial due process in the FOIA lawsuit proceeding.

II. FCC Denied Expediating

The FCC denied the Expediating on March 30, 2021.

III. FCC Due Date For this Request

The FCC refused to comply with the FOIA deadline. The FCC two page response and four (4) pages of random non-responsive emails could have been produced on April 21, 2021 deadline.

The FCC, Chairwoman, Commissioners, General Counsel, attorneys and staff negligently and/or fraudulently concealed this response and responsive records so Chelmowski would not have access of material facts needed in Chelmowski's filings to Honorable Judge James Boasberg on April 22, 2021 in DDC 1:17cv1394 *Chelmowski v USA*, FCC, EPA and NARA.

IV. FCC FOIA Response

On May 20, 2021, the FCC provided a 29 day past due response for FOIA FCC-2021-000341 response with 4 pages of FCC emails with the bodies of the emails completely redacted that had nothing to do with FOIA referrals or consultants.

FCC FOIAonline records stated the final disposition was <u>Partial Grant/Partial Denial</u> and the FCC closed the FOIA request FCC-2021-000341 on May 21, 2021. The Response letter stated the following:

[&]quot;What is the Federal Communications Commission hiding?"

[&]quot;Something here is rotten—and it's time for the FCC to come clean."

[&]quot;It is hiding what it knows about the fraud in our record and it is preventing an honest account of its many problems from seeing the light of day."

The Office of the Managing Director conducted a search and located four pages responsive to your request. Some material on the pages produced has been redacted due to the reasons discussed below. Records responsive to your request were withheld or redacted under FOIA Exemption 5.

V. Arguments

<u>Argument 1 - Inadequate Search and/or Responsive Records being Wrongfully/Improperly Withheld.</u>

The FOIA search was inadequate and/or the FCC withholding in Full Responsive Records.

The EPA and NARA produced emails through District Court order in DDC 17cv1394 Chelmowski v USA, FCC, EPA and NARA of multiple FOIA referrals and consultants with the FCC from the EPA and NARA including the following:

These referrals and consultants including but not limited ones documented from other agencies to the FCC include NARA-NGC-2016-000555, NARA-NGC-2017-000437, NARA-NGC-2018-000455, NARA-NGC-2018-000508, EPA-HQ-2017-005390, EPA-HQ-2017-008255, EPA-HQ2017-008256, EPA-HQ-2018-007088, EPA-HQ-2019-000357, EPA-2020-006388, ...

Of course, Agencies have mandatory duties pursuant, to federal laws, regulations, OMB, directives, policies, and procedure when a request is both FOIA and PA or if the individual asks for "all information about me" or similar language in the request.

The burden of proof is on the defendant agency, which must justify its decision to withhold any information. See 5 USC § 552(a)(4)(B); *Solar Sources, Inc. v. United States*, 142 F.3d 1033, 1037 (7th Cir. 1998)

This is not a duplicate argument the FCC Commission that already made an Appeal/Application for Review to the Full Commission determination in any my prior Appeal/AFR's.

Argument 2 – FCC is fraudulently concealing these FOIA and Privacy Act Responsive Records because these records will IMPEACH the FCC. NARA and EPA statements under the Penalty of Perjury to Honorable Judge Boasberg in DDC 17cv1394

The FCC refused to comply with the FOIA deadline. The FCC two-page response and four (4) pages of random non-responsive emails could have been produced on April 21, 2021 deadline.

The FCC, Chairwoman, Commissioners, General Counsel, attorneys and staff negligently and/or fraudulently concealed this response and responsive records so Chelmowski would not have access of material facts needed in Chelmowski's filings to Honorable Judge James Boasberg on April 22, 2021 in DDC 1:17cv1394 *Chelmowski v USA*, FCC, EPA and NARA.

This letter dismisses your application for review (AFR)¹ filed in connection with the abovereferenced Freedom of Information Act (FOIA) request.² Your FOIA request sought "all the FCC FOIA consultants [sic] and referrals to or from the FCC regarding this [r]equester James Chelmowski provide all communications, the FOIAonline records, and control numbers. These referrals and consultants [sic] including but not limited ones documented from other agencies to the FCC include NARA-NGC2016-000555, NARA-NGC-2017-000437, NARA-NGC-2018-000455, NARA-NGC-2018-000508, EPA-HQ-2017-005390, EPA-HQ-2017-008255, EPA-HQ-2017-008256, EPA-HQ-2018-007088, EPA-HQ-2019-000357, EPA-2020-006388, ... "3 In response to your request, the Federal Communications Commission (FCC or Commission) Office of the Managing Director (OMD) searched for records responsive to your request, disclosing four pages of records on May 20, 2021 in addition to providing a narrative response. In this narrative response, OMD explained that portions of the responsive records, consisting of deliberative communications between the FCC and National Archives and Records Administration (NARA) employees and management in connection with a FOIA request being processed by NARA, were redacted under the deliberative process privilege, as applied pursuant to FOIA Exemption 5, and provided the underlying rationale for doing so.⁴

Your AFR asserts that the FCC conducted an inadequate search and improperly withheld responsive records.⁵ The AFR also states that the Commission is concealing responsive records and could have issued the FOIA response within the statutory timeframe.⁶

We dismiss your AFR because it raises no specific arguments that warrant the Commission's review of OMD's decision. The AFR offers no support or explanation for its assertions that OMD's search was inadequate and that the Commission is improperly withholding responsive records.⁷ As the FOIA response previously indicated, OMD disclosed all responsive records and withheld none in full. The statement regarding the timing of the FOIA response is similarly conclusory and provides no basis for review. Accordingly, we dismiss your AFR under section 0.251(j) of the Commission's rules for failure to articulate specific grounds for review.⁸

Pursuant to 5 U.S.C. § 552(a)(6)(A)(ii), we notify you of the provisions for judicial review under paragraph (a)(4) of the Freedom of Information Act. We note that as part of the Open Government Act of 2007, the Office of Government Information Services (OGIS) was created to offer mediation services to resolve disputes between FOIA requesters and Federal agencies as a non-exclusive alternative to litigation.
