UNITS RESPONDED TO 140 EAST 60 STREET IN REFERENCE TO AN ASSAULT. UPON ARRIVAL VIC 1 STATED THAT HE WAS WALKING AROUND THE NEIGHBORHOOD HANDING OUT FLIERS WHEN HE CAME ACROSS THE DEFENDANT WHO WAS BLOCKING THE SIDEWALK. DEFENDANT CONFRONTED THE VIC AND STATED THAT HE COULD NOT PASS THROUGH THE SIDEWALK IN FRONT OF HIS RESIDENCE. VIC PROCEEDED TO WALK TOWARDS THE STREET TO AVOID THE DEFENDANT AT WHICH POINT THE DEFENDANT STATED TO THE VIC " YOU CAN'T PASS BY HERE THIS IS MY NEIGHBORHOOD" VIC THEN STATED TO THE DEFENDANT " THIS IS PUBLIC PROPERTY AND I CAN BE HERE IF I WANT TO. POINT ANOTHER SUBJECT WHO FLED THE SCENE PRIOR TO POLICE ARRIVAL KICKED THE DEFENDANT ON THE RIGHT SIDE OF HIS FACE. KENYON INCIDENT NUMBER 202229857 RESPONDED TO THE SCENE TO TREAT VIC INJURIES.
