Officials to cite Biden-Harris administration's commitment to creating good-paying, union jobs

WASHINGTON – Secretary of Labor Marty Walsh will visit the Madison, Wisconsin area on Wednesday, Oct. 26 to discuss the value of workforce training in strengthening the nation's economy.

Secretary Walsh will join Sen. Tammy Baldwin and Rep. Mark Pocan at the recently expanded Laborers Apprenticeship and Training Center in DeForest to highlight the Biden-Harris administration's commitment to reducing costs for American families and creating good-paying, union jobs through the investments from the Bipartisan Infrastructure Law, Inflation Reduction Act, and the CHIPS and Science Act.

Operated by the Wisconsin Laborers District Council of the Labor International Union of North America, the center has eight classrooms and four training bays for hands-on learning, where the officials will see laborers perform work in concrete, demolition, scaffolding, surveying, grading, sewer and water, pipe fusing, welding, small engine, asbestos abatement and environmental remediation.

Secretary Walsh, Sen. Baldwin, and Rep. Pocan will have media availability at the end of the tour.
