any law enforcement or correctional agency for law	
enforcement purposes, but only to the extent that	
disclosure would: (i) interfere with pending or actually	
and reasonably contemplated law enforcement	
proceedings conducted by any law enforcement or	
correctional agency that is the recipient of the request; (ii)	
interfere with active administrative enforcement	
proceedings by the City (vii) obstruct an ongoing criminal	
investigation by the agency that is the recipient of the	
request. "Disclosure of the records requested will also	
create a substantial likelihood that the individual charged	
with the criminal offenses will be deprived of a fair trial.	

Therefore, the requested records are exempt from disclosure pursuant to section 7(1)(d)(iii). (iii) create a substantial likelihood that a person will be deprived of a fair trial or an impartial hearing; Rule 3.6 (a) of the Illinois Rule of Professional Conduct states the following: Rule 3.6: Trial Publicity (a) A lawyer who is participating or has participated in the investigation or litigation of a matter shall not make an extra judicial statement that the lawyer knows or reasonably should know will be disseminated by means of public communication and would pose a serious and imminent threat to the fairness of an adjudicative proceeding in the matter. In the comments section for the Rule, the following is provided for clarification: [5] There are, on the other hand certain subjects that would pose a serious and imminent threat to the fairness of a proceeding, particularly when they refer to a civil matter triable to a jury a criminal matter, or any other proceeding that would result in incarceration. These subjects related to [5] information that the lawyer knows or reasonably should know is likely to be inadmissible as evidence in a trial and that would, if disclosed, create a substantial risk of prejudicing an impartial trial; Rule 3.8(f) of the Illinois Rules of Professional Conduct states the following: Rule 3.8: Special Responsibilities of a Prosecutor – The duty of a public prosecutor is to seek justice not merely to convict. The prosecutor in a criminal case shall: (f) except for statements that are necessary to inform the public of the nature and extent of the prosecutor's action and that service a legitimate law enforcement purpose, refrain from making extrajudicial comments that pose a serious and imminent threat of heightening public condemnation of the accused and exercise reasonable care to prevent investigators, law enforcement personnel, employees or other persons assisting or associated with the prosecutor in a criminal case from making an extrajudicial statement that the prosecutor would be prohibited from making under Rule 3.6 or this Rule. In the comments section for the Rule, the following is provided for clarification: [6] Like other lawyers, prosecutors are subject to Rules 5.1 and 5.3, which relate to responsibilities regarding lawyers and nonlawyers who work for or are associated with the lawyer's office. Paragraph (f) reminds the prosecutor of the importance of these obligations in connection with the unique dangers of improper extrajudicial statements in a criminal case. In addition, paragraph [f] requires a

prosecutor to exercise reasonable care to prevent persons assisting or associated with the prosecutor from making improper extrajudicial statements, even when such persons are not under the direct supervision of the prosecutor. Ordinarily the reasonable care standard will be satisfied if the prosecutor issues the appropriate cautions to law enforcement personnel and other relevant individuals. Therefore, as demonstrated by the comments to the Rule, the police department is also equally bound by the prosecutor's ethical obligations. :

9. Justification for Denial

Your Request is being denied or partially denied with respect to the Specified Records because the Specified Records are exempt from disclosure pursuant to the Illinois Freedom of Information Act for the following reason or reasons (references are to sections of the Act):

The Specified Records are neither prepared by or for the City, nor have the Specified Records been or are being used by, or received by, the City. § 1, § 2(c)

The Specified Records are not within the City's possession or control, nor are the Specified Records related to a governmental function and in the possession of a party with whom the City has contracted to perform that governmental function on behalf of the City. 1, 2(c), 7(2)

The Specified Records are Chronologically maintained arrest or criminal history information, the disclosure of which would interfere with pending

or actually and reasonably contemplated law enforcement proceedings. $\S 2.15(c)$

- The Specified Records are Chronologically maintained arrest or criminal history information, the disclosure of which would endanger the life or physical safety of any person. § 2.15(c)
- The Specified Records are Chronologically maintained arrest or criminal history information, the disclosure of which would compromise the security of a correctional facility. § 2.15(c)
