Re: **Freedom of Information Act Appeal, Request No. EPA-R4-2014-008895**

Dear National FOIA Officer:

Please accept this appeal of the September 9, 2014 response by the U.S. Environmental Protection Agency's ("EPA"), Region 4 ("Response"), to the above-referenced information request under the Freedom of Information Act, 5 U.S.C. § 552 ("FOIA"), and EPA's FOIA regulations at 40 C.F.R. Part 2 (hereinafter, the "FOIA Request"). This FOIA request was, and this FOIA appeal is hereby, submitted by my firm on behalf of our client, Drummond Company, Inc., and its subsidiary, ABC Coke. While we appreciate the EPA's response to the FOIA Request to date, we are respectfully appealing EPA's decision to withhold certain documents and portions of documents, under the claim by EPA that such information is not subject to disclosure under FOIA.

Specifically, we are appealing EPA's claims in its Response that certain of its responsive records, and portions of records, are not subject to release by virtue of FOIA Exemption 5, 5 U.S.C. § 552(b)(5), which exempts from mandatory disclosure "inter-agency or intra-agency memorandums or letters which would not be available by law to a party other than an agency in litigation with the agency." As EPA's Response infers, Exemption 5 encompasses various privileges similar to those in the civil discovery context; however, such privileges do not all necessarily apply to the same types of agency records. Because of this, courts have determined that in order to "justify nondisclosure under Exemption 5, an agency must show that the type of material it seeks to withhold is generally protected in civil discovery for reasons similar to those asserted by the agency in the FOIA context." Burka v. DHHS, 87 F.3d 508, 517 (D.C. Cir. 1996). Moreover, it is a well-established FOIA principal that it is the agency's burden to establish that withheld information falls within a FOIA exemption. See, e.g., Abraham & Rose, P.L.C. v. United States, 138 F.2d 1075, 1078 (6th Cir. 1998); GC Micro Corp. v. Defense Logistics Agency, 33 F.3d 1109, 1113 (9th Cir. 1994); Church of Scientology International v. U.S. Dept. of Justice, 30 F.3d 224, 228 (1st Cir. 1994); Lewis v. IRS, 823 F.2d 375, 378 (9th Cir.1987).

While EPA cites Exemption 5 repeatedly in its index of withheld records produced along with its Response, EPA does not indicate which privilege it claims applies to the specific document being

withheld. To the extent Exemption 5 is being invoked for purposes of protecting attorney-client communications, attorney work product, deliberative process, or other privilege, that privilege must be invoked in order for a FOIA requester to determine the reason(s) why its requested information is being withheld. This is particularly important in this situation because many of the documents that EPA may be withholding pursuant to the deliberative process privilege are likely to no longer qualify for such privilege now that EPA "has finalized the preliminary assessment/site investigation phase of the Superfund remedial process[.]" See Response at 1. As stated in the Response, this FOIA request, and EPA's response thereto, pertain only to that phase of its actions relating to the 35th Avenue site. Indeed, EPA has already completed its decision as to whether or not the 35th Avenue Site should be listed on the National Priorities List. See 79 Fed. Reg. 56,538 (Sept. 22, 2014). Invocation of the deliberative process privilege requires that the agency information sought to be protected be both "predecisional" as well as "deliberative." Thus, in order to qualify for the deliberative process privilege, an agency record must be "antecedent to the adoption of an agency policy," Ancient Coin Collectors Guild v. U.S. Dep't of State, 641 F.3d 504, 513 (D.C. Cir. 2011), as well as "a direct part of the deliberative process in that it makes recommendations or expresses opinions on legal or policy matters." Vaughn v. Rosen, 523 F.2d 1136, 1143-44 (D.C. Cir. 1975). And, as stated generally above, because it is the agency's burden to establish the applicability of any asserted exemption, EPA must establish that both elements are met in order to invoke the deliberative process privilege. See ACLU v. DOJ, 655 F.3d 1, 5 (D.C. Cir. 2011) (noting that burden is upon agency to demonstrate that withheld documents are exempt from disclosure).

Thus, because EPA has not indicated its basis or bases for claiming Exemption 5 for any of the withheld documents labeled as being withheld thereunder, and because there is a likelihood that at least one Exemption 5 privilege (deliberative process) is inapplicable to many or all of these records due to EPA's completion of the decisionmaking process directly associated with the FOIA Request, I respectfully appeal any and all decisions by EPA to withhold responsive records pursuant to Exemption 5, as indicated by EPA's index of withheld records, entitled "Confidential Site Documents with Comments (Sorted by Doc Date)."¹ A copy of EPA's Response is attached for your reference as Attachment 1, and the referenced index of withheld records is attached for your reference as Attachment 2.

Dear Mr. Simpson:

This letter is in response to your Freedom of Information Act (FOIA) request regarding the 35th Avenue Superfund Site in Birmingham, Jefferson County, Alabama.

Currently, the Superfund Remedial Division has advised us the site has finalized the preliminary assessment/site investigation phase of the Superfund remedial process, which involves gathering historical and other available information about site conditions to evaluate whether the site poses a threat to human health and the environment and/or whether further investigation is needed. Information about the site collected in the preliminary assessment phase helps the EPA to evaluate the risk posed by the site using the Hazardous Ranking System (HRS). Enclosed is information regarding the Superfund remedial process.

For purposes of FOIA, the completion of the preliminary assessment and the site investigation mark the completion of our incremental responses for the Site. To date, we have provided you all the documents provided to us by the Superfund Division through the Superfund Document Management System (SDMS). Enclosed please find the index that lists the complete set of documents provided in response to your FOIA request (to include new documents as annotated). Additionally, upon review of the record with an eye toward disclosure, we are unable to provide you with the documents or portions of documents which have been determined to be exempt from mandatory disclosure by virtue of 5 U.S.C. §§ 552 (b)(4), (b)(5), (b)(6) and (b)(7)(C) of the FOIA. An index of exempt records is enclosed.

Pursuant to your conversation with Ms. Gayla Uslu on August 15, 2014, you agreed to accept the enclosed indices and documents to evaluate and determine if they satisfy your request regarding activities at the site since its establishment in 2011, through the completion of the preliminary assessment. Ms. Uslu will work with you to submit a new request for new records available for the next phase of the Superfund process, which is the National Priority Listing (NPL) process.

Exemption 4 of the FOIA permits the withholding of trade secrets and commercial or financial information obtained from a person that is privileged or confidential. Class Determination I-95, a copy of which is enclosed, covers certain business information submitted by contractors and prospective contractors during the course of business. Such documents include contract proposals, awarded contracts and contract modifications, invoices, accounting and financial reports, and any array of other documents that track the contracting process.

Exemption 5 of the FOIA protects “inter-agency or intra-agency memorandums or letters which would not be available by law to a party other than an agency in litigation with the agency.” Courts have construed this somewhat opaque language to “exempt those documents, and only those documents that are normally privileged in the civil discovery context.” The most commonly invoked privilege incorporated within Exemption 5 is the deliberative process privilege, the general purpose of which is to “prevent injury to the quality of agency decisions.” Specifically, three policy purposes consistently have been held to constitute the basis for the privilege: (1) to encourage open, frank discussions on matters of policy between subordinates and superiors; (2) to protect against premature disclosure of proposed policies before they are actually adopted; and (3) to protect against public confusion that might result from disclosure of reasons and rationales that were not in fact ultimately the grounds for an agency’s action.

Exemption 6 of the FOIA permits the withholding of all information about individuals in “personnel, medical and similar files” when the disclosure of such information “would constitute a clearly unwarranted invasion of personal privacy.” Likewise, Exemption 7(C) of the FOIA protects from disclosure “records or information compiled for law enforcement purposes, but only to the extent that the production of such law enforcement records or information could reasonably be expected to constitute an unwarranted invasion of personal privacy.”

Under the FOIA, you may appeal this partial denial to the National Freedom of Information Officer, U.S. EPA, FOIA and Privacy Branch, 1200 Pennsylvania Avenue, N.W. (2822T), Washington, D.C. 20460 (U.S. Postal Service Only) or Email: hq.foia@epa.gov. Only items mailed through the United States Postal Service may be delivered to 1200 Pennsylvania Avenue, N.W. If you are submitting your appeal via hand delivery, courier service or overnight delivery, you must address your correspondence to 1301 Constitution Avenue, N.W., Room 6416J, Washington, D.C. 20004. Your appeal must be made in writing, and it must be submitted no later than 30 calendar days from the date of this letter. The Agency will not consider appeals received after the 30 calendar day limit. The appeal letter should include the FOI number listed above. For quickest possible handling, the appeal letter and its envelope should be marked “Freedom of Information Act Appeal.”
