NORMAL FLOW OF BUSINESS.

WHEN THE SECURITY STAFFED TOLD THE DEF HE COULD NOT DO THIS HE CONTINUED HIS BEHAVIOR AND AT ONE POINT INTENTIONALLY THREW WATER AT A STAFF MEMBER. ONCE OFFICERS ARRIVED ON SCENE, THEY WERE ESCORTED TO THE DEFENDANTS ROOM (R343).

ONCE AT THE DOOR OFFICERS CAN HEAR LOUD MUSIC BEING PLAYED FROM THE HOTEL ROOM. AFTER SEVERAL KNOCKS INCLUDING ONE BY OFFICER LEON CLEARLY IDENTIFYING AS MIAMI BEACH POLICE, THE DEFENDANT OPENS THE DOOR. ONCE THE DEFENDANT OPENS THE DOOR, THE SECURITY STAFF EXPLAINED TO THE DEFENDANT THAT HIS ACTIONS NEEDED TO STOP, OR IT CAN LEAD TO HIM BEING ASKED TO LEAVE THE PROPERTY.

THE DEFENDANT CLOSED THE DOOR ON OFFICERS AND IN A SHORT TIME OPENS IT AGAIN AND TELLS THE SECURITY GUARD DO YOU WANT MORE? AND PROCEEDS TO SWING AN OPEN WATER BOTTLE CAUSING THE WATER TO HIT AND SPILL ON BOTH THE SECURITY GUARD MR.BAZILE AND OFFICER GONZALEZ.
