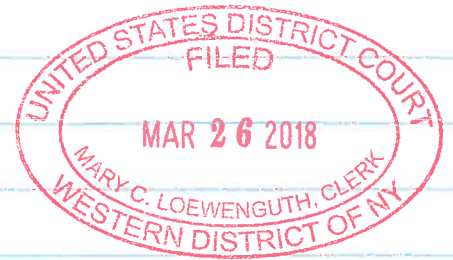

Did the following: Aug 14th the two officers followed me then chased me with lights on in fear for my safety I tried to escape the other patrol cars stopped but Beyer & Hy vicious attempt to catch me still pursued I bailed from the vehicle in an attempt to get attention of on-lookers residents the officers tried to ram a fence to mount on top of me so I proceed into the backyard of another resident where I was assaulted by both Beyer & Hy, but first Beyer the on-lookers residents stopped Hy from kicking me in the face by telling them to stop. After Lieutenant Beyer came and I asked for medical attention she laughed and told me if my eye fall out she would tape it to my face and that would be the only medical attention I would see. At the central Booking Beyer attended my screening and told booking I had been in a car accident which was false. Buffalo PD failed to protect me from such cruelty.

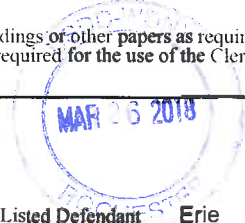

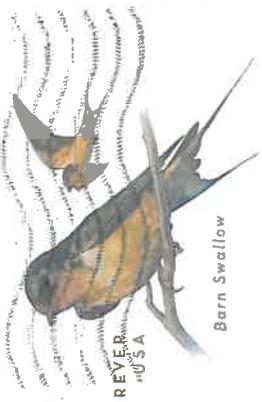
