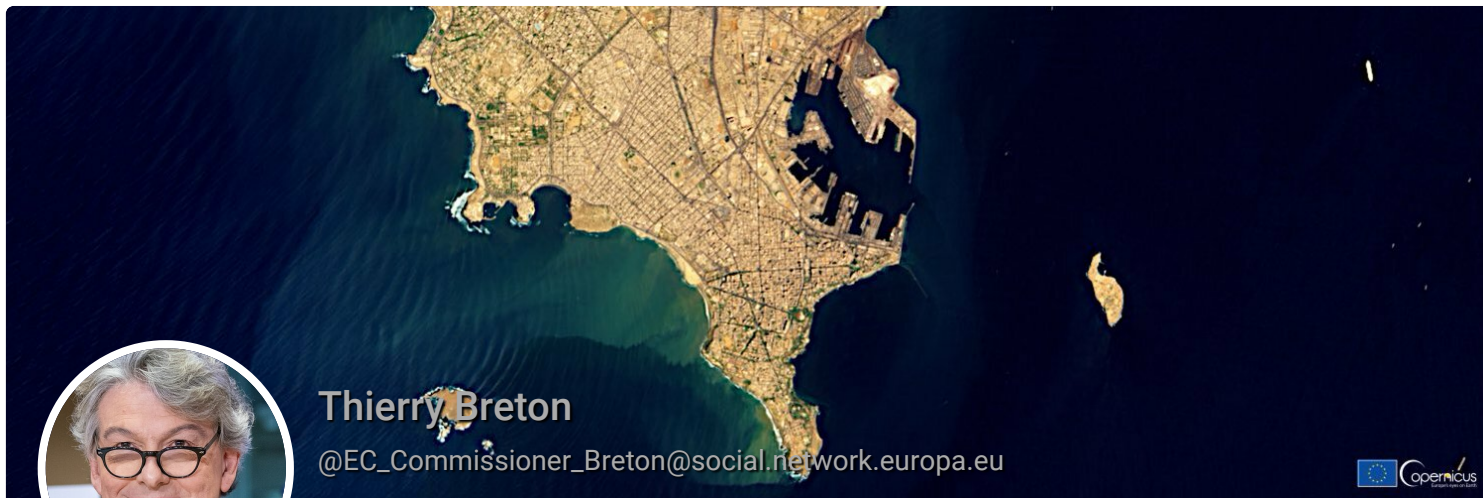

#5. Prepare for an extensive independent audit

- ✓ Appoint a DSA compliance officer – independent from the board.
- ✓ EU teams will come and check readiness
- ✓ Twitter needs to appoint an independent third-party auditor to verify DSA compliance from summer 2023

#4. Limit targeted advertising

Give users a good explanation on how they are profiled and why a specific user gets a specific targeted ad:

- ✓ No ad targeting of children
- ✓ No ad targeting based on sensitive information (e.g. sexual orientation or religious beliefs)

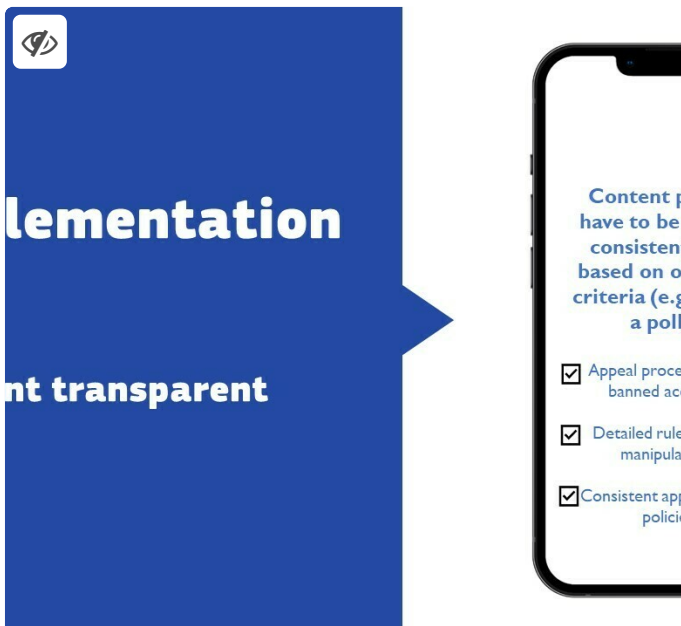

#3. Implement transparent policies

Content policies have to be applied consistently and based on objective criteria (e.g. not via a poll):

- ✓ Appeal procedures for banned accounts
- ✓ Detailed rules against manipulation

✓ Consistent application of policies

#2. Tackle disinformation

Live up to commitments on Code of conduct on disinformation:

- ✓ Label hoaxes and disinformation in cooperation with fact-checkers
- ✓ Promote authoritative sources
- ✓ Demonetise disinformation spread

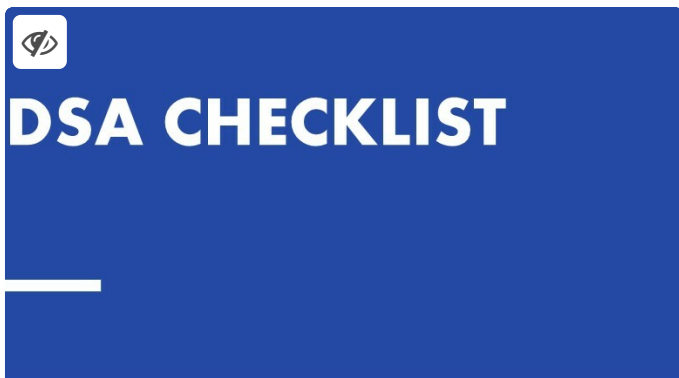
