**STATEMENT OF REASONS**

A review of your eligibility for security clearance has been made pursuant to Executive Order 10865 (as amended) and as implemented by DoD Directive 5220.6, dated, January 2, 1992, (as amended). Because this office is unable to find that it is clearly consistent with the national interest to grant you access to classified information, your case will be submitted to an Administrative Judge for a determination as to whether or not to grant, deny, or revoke your security clearance. This determination is based on the following reasons:

1. Guideline J: Criminal activity creates doubt about a person's judgment, reliability, and trustworthiness. By its very nature, it calls into question a person's ability or willingness to comply with laws, rules, and regulations. Available information raising this concern shows that:

a. In about November 2001, you were arrested and charged with felony Indecent Liberties with Child by Custodian. In about January 2002, the charge was nolle prossed.

b. In about December 1998, you pled guilty at an Article 15 hearing to Conduct Unbecoming an Officer and a Gentlemen (two specifications) (Article 133, Uniform Code of Military Justice (UCMJ)), and Indecent Acts (Article 134, UCMJ). You received a punitive letter of reprimand and forfeiture of \$2,000 pay per month for two months, all but \$750 per month of which was suspended for six months. In about April 1999, a Board of Inquiry substantiated your misconduct and substandard performance of duty and recommended that you be discharged with a General under Honorable Conditions Discharge. Subsequently, you were involuntarily discharged from the Marines with a characterization of General under Honorable Conditions.

2. Guideline D: Sexual behavior that involves a criminal offense; reflects a lack of judgment or discretion; or may subject the individual to undue influence of coercion, exploitation, or duress. These issues, together or individually, may raise questions about an individual's judgment, reliability, trustworthiness, and ability to protect classified or sensitive information. Sexual behavior includes conduct occurring in person or via audio, visual, electronic, or written transmission. No adverse inference concerning the standards in this Guideline may be raised solely on the basis of the sexual orientation of the individual. Available information raising this concern shows that:

a. Information as set forth in subparagraphs 1.a. and 1.b., above.

3. Guideline E: Conduct involving questionable judgment, lack of candor, dishonesty, or unwillingness to comply with rules and regulations can raise questions about an individual's reliability, trustworthiness, and ability to protect classified or sensitive information. Of special interest is any failure to cooperate or provide truthful and candid answers during national security investigative or adjudicative processes. Available information raising this concern shows that:

a. You falsified material facts on an Electronic Questionnaires for Investigations Processing (e-QIP), executed by you on August 3, 2020, in your response to "Section 22 - Police Record (EVER) Other than those offenses already listed, have you EVER had the following happen to you? Have you EVER been charged with any felony offense? (Include those under the Uniform Code of Military Justice and non-military/civilian felony offenses)." You answered "No" and thereby deliberately failed to disclose that information as set forth in subparagraph 1.a., above. You also failed to disclose that in about May 1998, court-martial charges alleging rape, sodomy, conduct unbecoming an officer, and indecent acts were brought against you.

b. Information as set forth in subparagraphs 1.a. and 1.b., above.

The Adjudicative Guidelines cited above were made applicable to all executive branch agencies by the Security Executive Agent on December 10, 2016, and are effective for all adjudications to determine eligibility for access to classified information or eligibility to hold a sensitive position, effective June 8, 2017. A copy of DoD Directive 5220.6 is contained in this package and the Guidelines can be found at Enclosure 2 of the Directive.

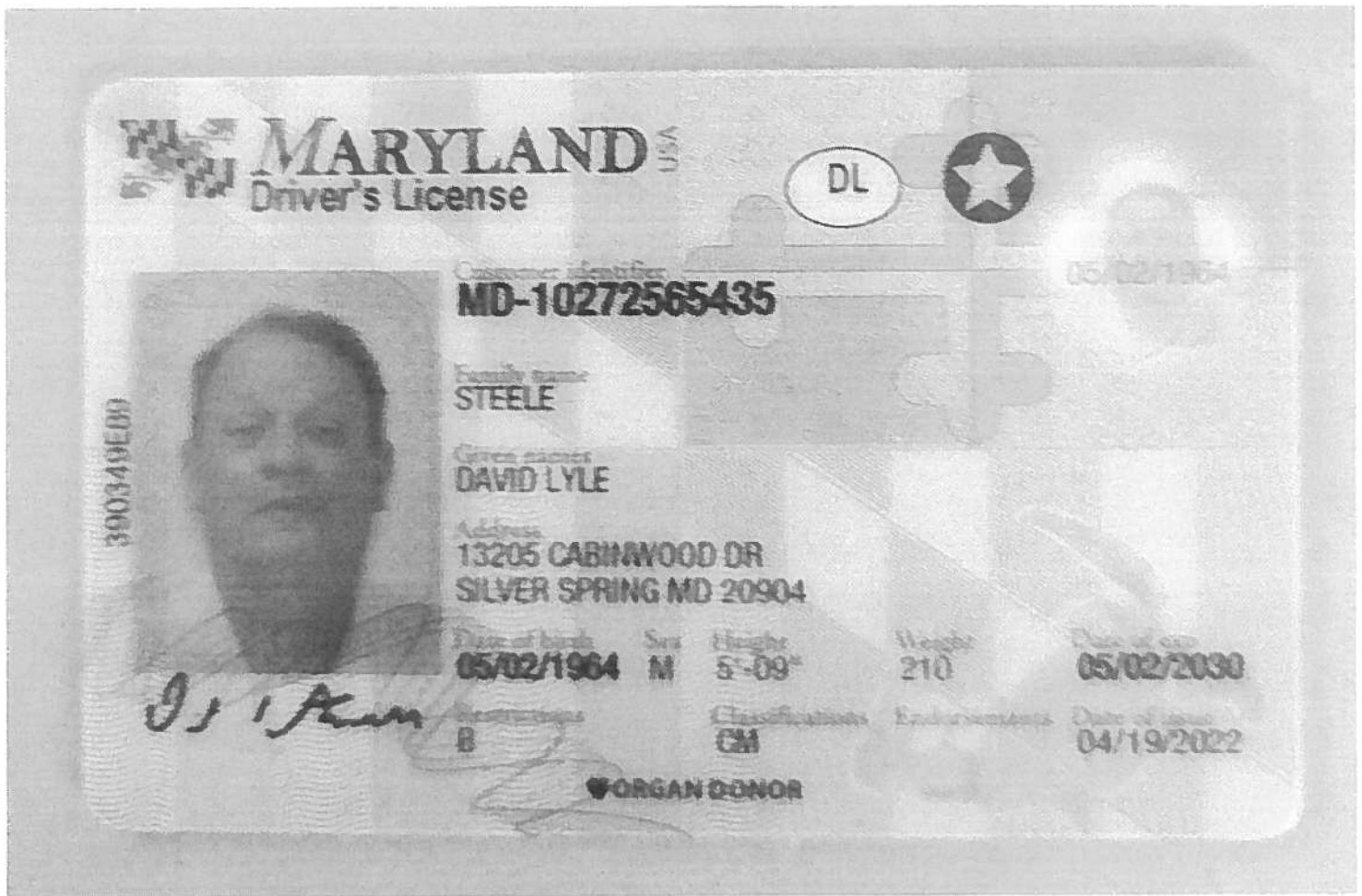
