I am the attorney representing Maj Joseph Palen. We both greatly appreciate you corresponding with us and I hope that I can provide any information you need to make your search for records easy.

Per his request below, please see the attached email. This is an email chain between me, Mr. Andre Gregorian (DOD DOHA Counsel) and Mr. Jim Clark (DOD CAF General Counsel). In the email chain, Mr. Clark confirms that DSCA does not have the authority to release Air Force records in its possession to Maj Palen or I as the Air Force "owns" the documents. Mr. Clark is the senior most attorney at the DOD CAF, so there is no higher authority we can go to within that organization. He directed us back to the Air Force to request the records.

I have been working on these matters with Maj Palen for 3 years.
