On 02/03/06 at 1200 hours, I received the subpoena from the State Attorney's Office.

At 1500 hours, Det Hanley and I met with Tanzabar manager Caroline Clear regarding this investigation. The subpoena was then executed for the surveillance videotape and computer entry log. Clear provided me the register's client history, tanner's report, all sales for 01/28/06, and the employee history log. Clear stated that the business does not have video surveillance.

The client history log shows that, on 01/28/06 at 1703 hours, client #8089 Vincent McMahon paid \$13.00 cash for a single session to include Sun Set sunglasses.

The tanner's report shows that, on 01/28/06 at 1650 hours, client #5167 Kelly McMahon logged into the system. At 1703 hours, client #8089 Vincent McMahon logged into the system.

The sales and employee history shows that employee logged in clients #5167 and #8089 on 01/28/06. The sales history shows that the transaction was paid for with cash.

At 1520 hours, I met with Tanzabar manager Caroline Clear regarding this investigation. She provided a written statement about the allegations. Clear stated that, on 01/28/06 between 1745-1810 hours, she received a phone call from asked Clear what she was doing. Clear stated that began to cry and stated, "An older gentleman followed me into a room and tried to kiss me". asked Clear if she should call the cops, but Clear told her not to do anything that she was on her way in. Clear stated that she called the owner and advised her of the situation.

Clear stated that, when she arrived at the store, she observed a black colored Hummer sitting in the parking lot. The vehicle was occupied by an unknown person. Clear walked inside the business and found John's employee inside. told Clear that she had just placed a customer in a bed with the last name McMahon. When got back to the counter, a second customer, with the same name as McMahon, needed a bed. asked the customer if he had a wife. said that she went to clean either bed two or three when he followed her into the room and tried to kiss her. showed Clear how she pushed him away and then stated to her that this happens to her all the time. then told Clear that McMahon asked her to take a picture of him with his camera phone, which she did, and then told her that he began to show her naked photos of himself.

Clear stated that she walked next door to Papa John's restaurant to speak with William Wells about the situation. Wells told Clear that was asking McMahon about ways to bulk up. Wells stated that told him that she showed McMahon her stomach.

At 1535 hours, I viewed both bed #2 and #3 at Tanzabar tanning salon. The small rooms contain lay-down tanning bed and a chair.

When she came out, she stated that was very excited. told her that a guy in bed #3 had the same last name as her. told her that Vincent McMahon wanted to meet her. also told her that he asked to take a picture of that he was going to take some nude pictures of him to send to his girlfriend.

I then showed her the photo lineup. She viewed the photo lineup and pointed to photo #2 as the man she met inside the tanning salon. She initialed and dated above her selection.

At 1830 hours, I met with Clear at the police department regarding this investigation. Clear gave me a typed statement that she stated she typed the day after the incident. The letter was collected and placed into evidence. The content of the letter is no different than Clear's written statement.

On 02/14/06 I received a letter from attorney Douglas Duncan regarding Vincent McMahon. The letter states that Mr. McMahon denies any allegations of personal wrongdoing involving the former employee ().

Wrestling star Vince McMahon accused of groping Bottanning salon worker

Boca Raton -- Wrestling personality Vince McMahon could be facing a legal smackdown.

An employee at Tanzabar Tanning Salon, 499 N. Federal Highway, told Boca Raton police that the chief executive of World Wrestling Entertainment tried to get a little too raw on Saturday, showing her pictures of himself in the buff before kissing and groping her.

McMahon, 60, is best known for running the WWE and for the character he plays on several WWE shows including *SmackDown* and *Raw* and on payper-view events such as *Royal Rumble* and *WrestleMania*.

His on-air persona is often arrogant and vengeful.

The shows are a sort of

family affair for McMahon, who has feuded publicly with his son and daughter. McMahon even asked his wife for a divorce on television, and in a later show kissed a female wrestler in front of her.

On Sunday, the 22-year-old Tanzabar employee told police that she led McMahon to tanning room No.3 and that McMahon asked if she could use his camera phone to take his picture.

She obliged and then gave the camera phone back to McMahon, who then showed her nude and semi-nude photos of himself on the camera phone, the police report shows.

According to the report, the woman asked McMahon to stop.

Once the 20-minute session was over, McMahon talked to her again, she told police. She walked over to the tanning suite and McMahon followed, closed the door and tried kissing her, she told police. She pushed McMahon away as he tried to lift up her shirt, she said.

Kelly McMahon, a Tanzabar customer who is not related to the wrestler, said McMahon was quite different with her on Saturday.

"He was nothing but a gentleman. He shook my hand three times," Kelly McMahon said Wednesday. "He showed no signs of coming on to [the employee]. He was talking to me. She was trying to interrupt our conversation."

They spoke briefly about their shared last name and their backgrounds, Kelly McMahon said.

"I didn't realize he was famous until I spoke with my husband," she said.

McMahon's attorney, Jerry McDevitt, said Boca Raton police told him this happened Sunday.

"We pointed out that it's not even possible because he was not in town that day," said McDevitt, who confirmed that McMahon was in town Saturday and has been a Tanzabar customer.

Boca Raton police have to get McMahon's side of the story before prosecutors determine whether there is enough evidence to file charges.
