I have some additional questions.

- 9/10/2020 -- To whom was the letter sent notifying TJHSST of commended students sent? NMSC sends the Commended Student mailing to the attention of the high school principal (by title only)
- 2. How many commended students were there in 2020 at TJHSST? NMSC does not publicly announce numbers of Commended Students by high school your high school may be able to answer this question for you
- 3. 2021 When was the letter about the commended students sent in 2021? September 16, 2021
- 4. 2022 -- I already have confirmation of what happened re: this year's mailing. I want to know: why did you wait so long to remail the mailing after the package was returned for insufficient postage? we processed this as soon as we were notified by the postal service
- 5. I would like to get copies of the letter that you send principals re: semifinalists and commended students. you would have to ask your high school for copies
- 6. With this situation as an example, why doesn't the National Merit Scholarship Corporation send to the College Board the data of students who are commended students? I have follow-up questions.

1. Why doesn't the National Merit Scholarship Corporation also notify students directly that they are commended students, semi-finalists or finalists? – high school officials have consistently requested to be the first to announce and recognize their Semifinalists and Commended Students in the National Merit Scholarship Program

To you answer, even if schools are notified **first**, why don't you directly notify students **after** the school is notified? – **We leave this honor exclusively to the high school officials**

2. With this situation as an example, why doesn't the National Merit Scholarship Corporation send to the College Board the data of students who are commended students? Does it notify the College Board of semi-finalists and finalists? – College Board is not involved in the administration of the National Merit Scholarship Program

You are not answering my question. I didn't ask if College Board is involved with the administration of the National Merit Scholarship Program. My question is: why do you **NOT share** with the College Board the results of your awards? If you are interested in helping students advance, it seems you would make the information available directly to students. — **This question has been answered — College Board is a separate organization and not involved with our program administration or recognitions**

- What is the total value of scholarships that you have estimated students received in 2020, 2021 and 2022 if they were commended students? – Commended students do not receive scholarship awards through NMSC
- 4. With whom do you share the data regarding commended students, semi-finalists and finalists? All public information regarding NMSC recognitions is posted on our website at www.nationalmerit.org
- 5. Fairfax County Public Schools has a contract with National Merit Corporation. Please provide me a copy of the contract. NMSC does not have contracts with any school districts (or individual high schools)
- 6. I would also like a copy of the 2022 990 for the corporation. Please provide me to that today along with any and all attachments. NMSC's 2022 990 will not be filed until October 2023. All other published 990s of the Corporation can be accessed (for free) at www.IRS.gov and <a href="www.IRS

I received your voicemail, and Matt Budreau talked with me about your phone conversation with him. We are also in receipt of your email from 11/23. Our office was closed on 11/23 through 11/27, and we are just now getting caught up with correspondence.
