If Customs and Border Patrol continues to withhold the documents to which Mr. Von Kaltner is entitled, the agency should expect a civil lawsuit filed in accordance with 5 USC 552a(g)(1)(B) or (D), to include reasonable attorney fees and litigation costs under 5 USC 552a(g)(2)(B).

Both the Federal and State governments have, time and again, reiterated the importance of the Freedom of Information Act and the Privacy Act. The Judiciary has done the same. Any ambiguity must be resolved in favor of disclosure and transparency.

There is nothing ambiguous about George Von Kaltner's request. 5 USC 552a(d)(1) mandates that CBP disclose the requested records. There is no pertinent exception.

George Von Kaltner, once again, requests all of the documents laid out in Exhibit A. If they are denied once again, CBP should expect a lawsuit.
