On December 19, 2022, 13-year-old female (VICTIM) was brought to ST Mary's Hospital with abdominal pain. Further hospital testing revealed the VICTIM was approximately 6weeks 2days pregnant. The VICTIM disclosed that [REDACTED], 41-year-old, Jean Innocent (DEFENDANT) has been having sexual intercourse with her and the last sexual abuse was in November 2022.

During a sworn statement with the child VICTIM, she disclosed the DEFENDANT has had sexual intercourse with her approximately four times since she had abdominal surgery in July 2020. The VICTIM was able to describe penile vaginal sexual abuse over the summer of 2022. The second sexual abuse was in November 2022. The VICTIM stated [REDACTED] was at work when the DEFENDANT entered her bedroom and told her "Give me 10-minutes." The DEFENDANT pulled down her bottoms exposing her bare body and he pulled down his pants. The DEFENDANT climbed on top of her and inserted his "PP inside of her PP." The VICTIM said "no" and was refusing and crying. The VICTIM stated that he stopped and said "never mind" because she was crying. He then left the room. The VICTIM described it to "feel weird." She also said it hurt.

During a one-party consent-controlled call from the VICTIM to the DEFENDANT, the VICTIM told the DEFENDANT she had been throwing up and the hospital was going to give her a Pregnancy Test. The DEFENDANT told her to say no and began making up a story to tell about a relationship with a boy named "Semen." He told the VICTIM if she tells he will go to jail. The DEFENDANT told the VICTIM she was not pregnant because her period was not due for another week. The VICTIM asked, "did you do it inside of me?" The DEFENDANT replied "Yes, I think I do it." He continued to explain that he believes his pre-ejaculation could have caused her to become pregnant.

On December 19, 2022, during a Post Miranda interview with the DEFENDANT, he stated that he believes VOODOO caused him to have sexual intercourse with [REDACTED]. The

DEFENDANT stated that he only remembers having Penile Vaginal intercourse with her on two separate occasions. The first sexual abuse was approximately 3months ago (September 2022.) He stated that they were inside of his bedroom on his bed. The DEFENDANT described telling [REDACTED] he needed "5minutes" He then inserted his penis into her vagina. He stated that it was only for a few seconds and then he stopped and left the room.

The second sexual abuse was in November 2022 on a Saturday. The DEFENDANT stated that he entered her bedroom and asked her for "10 minutes." He stated that he told [REDACTED] "This is the last time I`m going to ask." He said that [REDACTED] had tears coming from her eyes and she said OK. He then climbed on top of her and had penile vaginal intercourse with her.

Based on the above stated facts, Your Affiant has probable cause to arrest, JEAN EVENEL INNOCENT and charge him with (2) count in violation of F.S.S 794.011(8b) SEXUAL BATTERY WITH A CHILD (Familial or Custodial), (1) count in violation of F.S.S 826.04 INCEST, and (1) count in violation of F.S.S 827.04(3) IMPREGNANTION OF A CHILD .

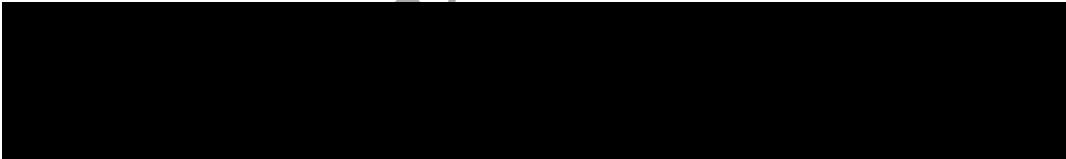
