Mr. Wiener --

I'd like to amend my request under OPRA and the common law right of access to read:

This is a request for the following records pursuant to the New Jersey Open Public Records Act (N.J.S.A. 47:1A-1 *et seq.*), as well as the common law right of access.

Records Requested:

1. Copies of the "letters and complaints" sent to, *inter alia*, the New Jersey Office of the Attorney General, Office of the Governor, Essex County Prosecutor, Office of the United States Attorney, Municipal Prosecutor, United States Senate, and Department of Education by Elouise McDaniel, as referenced in ¶ 20 of the September 17, 2021 complaint filed by the Township of Irvington in *Township of Irvington v. Elouise McDaniel*.
2. The Notice of Claim dated March 4, 2020 referenced in ¶ 22 of the aforementioned complaint, as well as any correspondence sent to McDaniel in response to the Notice of Claim.
3. A copy of any log of OPRA requests maintained by Irvington Township.
4. Any retainer agreement entered into with Ruderman & Roth, LLC and/or Allan C. Roth. This request is limited to agreements entered into after January 1, 2021.
5. Any invoices or bills received from Ruderman & Roth, LLC and/or Allan C. Roth on or after January 1, 2021.
6. Any retainer agreement entered into between Irvington Township and any firm or attorney in connection with responding to a request (or petition to the Government Records Council) issued by Elouise McDaniel under OPRA or the common law right of access.
7. Any invoices or bills received in connection with any request identified by Request No. 6, above.
8. The November 3, 2021, letter from Michael DeCotiss to NBC Universal.

9. The "March 6, 2020" document referenced on page 1 of the November 3, 2021, letter from Michael DeCotiis.

10. Any retainer agreement entered into between Irvington Township or Mayor Vauss and Michael R. DeCotiis or Decotiis, FitzPatrick, Cole & Giblin, LLP, together with any invoices or bills received from Mr. DeCotiis or the firm. This request is limited to agreements, invoices, or bills generated on or after January 1, 2021.
