NARRATIVE / CONTINUATION	<p>On December 29, 2022, the Lee County Sheriff's Office responded to [REDACTED], in reference to a Lewd or Lascivious Battery.</p> <p>Upon arrival, Deputy Gray made contact with Devon Garrett, a black male born on December 10, 1984, his wife, Elizabeth Morales, a Hispanic female born on March 8, 1986, and [REDACTED] herein referred to as the victim.</p> <p>Devon advised he woke to use the restroom and observed the victim still awake and playing on her laptop. Devon told the victim to go to bed. After a short time, Devon heard a noise from the front door. When Devon went to check, he observed the victim closing the door. When Devon questioned the victim about it, the victim stated she heard wind coming from the door, so she was locking it shut to prevent the wind noise. Devon sent the victim back to her bed. When he returned to his room, Devon told Elizabeth about the door, however, Elizabeth assured him that she had already secured the door. Devon then began to look through the victim's school-issued Chrome Book and discovered a chat log between the victim and a user with the email address listed as "dillon_atkinson@icloud.com."</p> <p>"When Devon confronted the victim about the chat log, the victim admitted to having a sexual relationship with a 26-year-old male. The victim admitted to having met the male via Fortnite in June 2022 and recently began talking to him again. The victim told Devon that in the past two weeks, she and the male had sexual intercourse multiple times, with the most recent incident occurring approximately two days ago.</p> <p>Based on the nature of the investigation, Detective Torres, of the Lee County Sheriff's Office Special Victim Unit, responded to the scene and assumed the investigation.</p> <p>Upon arrival, Detective Torres made contact with Devon and Elizabeth, who provided a similar statement, as to the one provided to Deputy Gray. Devon also advised that in the chat log on Google Docs from the victim's Chrome Book, he noted a message from "dillon_atkinson@icloud.com" which indicated that he was at the residence. Devon immediately went outside with his firearm, but he was unable to locate anyone. When Devon returned inside, he continued to look through the chat logs on Google Docs and located more messages between the victim and "dillon_atkinson@icloud.com," which was when the victim admitted to her relationship with the male and Devon subsequently called law enforcement.</p> <p>An inquiry via Accurint, using the email address "Dillon_atkinson@icloud.com" confirmed the suspect to be Dillon Atkinson, a white male born on August 15, 1996.</p> <p>Based on the victim's disclosure of the statement provided by Devon, the victim was transported to the Children's Advocacy Center, where she met with Case Coordinator Alexandria Atal, who conducted a forensic interview with the victim. During the forensic interview, the victim provided the following information.</p> <p>The victim admitted to having sexual intercourse with Dillon, on at least two occasions. The victim stated Dillon was aware that she was 15 years old, and she was aware he was 26 years old. Dillon told the victim that he currently does not have a personal vehicle, and currently only has a work vehicle. The first incident occurred approximately two weeks ago inside the suspect's work truck???????, a white in color Chevrolet Silverado bearing Florida tag# JNNF47 with TRUTECH insignia, the suspect picked up the victim near her school, bought Burger King, and drove to the dead end side of Garden Street. The victim stated that they engaged in sexual intercourse. During the incident, Dillon penetrated her vagina, her anus, and her mouth, with his penis. In addition, the victim performed oral sex on Dillon. The victim advised that Dillon used a condom during this incident, however, she was unsure of how he disposed of it. Afterward, he dropped the victim off at the convenience store located at the intersection of Garden Street and Laurel Drive. The second incident occurred on December 21, 2022. Dillon picked up the victim and took her to his residence located at 298 Lowell Avenue, North Fort Myers, in Lee County, Florida. While at his residence Dillon and the victim engaged in sexual intercourse. Dillon penetrated both the victim's vagina and anus with his penis, as well as digitally penetrated her vagina. During this incident Dillon was wearing a condom, however, the victim advised it broke. Dillon continued to vaginally penetrate the victim and used a green t-shirt to wipe his penis occasionally during intercourse while stating that he did not want to get the victim pregnant. Afterward, Dillon took the victim to a nearby Walgreens where he purchased Plan B, and gave it to the victim as a precaution, because the condom broke.</p> <p>Detective Torres and Detective Minto responded to the victim's residence to collect clothing and photograph the area at the end of Garden Street for evidence. During that time Devon advised Detective Torres and Detective Minto that on the drive back from the Children's Advocacy Center the victim admitted to omitting the most recent incident, which occurred on the side of their house approximately three days ago. The victim agreed to participate in a medical assessment and a sexual assault kit, therefore her parents drove her back to the Children's Advocacy Center, where she was seen by Nurse Practitioner Jean Marie Blasco. Nurse Practitioner Blasco stated the</p>

NARRATIVE / CONTINUATION	<p>victim disclosed that Dillon brought a soft, gray blanket, to the third incident, where they engaged in sexual intercourse outside of the victim's residence. Detective Torres and Detective Minto contacted Trutech Wildlife Service and spoke with Dillon's District Manager, Aaron Carlson. Aaron advised that Dillon's current address was 295 Lily Pond Court, North Fort Myers, Lee County, Florida and that the GPS of his work truck was pinging at that location. Detective Torres and Detective Minto subsequently responded to 295 Lily Pond Court and immediately observed a Trutech work truck in the driveway. Neighbors advised Dillon's residence was around the rear of the building. Detectives knocked on the door and made contact with Dillon, who confirmed his name. Dillon was detained and transported to the Lee County Sheriff's Office to be interviewed. It should be noted that the address was confirmed to be 298 Lowell Avenue Unit E, North Fort Myers, Florida, via Google Maps.</p> <p>On December 29, 2022, Dillon was transported to the Lee County Sheriff's Office Main Headquarters located at 14750 Six Mile Cypress Pkwy, Fort Myers, Florida, for an attempted interview. Detective Villa read Dillon his Miranda warnings from an agency-issued pretext Miranda card. Dillon advised he understood his rights and agreed to speak with Detective Villa without his attorney being present. Detective Villa obtained a sworn digitally recorded statement.</p> <p>During his post-Miranda statement, Dillon confirmed he and the victim met each other approximately five months prior on the video game Fortnite. The two began a friendship that later turned romantic in nature. They began communicating through Discord, a phone application where people text, chat and make video calls.</p> <p>Dillon advised he and the victim met in person at the beginning of December of 2022, when he moved to his apartment in North Fort Myers located at 298 Lowell Avenue Unit E, North Fort Myers, Florida, Dillon stated the first time he and the victim had sex was two weeks ago when he picked her up from her school. The two drove towards her residence, pulled over on the side of the road, and engaged in sexual intercourse.</p> <p>The second and last time the two engaged in sexual intercourse was approximately one week ago. Dillon stated he picked her up from her residence and took her to his apartment where they had sexual intercourse.</p> <p>Dillon admitted to knowing the victim was underage because she told him she was sixteen years old. However, he advised the victim told him the age did not matter to her. Dillon also stated he was unaware of the legal age of consent. Dillon stated he had not washed his bedding and that his red sheet was in the hamper.</p> <p>Dillon appeared to be extremely remorseful of his actions.</p> <p>Dillon confirmed his address to be 298 Lowell Avenue Unit E.</p> <p>Based on the investigation in its entirety, including the victim's disclosure as well as statements provided by Devon, Elizabeth, and Dillon, probable cause was established to place Dillon Atkinson under arrest for the violation of Florida State Statute 800.04 (4c) Lewd or Lascivious Battery. Dillon Atkinson was placed under arrest and transported to the Lee County Jail for processing without incident.</p>

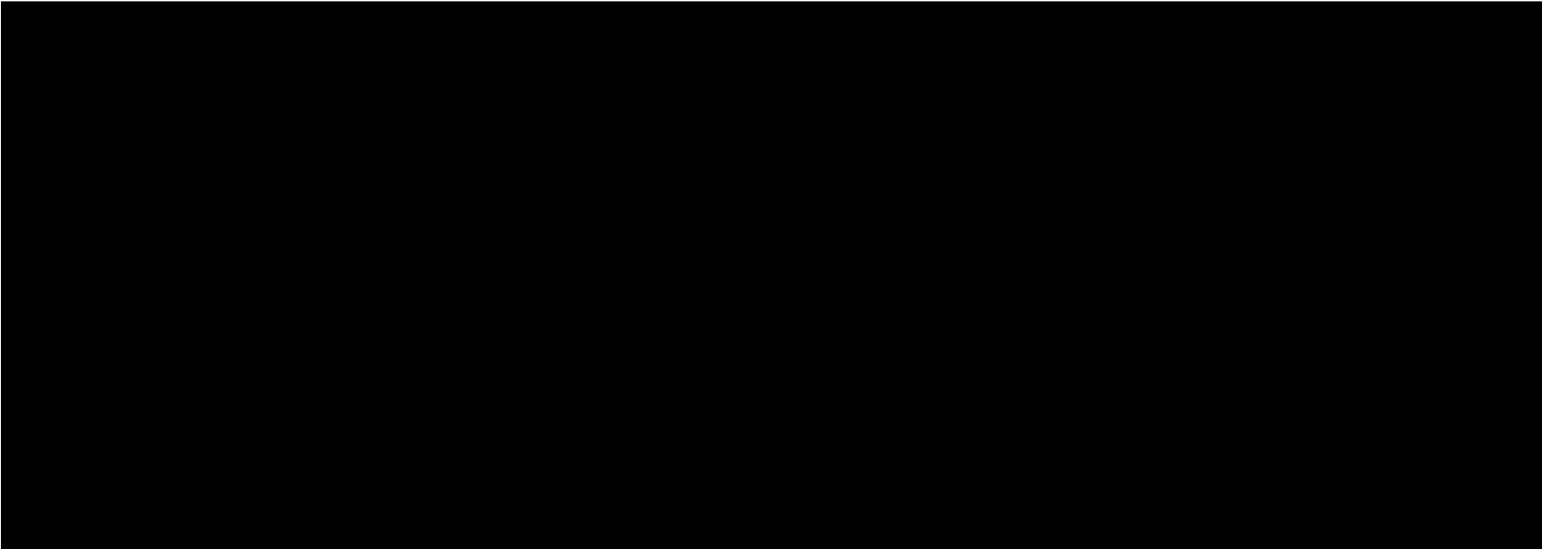

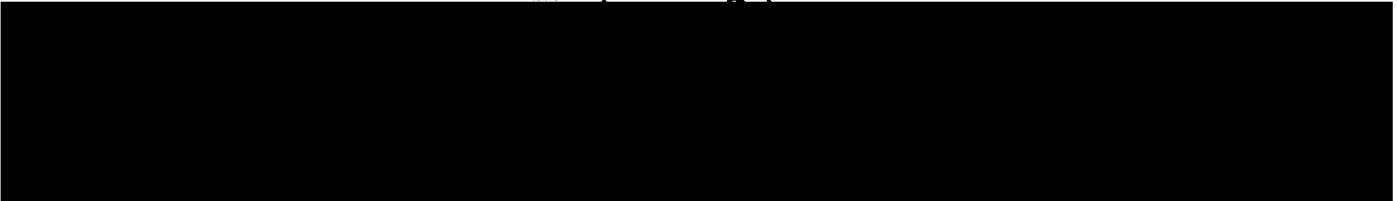
