Narrative Information

ON 11/23/22, DION RABOUIN COMMITTED 3RD DEGREE TRESPASSING AT REFUSING TO LEAVE THE CHASE BANK PROPERTY UPON REASONABLE REQUEST MADE BY AN EMPLOYEE. HE WAS DETAINED BRIEFLY AS HE FAILED TO PROVIDE HIS IDENTIFICATION UPON REQUEST. DION WAS RELEASED AND TRESPASSED AS A RESULT OF THIS INCIDENT.

AT 1443 HOURS, CHASE BANK EMPLOYEE, BRENDA CRUZ, CALLED TO REPORT A SUSPICIOUS PERSON OUTSIDE THE BANK. CALL NOTES STATED THE FOLLOWING: "B OR IM WHI SHRT BLU SHORTS BLK SHOES ASKING FOR CUST PERSONAL INFO AND 250ING THEM IN PLOT. REFUSING TO LEAVE SAYING HES A REPORTER."

UPON ARRIVAL AT 1503 HOURS, I WAS OPERATING A FULLY MARKED POLICE TAHOE. I WAS WEARING A PHOENIX POLICE UNIFORM WITH SHOULDER PATCHES AND A BREAST BADGE, READILY IDENTIFIABLE AS A POLICE OFFICER.

I OBSERVED A MALE MATCHING THE ABOVE DESCRIPTION, LATER IDENTIFIED AS DION RABOUIN. DION WAS STANDING OUTSIDE THE MAIN ENTRANCE ON THE SOUTH SIDE OF THE BANK AND SPEAKING WITH A MALE AS HE WAS ATTEMPTING TO ENTER THE BANK. I WALKED WITHIN FIFTEEN FEET OF DION AS I ENTERED THE BANK AND HE LOOKED DIRECTLY AT ME.

I WENT INSIDE AND MET WITH CALLER, BRENDA. SHE POINTED OUT DION TO ME AND STATED HE HAD BEEN STANDING OUTSIDE APPROACHING CUSTOMERS AS THEY ENTERED THE BANK. SOME CUSTOMERS REPORTED TO BRENDA THAT DION WAS MAKING THEM UNCOMFORTABLE. BRENDA STATED BANK STAFF APPROACHED DION AND TOLD HIM HE WAS MAKING PEOPLE UNCOMFORTABLE AND ASKED HIM TO LEAVE. DION REFUSED TO LEAVE AND TOLD BRENDA HE WAS A REPORTER. BRENDA STATED CHASE BANK WAS WILLING TO AID IN PROSECUTION IF DION WAS UNWILLING TO LEAVE. SHE ALSO STATED SHE WANTED HIM TRESPASSED FROM THE PROPERTY.

I WENT OUTSIDE AND MET WITH DION, WHO WAS STILL IN THE SAME LOCATION I ORIGINALLY OBSERVED HIM. BASED UPON MY CONVERSATION WITH BRENDA, I ESTABLISHED PROBABLE CAUSE THAT DION HAD COMMITTED THE CRIME OF TRESPASSING AS A RESULT OF FAILING TO LEAVE THE PROPERTY AFTER A REASONABLE REQUEST HAD BEEN MADE FOR HIM TO LEAVE BY A PERSON HAVING LAWFUL CONTROL OVER THE PROPERTY. MY INTENTION WAS TO IDENTIFY HIM AND NOTIFY HIM HE WAS BEING TRESPASSED FROM THE PROPERTY. I REQUESTED DION'S IDENTIFICATION, TO WHICH HE BEGAN TO QUESTION WHY I NEEDED HIS ID AND WHAT "BEING TRESPASSED" WAS. AFTER I EXPLAINED THE TRESPASS PROCESS, DION ADMITTED THAT EMPLOYEES FROM THE BANK HAD APPROACHED HIM AND SPOKEN WITH HIM. HE STATED THEY ADVISED HIM HE WAS NOT ALLOWED TO SOLICIT ON THEIR PROPERTY. I EXPLAINED TO DION HE WAS BEING DETAINED. AS HE WOULD CONTINUE TO DO THROUGHOUT MY CONTACT WITH DION, HE SPOKE AS I WAS ATTEMPTING TO EXPLAIN THE CIRCUMSTANCES OF MY CONTACT WITH HIM. THIS MADE IT DIFFICULT TO COMMUNICATE EFFECTIVELY WITH DION.

I AGAIN REQUESTED DION'S IDENTIFICATION, WHICH HE REFUSED TO PROVIDE TO ME BECAUSE HE CLAIMED HE DID NOTHING WRONG. HE STATED HE HAD HIS ID ON HIM, BUT REFUSED TO PRODUCE IT. AT THAT TIME, I TOLD DION TO TURN AROUND AND PUT HIS HANDS BEHIND HIS BACK, WHICH HE DID NOT DO. I REMOVED MY HANDCUFFS TO DETAIN DION. AFTER PLACING A HANDCUFF ON DION'S RIGHT HAND, HE BEGAN PULLING AWAY FROM ME. AT 1508 HOURS, AFTER REPEATEDLY TELLING DION TO PLACE HIS HANDS BEHIND HIS BACK, I WAS ABLE TO SECURE HIM IN HANDCUFFS AFTER A BRIEF STRUGGLE TO GET HIS HANDS BEHIND HIS BACK. AT THAT TIME, I ESCORTED DION TO MY PATROL VEHICLE, WHERE HE RELUCTANTLY SAT IN MY PATROL VEHICLE, BUT REFUSED TO PUT HIS FEET INSIDE SO I COULD CLOSE THE DOOR. I CONTINUED ATTEMPTING TO HAVE A CONVERSATION WITH DION TO EXPLAIN WHAT WAS HAPPENING, BUT HE CONTINUED TO MAKE IT DIFFICULT BY ARGUING WITH ME AND SPEAKING OVER ME. AT THIS TIME I ASKED DION SEVERAL TIMES TO PLACE HIS FEET INSIDE, SO I COULD SAFELY CONTINUE MY INVESTIGATION. IT SHOULD BE NOTED AT THIS TIME, I WAS STILL WAITING ON A BACKUP OFFICER TO ARRIVE AND THERE WAS AN UNKNOWN FEMALE BYSTANDER WHO WAS STANDING IN CLOSE PROXIMITY TO ME RECORDING AND INTERJECTING COMMENTS AS I CONDUCTED MY INVESTIGATION.

PRIOR TO HAVING DION SIT IN MY VEHICLE, I PERFORMED A PAT DOWN FOR WEAPONS. DURING THAT TIME, I NOTICED DION'S WALLET IN HIS FRONT RIGHT POCKET. I REMOVED THE WALLET WHICH CONTAINED HIS IDENTIFICATION. AFTER OTHER OFFICERS ARRIVED ON SCENE TO ASSIST, I COMPLETED A QUERY OF DION'S INFORMATION AND COMPLETED A TRESPASS NOTIFICATION CARD TO PROVIDE TO CHASE EMPLOYEES.

AT1524 HOURS, I EXPLAINED TO DION THAT HE WAS OFFICIALLY TRESPASSED FROM THE PROPERTY AND IF HE RETURNED, HE WAS SUBJECT TO ARREST FOR TRESPASSING. DION STATED HE UNDERSTOOD. AT THAT TIME, DION WAS RELEASED FROM HANDCUFFS AND ADVISED TO LEAVE THE PROPERTY. DION STATED HE WANTED INFORMATION TO FILE A COMPLAINT. I PROVIDED DION MY NAME, BADGE NUMBER, MY SUPERVISOR'S INFORMATION, INCIDENT NUMBER, AND PRECINCT PHONE NUMBER. DION FURTHER REQUESTED THE INFORMATION OF THE OTHER OFFICERS ON SCENE, WHICH WAS PROVIDED. DION LEFT THE PROPERTY AT THAT TIME.

ALTHOUGH PROBABLE CAUSE EXISTED FOR DION'S ARREST, BASED ON THE TOTALITY OF THE CIRCUMSTANCES, DION WAS RELEASED FROM CUSTODY AS HE WAS WILLING TO LEAVE THE PROPERTY.

I PROVIDED THE TRESPASS AND INCIDENT INFORMATION TO BRENDA.
